APKINDO/ JLIA/ JPMA/ MPMA/ STA Meeting

Asosiasi Panel Kayu Indonesia, Persatuan Pekilang-Pekilang Produk Panel Malaysia, Persatuan Pengimport Balak Jepun, Persatuan Pekilang Papan Lapis Jepun dan STA bermesyuarat di Jakarta, Indonesia pada 10 September 2007.

Ahli-ahli kelima-lima persatuan menukar maklumat pasaran semasa dalam mesyuarat. Mereka juga berbincang beberapa isu termasuk isu kesahan kayu dan pengurusan hutan secara mampan. Mesyuarat memutuskan bahawa mesyuarat akan datang diadakan di Bangkok pada 21 April 2008.

■ The Indonesian Wood Panel Association (APKINDO), the Japan Lumber Importers' Association (JLIA), the Japan Plywood Manufacturers' Association (JPMA), the Malaysian Panel Products Manufacturers' Association (MPMA) and STA met in Jakarta, Indonesia on 10 September 2007. This meeting was well attended by members of the five associations.

The meeting took this opportunity to exchange market information. The following are some of the highlights of the discussion:

1. The housing construction industry in Japan is experiencing a crisis with the introduction of the new

building standards law on June 20 2007. This resulted in stricter control and delays in the issuance of building licences which caused the housing starts to drop by 23% in July 2007 .

2. Japan is the biggest importer of wood materials, but volume of import will decrease due to drop in housing starts.

3. According to the Nikkei news on 8 September 2007, the price of plywood had gone up ¥20 per piece.

The plywood market in Japan is depressed and the total plywood

supply from overseas is decreasing. The condition will only improve when demand picks up and imported stock is low. The supply of domestic softwood plywood is however, on an increasing trend. It is anticipated that the plywood market may improve

again beginning 2008.

The meeting also discussed on the issue of legality verification and sustainability. It was proposed that the next joint meeting will be held in Bangkok on 21 April 2008. ❁

Refresher Course by MTCC on MC&I(2002) and Forest Management Certification Requirement

■ Following from the Second Forest Management Certification Steering Committee Meeting, Mr. Liew Tchin Fah, Chairman of the Committee invited the Malaysian Timber Certification Council (MTCC) to conduct a Refresher Course to the six Forest Management Units (FMU) holders on the overall requirements under the Malaysian Criteria &

Indicators (2002) [MC&I(2002)] and Forest Management Certification. This Course held on 20 September 2007 at Wisma STA, Kuching and attended by 84 participants comprising Members of STA and staff members of the Forest Department Sarawak, the Sarawak Forestry Corporation, the Sarawak Timber Industry Development

Corporation and Harwood Timber Sdn Bhd. Also present were Dr. Yap Son Keong and Mr. Khoo Khay Jin, auditors from SIRIM QAS International Sdn Bhd to provide additional clarifications based on their auditing experience in conducting assessment of the FMU using the MC&I(2002).

The Course was conducted by two officers from MTCC, Mr. Hanarinder Singh and Mr. Yong Teng Koon. The session started with an introduction to MTCC, the operations of different schemes under MTCC, recognition of the scheme, the latest

development at MTCC which is the development of standard for the certification of forest plantations and the new institutional arrangement for MTCC scheme. This was followed by a presentation on the forest management certification process. Participants were taken through the nine principles of the MC&I(2002). This Course saw an active engagement from the participants who took the opportunity to seek further clarification on requirements of the MC&I(2002). ❁

Briefing on the Requirements on Chain of Custody Certification under the MTCC Scheme

■ STA in collaboration with the Malaysian Timber Certification Council (MTCC) organised a briefing on the Requirements on Chain of Custody (RCoC) certification under the MTCC scheme on 21 September 2007 at Wisma STA, Kuching. The briefing was attended by 54 participants from the STA member companies and the Sarawak Forestry Corporation.

The session was conducted by Mr. Hanarinder Singh of MTCC. He gave an introduction to CoC certification and how the scheme works. CoC is verification by an independent third party that wood products, including logs, are legally derived or sourced. The CoC standard that is used under the MTCC scheme is the Requirements for Chain-of-Custody Certification (RCOC). There are nine requirements for CoC requirements namely,

- Organisation which involves the commitment of the management, establishment of responsibility and documented procedures.

- Training, the personnel involved in CoC related activities must be adequately trained.
- Transport where the traceability of certified products is maintained during transportation. The consignments of certified products must be able to be traced from the supplier to the client and vice versa.
- Purchasing involves documents such as the removal pass for logs from certified Forest Management Unit, purchasing documents and records of purchases. For products containing non-certified wood, a self signed declaration to need to be furnished by the supplier of the materials declaring that the supplied wood materials are not from controversial sources.
- Processing of Certified Materials in accordance to the physical separation system, the minimum average percentage system and the input/output system.
- Packaging and Labelling where

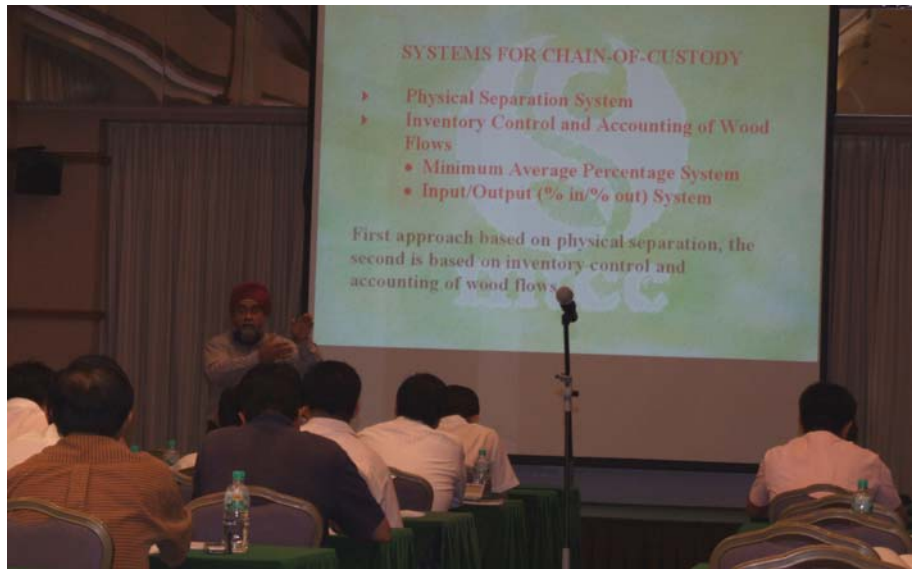
certified products are packed and labelled in accordance to the specified rules in the 'MTCC Logo guide for Certificate holder'.

- Sales where all related documents need to identify the certified status of the product sold. The documents are the Certificate for CoC number, type and quantity of material.
- Record Keeping is the establishment, implementation and the maintaining of monthly

records of suppliers, purchases, input, processing and outputs of certified products where records need to be legible and identifiable for the product.

- Stakeholders' Input is the maintenance of records of stakeholders' input and feedback and the corrective and preventive actions that has been taken.

STA received a letter from Sarawak Timber Industry Development Corporation (STIDC) reference STIDC.20.PPD.09.12 dated 5 September 2007 concerning the implementation of the Paperless Permit for export of timber and timber products to Japan Market. The implementation has been postponed until further notice.

Workshop on California New Formaldehyde Regulations

■ The California Air Resources Board (CARB) with the assistance from STA organised a Workshop on California New Formaldehyde Regulations on 27 September 2007 at Wisma STA, Kuching. This workshop was attended by 33 participants from the plywood mills in Sarawak and interested parties. The participants were informed of the upcoming California regulations in California. The speakers were Mr. Jim Aguila, the Manager for Substance Evaluation Section of the California Air Resources Board and Dr. Erwin Schufort, a Senior Wood Scientist attached with the Professional Services Industries (PSI) USA.

Three topics were presented namely,

- *California's New Composite Wood Regulation - What does it mean to me and why should I care* by Mr. Jim Aguila. Mr. Aguila discussed why the need to regulate formaldehyde for composite wood products, the airborne toxics control measure, third party certification, the requirements for manufacturer, importer, exporters, fabricators and retailers and the exemptions.
- *Large Chamber Formaldehyde*

Measurement of Sabah Hardwood Plywood by Dr. Erwin Schufort. This paper is about the need of plywood producers to demonstrate that their products meet the new requirements. Thus, this paper addresses the measurement of a variety of Sabah Hardwood plywood using the large chamber in accordance with ASTM E1333. The method and technical protocol for large chamber measurements are reviewed.

- *Statistical Analysis of Hardwood Plywood Formaldehyde Emission* by Dr. Erwin Schufort. This research compares the formaldehyde emissions from Sabah Hardwood plywood using a large chamber (ASTM E1333), a desiccator (ASTM D5582 and JIS 1460) and small chamber (ASTM D6007 and JIS 1901A).

First Meeting of the Technical Committee in Integrated Information Management for Timber Industry in Sarawak

■ The First Meeting of the Technical Committee in Integrated Information Management for Timber Industry in Sarawak was held on 11 September 2007 at the headquarters of the Sarawak Timber Industry Development Corporation in Kuching. This Committee was formed during the Steering Committee Meeting in Integrated Information Management for Timber Industry in Sarawak on 20 August 2007 to plan and implement inter-agencies information integration.

The meeting agreed to study and comment on the final report by URS Forestry, Australia. URS Forestry was engaged to undertake a review of the current Chain of Custody (CoC) in Sarawak and assess the impact of the Forest Law

Enforcement, Governance and Trade (FLEGT) on the CoC. The Committee also discussed in length the objectives of the committee and further actions that will be taken to meet the objectives. The objectives are:

- To study the findings of URS Forestry on the timber tracking system to provide the basis for future adoption,
- To identify the prevailing timber tracking system in Sarawak and relate it to the actual requirement of CoC, and
- To identify the systems used and to link the timber tracking system to the relevant agencies. ❁

Extension of Working Hour at Senari Port, ASSAR Senari Port, Pending Port and Bintulu Port

STA was informed by the Royal Customs Malaysia via letter Ref. No. KE.YB(05)651/03 Klt. 1 Sk. 2(7) dated 18 September 2007 concerning the extension of working hours at the Senari Port, Assar Senari Port, Pending Port and Bintulu Port. The offices of the Royal Customs Malaysia located at the Kuching Port (Senari and Pending) and Bintulu will be operating until 10.00 p.m. from Monday to Sunday, including public holidays. This takes effect from 1 October 2007.

Forest Workers Training and Section 54B Forests Ordinance (Sarawak, Cap 126)

■ In anticipation of the implementation of Section 54B Forests Ordinance (Sarawak, Cap 126), the Sarawak Timber Association through its wholly-owned company, STA Training Sdn Bhd, organised two briefing sessions, one in Sibul on 14 August 2007 and the other in Bintulu on 15 August 2007, on the Forest Workers Training for representatives from Member Companies of STA. In Sibul, the briefing was attended by 41 participants from 11 Member Companies while in Bintulu, 44 participants from 16 Member Companies.

The main objectives of the briefing were to inform the participants on (i) the status of Section 54B Forests Ordinance (Sarawak, Cap 126), (ii) various courses offered by STA Training Sdn Bhd, (iii) financial contributions available for training, and (iv) the

progress of training to date.

This briefing, targeting Forest Managers, General Operation Managers, Camp Managers, Training Co-ordinators, Trainers and Foremen, covered legal requirements of training and the impact to the industry, training procedure and documentation and financial contributions provided to participants of the three skills sets currently being offered by STA Training Sdn Bhd. ❁

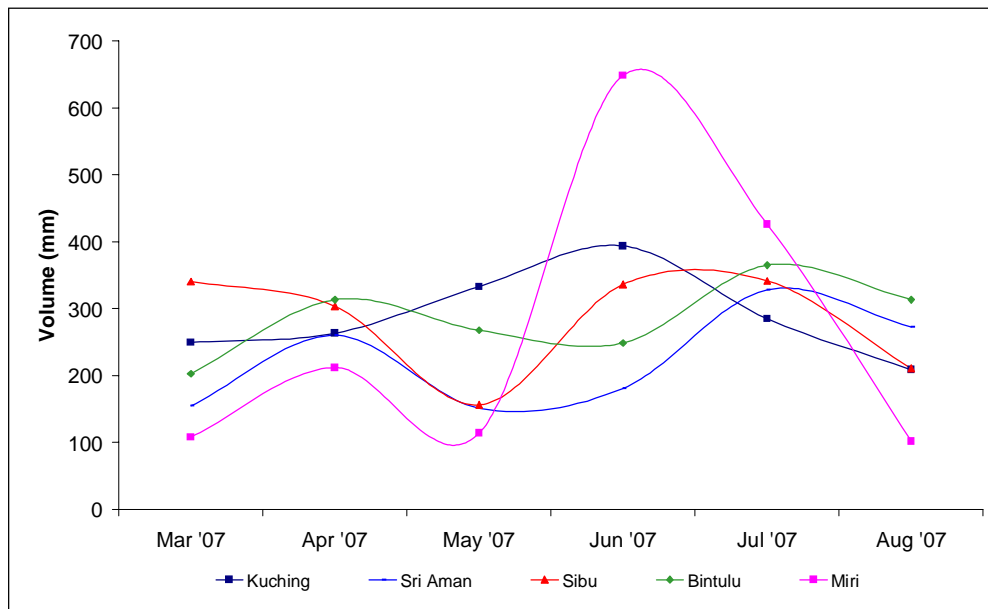
