SEMINAR ON APPLICATION OF ILO CORE CONVENTIONS IN FORESTRY AND TIMBER INDUSTRY

The Malaysian Certification Timber Council (MTCC), the Timber Employees Union Peninsular Malaysia (TEUPM) and the Building Wood Workers International (BWI) jointly organised a Seminar on Application of International Labour Organisation (ILO) Conventions in Core Forestry and Timber Industry. The objective of Seminar was to and educate raise awareness on the application of the ILO core fundamental o r conventions in relation to the forestry and timber industry in Malaysia. Approximately 120 participants from the Government agencies. workers' unions, timber and notified industry Certification Body (CB) with MTCC attended the Seminar.

There are eight ILO core conventions, namely C29 (Forced Labour), C98 (Right to Organize and Collective Bargaining), C 1 0 0 (Equal remuneration), C87 (Freedom of Association and Protection of the Right Organize), C105 (Abolition of Forced Labour), C 1 1 1 (Discrimination (Employment Occupation), C138 (Minimum Age Convention), C182 (Elimination of the Worst Forms of Child Labour). Out of these eight (8) Core Conventions, six (6) had been included in the MC&I(2002), namely C29, C87, C98, C100, C105, C111 and out of these six (6) Core Conventions, Malaysia has ratified C29, C98 and C100 and has not ratified C87. 105 and 111.

Six papers were presented during the Seminar namely:

Harwood Timber Sdn Bhd had in a letter dated 3 September 2009 advised our Association that the date of implementation of issuance of transportation pass (supposed to be with effect from 1 September 2009) has been postponed to a later date.

Did you know that...

The Brazil government has unveiled a national action plan on climate change on December 1, with as a key goal to reduce Amazon deforestation by 72% by 2017. Deforestation would be reduced to 574,200 hectares per year at the end of the period, from an ongoing rate of 1,196,800 hectares per year. The plan estimates that avoided deforestation over the 8 year period would result in avoided emissions of some 4.8 billion tons of CO₂, a figure higher than the annual emissions of the European Union.

President-Elect of PEFC informed that the ILO Core Conventions had always been and will continue to be the requisite criteria for and since PEFC the national certification scheme (MC&I(2002) has been endorsed by PEFC, ILO Core Conventions would be superimposed as criteria in the national certification scheme.

SEMINAR ON WOODEN FURNITURE INDUSTRY 2009

The Forest Research Institute Malaysia (FRIM), with the support o f eight government agencies and trade associations Forest namely, the Department Peninsular Malaysia, the Sabah Forest Department, the Sarawak Timber Industry Development Corporation, the Malaysian Timber Industry Board, the Malaysia Furniture Entrepreneurs Association, the Malaysia Furniture Industry Council, the Sabah Timber Industry Association and STA, organised the Seminar on Wooden Furniture Industry 2009 held from 4 to 6 August 2009 at the FRIM Auditorium, Kepong, Selangor Darul

Ehsan. With the theme "Competitiveness and Sustainability", it attracted 145 participants from the government agencies, trade associations and private sectors.

The seminar aimed to disseminate the latest market development, investment opportunities, national timber industry government policy, financial assistance scheme, and research and development (R&D) findings on the wooden furniture industry to stakeholders who would like to see the sector to continue to flourish and contribute to sustainable development of the industry and the nation.

The Seminar was

officiated bу the Secretary General of the Ministry of Natural Resources a n d Environment (NRE), Y. Bhg. Dato' Zoal Azha Yusof on behalf of the Minister, Y.B. Datuk Douglas Uggah Embas. In his speech, he said that the export value for furniture industry grew from RM58.8 million in 1988 to RM6.5 billion in Although 2008. the industry facing severe challenges such as raw material supply, competition from low-cost producing countries and substitutes, he believed that with the cooperation and efforts of the wood furniture industry players, the industry could be able to come out with efficient more

technology and offer new products to the market.

Director-The General of FRIM, Y.Bhg. Dato' Dr Abd. Latif Mohmod, his in welcoming address, gave the current scenario of the wooden furniture industry as well R&D works carried out by FRIM. He mentioned FRIM has been entrusted with the task of conducting R&D on forest forestry and products to ensure that the R&D work fulfills the

needs of the industry. All the R&D works conducted are guided by the FRIM Strategic Plan and supported by the action plan that was prepared in line with the other economic plans and policies related to the forestry sector.

A total of 15 papers were presented covering topics related to the supply and demand of resources; economic productivity; branding, marketing and trade competitiveness; and sustainability and policy.

In conjunction with the Seminar, industrial visit was organised for interested participants to two selected mills, Seng Yip Furniture Sdn Bhd in Semenyih and Samling Housing Products Sdn Bhd in Port Klang.

Did you also know that...

Exports continued to expand in July 2009, increasing RM3.8 billion or 8.4% from June 2009. Imports increased by 14.2% to RM41.1 billion from the month before. Total trade increased month-on-month by RM8.9 billion or 11% from June 2009. Malaysia also recorded a trade surplus of RM7.8 billion making July 2009 the 141 consecutive month of trade surplus since November 1997.

PUBLIC COMMENTS ON MALAYSIAN STANDARDS DRAFTS AND ON A PROPOSED LIST OF MALAYSIAN STANDARD

STA Secretariat received notification from SIRIM Berhad that they are seeking public comments on a list of Malaysian Standards Drafts and on a proposed list of Malaysian Standards that are to be revoked without replacement. Some of the draft standards in the list that might be relevant are:

ISC B: Chemical and Materials

- 1. 09B032R0— Paper and Board—Determination of bursting strength after immersion in water
- 2. 09B035R1—Paper and Board— Determination of opacity (paper backing) diffuse reflectance method (first revision)

ISC W: Occupational Health and Safety

- 1. 09W001RO—Safety of Machinery—Evaluation of machinery—Evaluation of the emission of airborne hazardous substances—Part 1: Selection of test methods
- 2. 09W003R0—Safety of Machinery—Evaluation of emission of airborne hazardous substances—Part 2: Tracer gas method for the measurement of the emission rate of a given pollutant.



LACEY ACT DECLARATION UPDATE

The Animal and Plant Health Inspection Service (APHIS) published a Federal Register notice with updates to the implementation schedule for Lacey Act declarations. Among the comments received and the revised Phase-In Schedule Enforcement are as follows:

- 1. APHIS will delay enforcement of the declaration requirement for products containing composite and recycled or reused material (e.g. MDF, particleboard and scrap wood) until at least 1 September 2010.
- 2. APHIS is still evaluating the blanket declaration suggestion, in lieu of shipment-by-shipment declarations, for routine and/or repeat shipments.
- APHIS has removed some items from Phase III which is scheduled to begin on 1
 October 2009, which include wood pulp and wood charcoal.
- 4. In circumstances where the list of possible species in a product includes all species in a genus, it is acceptable to use 'spp.' following the genus name on the import declaration form. However, when reference to all possible species in a genus is not accurate, importers are expected to provide either the single genus and species, or a specific list on the import declaration form of all possible species used to produce the plant product.
- 5. APHIS is seeking comments on other HTS chapters/subchapters that could be included after 1 September 2010 and the applicability of the declaration to other products not already included in the revised phase-in schedule or previously listed. Other products include Chapters 44 (wood & articles of wood) and 94 (furniture).
