Leveraging In-House Resources to Fuel **Transition towards Self-Regulation in the** Forestry and Timber Industry

The shared interest between the The Training, held in support of the Natural Resources and Environment ECA, was conducted by a team of Board (NREB) and Sarawak Timber trainers with vast experience in the Association (STA) to ensure smooth field of water sampling from UNIMAS. and full implementation of the Natural Resources and Environment (Audit) was engaged by STA to train its Rules, 2008 (Rules) within the forestry and timber industry involves efforts to improve guidelines on the Rules as well as to build capacity through the conduct of Pilot Projects for Environmental Compliance Audit (ECA) and trainings.

Presentation Ceremony of Cash Awards, **Financial Contributions to Educational & other Non-profit Organisations, and STA & Daiken Scholarships**

Sarawak Timber Association (STA) through its subsidiary company, STA Mutual Sdn Bhd (STAM), organised three (3) Presentation Ceremonies of Cash Awards in Kuching, Miri, and Sibu. Apart from giving out the Cash Awards, STAM also presented financial contributions to educational and other non-profit organisations, as well as the STA and Daiken Scholarships.

The first Presentation Ceremony (PC) was held on the 26 July 2018, at Imperial Hotel, Kuching and attended by approximately 400 persons which includes invited guests namely Mr Jack Liam, Deputy Director of Forests cum Member of the Board of Honorary Advisers of STAM, Mr Philip Choo Kwong Hui, Company Secretary of STAM cum Honorary Treasurer of STA, Mr Simon Wong and Ms Bernadine Anak Jacob Acha from Daiken Corporation, officers from government agencies, Deans, Professors and lecturers from various universities, members of media as well students and their parents/guardians.

Pemanca Datuk Wong Kie Yik, Chairman of STA in his welcoming address, emphasised the continuous dedication of the Association in carrying out activities to improve the welfare of the community, especially in encouraging and supporting education in the State.

The Guest of Honour, Dato Sri Michael Manyin Jawong, the Minister of Education, Science and Technological Research Sarawak, expressed his gratitude to STA

for the contributions made in recognising outstanding students from Sarawak, and added that he Ministry would be introducing a pilot project in few schools in the State starting this year to monitor the performance of students. 212 students who excelled in their 2017 SPM and STPM public examinations were present to receive their Cash Awards at the PC, of a total of 1,465 selected students from Sarawak. To date, the STA Cash Awards has benefitted a total of 3,044 students, amounting to approximately RM 1.8 million.

Did you know that.....

The size of Eucalyptus pellita seed plays an important role in influencing rooting emergence, normal germination as well as the root and hypocotyls length. A study found that medium and large seeds have higher rooting emergence and germination compared to smaller seeds due to the bigger seeds' ability to take nutrient from the cotyledon, thus also having a positive effect on seed germination and early plant growth which is evident by longer root and hypocotyls observed in these seeds.

Did you also know that....

A study conducted to understand growth potential and regeneration status of logged-over forests in Sarawak has revealed that the recovery process and growth of tree species in logged-over forest are not only attributed to factors such as the presence of remaining adult trees, saplings and seedlings but are also influenced by environmental factors such as intensity of logging, light intensity in the forest, terrain, altitude, temperature, humidity, rainfall and soils.
