The STA Council held its Meeting No 1/2018 on 9 March 2018 at Wisma STA, Kuching. The Meeting was presided over by Pemanca Datuk Wong Kie Yik, the Chairman of the Association and attended by Dato Henry Lau, the Honorary Secretary, Mr Philip Choo, the Honorary Treasurer and twenty two members of the Council.

The Meeting received reports from the various Category Committees and Working Committees. The Meeting also approved several activities to be carried out by the Association, such as the Environmental Compliance Audit Training Courses, pilot projects for Environmental Compliance Audit for members in the category of small and medium enterprises, compilation of relevant sections of applicable laws in the form of a handbook for use by members undergoing forest management certification and briefing for members on changes in labour and immigration policies and procedures.

The Annual General Meeting (AGM) of Sarawak Timber Association (STA) was held on 28 March 2018 at Wisma STA, Kuching. The AGM was attended by representatives from 181 member companies. This year is an election year whereby members attending the AGM elected the STA Council members for the term of 2018 & 2019.

During the Meeting, Pemanca Datuk Wong Kie Yik, Chairman of STA presented the Report of the Council on the activities of the Association for the year 2017.

The Meeting also dealt with matters related to subsidiary companies of the Association, namely STA Enterprises Sdn Bhd, STA Training Sdn Bhd, STA Mutual Sdn Bhd and STA Ventures Sdn Bhd.

The following is the Chairman's Message.

Chairman's Message

Annual Report on the Workings of STA for Year 2017

It is with great pride that I highlight to you STA's works, undertaken to provide support to members of the Association in line with its objectives.

To begin with, the various initiatives undertaken by the State's forestry agencies in 2016 have kept STA busy throughout the year 2017. STA's members have regularly met to discuss and develop measures to comprehend new initiatives as well as changes introduced to policies and its unintended consequences. Similarly, a lot of efforts were made to articulate its concerns to the policy makers as STA seeks to close both the implementation and compliance gaps.

In retrospect, the untimely demise of the 5th Chief Minister of Sarawak, late Pehin Sri (Dr) Haji Adenan bin Haji Satem on 11 January 2017 had a huge impact on the forestry and timber industry as he had played a crucial role in spearheading the battle against illegal logging and steering the direction of the State's forestry and timber industry towards sustainable forest management (SFM).

The current Chief Minister, the Right Honourable Datuk Amar Abang Johari bin Tun Abang Haji Openg took over the reins of power from the late Adenan and held on to the visions his predecessors, Tun Pehin Sri Haji Abdul Taib Mahmud and Pehin Sri (Dr) Haji Adenan bin Haji Satem had, for the forestry and timber industry. He has placed great emphasis on the development of planted forests in Sarawak to alleviate the pressure on harvesting from the natural forests and to ensure sustainability of the downstream timber industry in Sarawak. He has also advocated for more research and development (R&D) in the areas of planted forests, especially planting of indigenous species that can be harvested within five (5) years and the utilisation of such planted timber by the downstream processing sector.

STA would like to point out that it is inequitable to compare Sarawak's forest plantation industry to the mature forest plantations elsewhere in the world as growth and survival of each species are attributed to several factors such as climate and topography, which varies from one place to another. These variables coupled with other site-specific pressures that the species are exposed to, may work in combination and increase the pressure on this species to survive. Therefore, the species of trees planted in other countries may not be suitable to be planted in Sarawak. Furthermore, Sarawak's forest plantation industry is relatively young in comparison to countries such as Finland, Sweden and New Zealand and the Government as well as the industry are still exploring suitable species to be planted in the tropical climate and difficult terrains of Sarawak.

In its continuous support towards R&D activities for the benefit of the forestry and timber industry, STA, through its Forest Plantation Committee has funded several R&Ds carried out by government agencies, universities and member companies over the years in the hope of improving the quality of the planting materials and enhancing the growth of planted trees. So far, STA has funded R&D projects up to a tune of RM6.5 million covering propagation techniques of Meranti, Sawih, Kapur and Kelampayan species, physical properties of *Acacia mangium*, identification of relationship between genetic markers and favourable traits of Kelampayan, formulation of biofertiliser for Kelampayan and *Ecalyptus pellita* as well as genetic improvement of *Acacia mangium* and Batai species. STA has also, in cooperation with Sarawak Forestry Corporation Sdn Bhd (SFC), conducted a weight to volume conversion factor study for both Kelampayan and *Eucalyptus pellita* to derive the conversion factor, for use in the royalty and cess assessments of these two (2) planted species.

Nonetheless, strong support from the State Government is needed to scale up these initiatives into broader strategies for the development and success of the forest plantation in the State. During a study tour to Southern China, the STA Forest Plantation Committee was impressed by the commitment of the Chinese Government in driving the development of its forest plantation. The Chinese Government does not collect royalty and cess on plantation logs, provides infrastructures and established R&D agencies dedicated to conduct research as well as provide technical support and advice. STA would like to implore to the State Government to emulate the unwavering support by the Chinese Government and resolve issues such as claims of native customary rights over land, escalating recruitment and labour costs due to Government's policy of reducing dependency on foreign workers and overlapping administrative controls as well as provide stronger R&D support in order for planting to progress. These issues have caused uncertainties and insecurities, and if not resolved, will hamper the progress of planting.

We thank the State Government for including STA in the review of the Planted Forests Policy and we hope these views would be adopted by the State Government. We also hope that we can participate and contribute in other revisions to the Forests Policies and decisions affecting the industry.

The industry players were taken aback by the manifold increase in Hill Timber Premium, to RM50 per cubic metre, from RM0.80 for all species of logs harvested from hill forests and RM3.00 for logs of hill species from agri-conversion areas. In the face of depressed market, high production costs and competition from other countries, the tremendous increase in the Premium coupled with the decline in log production over the foreseeable future will make it very difficult for the industry to sustain. While STA applauds the efforts taken by the State Government to finance bright students for tertiary studies through Sarawak Foundation Fund, STA feels that the support of such noble initiative should not fall merely on the shoulder of the timber industry alone, for a burden shared is a burden halved.

Conversely, I would like to underscore the good working relationships established with forestry agencies as well as the endless supports rendered by STA for the well-being of the timber trade and industry in Sarawak on other endeavours. STA is proud to be working with the Natural Resources and Environment Board (NREB) through a Working Committee to assist with the implementation of Natural Resources and Environment (Audit) Rules, 2008. The close cooperation between NREB and STA has led to successful launching of pilot projects, conduct of seminar on environmental management in the forestry sector, preparatory meetings as well as training on Environmental Quality Monitoring (EQM) which facilitated the implementation of Environmental Compliance Audit and helped prepare the participating member companies for self-regulation. With all the preparations well under way, the Pilot Projects involving eight (8) member companies had taken off in the first quarter of 2018.

The Sarawak Timber Legality Verification System (STLVS) Standard had been finalised early 2017 with the collective efforts and tenacity of the Association, Forest Department Sarawak (FDS), SFC, Sarawak Timber Industry Development Corporation (STIDC) as well as Harwood Timber Sdn Bhd (HTSB), paving the way for third party verification based on the STLVS Standard. By year 2020, all logs and timber products exported from Sarawak must be verified under the STLVS Standard. The latest development in STLVS was conveyed to STA members in a series of roadshows held in Sibu, Miri, Bintulu and Kuching. STA also actively promotes the STLVS at the international arena.

STA members grasp the importance of sustainable forest management and have answered the State Government's call to undergo forest management certification (FMC). Late last year, the State Government has made it mandatory for all long term timber licences to be certified by year 2022. STA commends the commitment and efforts of its members, who are currently at different stages of the certification process. STA would like to reiterate that the State Government, represented by its forestry agencies, also has a key role to play in helping STA members to overcome the hurdles of achieving FMC such as resolving land claim issues, standardising guidelines and procedures, as well as providing training to build the capacity for skilled personnel for STA members to implement certification in their forest management units.

The process of obtaining forest management certification is not a mean feat; it is a long, costly exercise where the costs are not shared by the buyers of certified timber. With third party verification based on the STLVS Standard and forest management certification all being mandatory for long term licences, it is more reasonable that the verification based on STLVS Standard be made optional for licensees who have obtained forest management certification. STA also welcomed the intention by the State Government to work with Malaysian Timber Certification Council (MTCC) on the mutual recognition of the same components in the STLVS Standard and Malaysian Timber Certification Scheme. Nonetheless, STA believes its members will eventually realise the State Government's aspiration, if the enabling conditions are in place.

STA Training Sdn Bhd (STAT) is currently the only Training Provider appointed under The Forests (Trained Workmen) Rules, 2015. As a Training Provider, STAT has endeavoured to work closely with both FDS and SFC to ensure smooth implementation of the Rules and to extend the training of the five (5) prescribed skills sets under the Rules to all workmen in the forests, including those who are not under the employment of STA members. STAT and SFC had jointly conducted a series of roadshows in Miri, Bintulu, Sibu and Kuching to brief the industry on the implementation of the Rules under Section 51 of the Forests Ordinance 2015 as well as the skills sets offered by STAT.

STA Mutual Sdn Bhd (STAM) has undertaken several Corporate Social Responsibility (CSR) projects with STA member companies during the year. Students studying in schools located within the concession areas of member companies had benefited from school bags and stationeries provided to them by STAM as well as better learning environment through repair works and improvements to the schools' facilities carried out by STA members with funding from STAM.

Other education initiatives by STAM included working with STIDC to improve infrastructures of rural schools in Sarawak and the award of three (3) scholarships to tertiary students and cash awards to an astounding 962 students who had excelled in their Sijil Pelajaran Malaysia (SPM) and Sijil Tinggi Pelajaran Malaysia (STPM) examinations in 2016. STAM also has plans to provide education assistance to twenty (20) vocational students from Institut Latihan Perindustrian Kota Samarahan in 2018.

To accentuate STA's commitment and belief in giving back to the society, STAM had also allocated RM1.07 million to nineteen (19) social and welfare organisations in Sarawak during the year. STA hopes that this amount goes some way in assisting these organisations in financing and implementing specific projects and activities that will improve the overall quality of life and wellbeing of the needy.

On behalf of STA, I would like express our appreciation to Tuan Haji Sapuan Ahmad and Mr Wong Ting Chung, both of whom had retired from their positions as the Director of Forests and the Chief Executive Officer of the SFC, for their assistance and contributions to the timber industry.

In conclusion, the accomplishments over the past year and the work ahead depends on the dedication of STA Secretariat, supports and active participation from STA members and most importantly, the State forestry ministry and its agencies. STA is positive that these constructive endeavours undertaken collectively by parties that share the same objectives for the well-being of timber trade and industry can address the shortcomings and provide the remedy for the unrest in the industry.

The meeting was chaired by its Chairman, Pemanca Datuk Wong Kie Yik, and was attended by Mr Philip Choo Kwong Hui, Company Secretary of STA Mutual Sdn Bhd, Temenggong Dato Vincent Lau Lee Ming, Mr Ho Yam Kuan, Mr Jack Anak Liam, Advisor from Forest Department Sarawak and Mr Dahrwani Muhammad, representative from Sarawak Timber Industry Development Corporation.

In this Meeting, amongst the many issues deliberated, the members of the BHA resolved to recommend the following decisions to the Company's Board of Directors for approval:

STA Training Sdn Bhd Board of Directors Meeting No 1/2018

STA Training Sdn Bhd (STAT), a subsidiary company of Sarawak Timber Association (STA) held its Board of Directors Meeting No 1/2018 on 5 March 2018 at Wisma STA, Kuching.

The Meeting was updated on training activities i.e. skills training of the Company for the months of October 2017 to February 2018; the trainers/assessors of the Company made twenty six (26) trips to various camps: nineteen (19) trips for assessing and seventeen (17) trips for delivering training seminar. A total of 205 workmen had been assessed and found to be competent.

During the Meeting, the Board of Directors had deliberated matters pertaining to the Financial Incentive Scheme for Training of Forestry Workmen, and Forests (Trained Workmen) Rules, 2015.

As the Fourth Cohort of the Postgraduate Diploma in Applied Science (*Sustainable Tropical Forest Management/ Sustainable Tropical Plantation Management*) will be having their graduation capping ceremony at Lincoln University in Christchurch, New Zealand on 13 April 2018, the Board in its meeting had also approved for one (1) Member of the Board of Directors and two (2) staff members of the Company to attend the Graduation Ceremony as well as study tour in New Zealand. The Board of Directors also approved the Directors' Report and Audited Financial Statements of the Company for the year ended 31 December 2017 and dealt with any matters arising therefrom.

Apart from that, the Board of Directors had also ratified the Emergency Expenditures for the months of December 2017.

Series of Roadshows on Sarawak Timber Legality Verification System Standard

A series of Roadshows on Sarawak Timber Legality Verification System (STLVS) Standard was jointly organised by the Ministry Urban Development of and Natural Resources (MUDeNR), Forest Department Sarawak (FDS), Sarawak Forestry Corporation Sdn Bhd (SFCSB), Sarawak Timber Industry Development Corporation (STIDC), Harwood Timber Sdn Bhd (HTSB) and Sarawak Timber Association (STA) in four (4) venues across Sarawak.

The Roadshow, conducted to brief the forestry and timber industry on the State Government's policy on

STLVS, STLVS Standard and its implementation were held at (i) Imperial Hotel, Miri on 12 March, (ii) Promenade Hotel, Bintulu on 14 March 2018, (iii) Kingwood Hotel, Sibu on 19 March, and (iv) Dewan Seminar STIDC on 27 March 2018, and were attended by approximately 500 participants from the industry and forestry agencies.

The Deputy Director of Forests, Tuan Jack Anak Liam introduced to the participants the STLVS Standard and informed them that the STLVS Standard allows licensee or company to engage an independent third party auditor to verify the company's compliance to STLVS requirements. He added that verification will be able to provide legality assurance to buyers on the timber and timber products exported from Sarawak. He further informed participants of the Roadshow that by 2020, only STLVS-verified timber and timber products will be allowed for export.

During the Roadshow, two (2) presentations were made by Ms Eveleen Augustine Lai, Forest Officer of FDS and Mr Afizulmizam Bin Afandi, Manager (Industrial Development) of STIDC, covering all the six (6) Principles in the Standard.

The State Government's policy requires both Forest Management Certification (FMC) and STLVS third party auditing to be carried out. However, the forestry agencies recognise that some criterion in the STLVS Standard overlaps with that of the Malaysian Criteria and Indicators for Forest Management Certification (Natural Forest) [MC&I (Natural Forest)], and that undertaking both audits will burden the licensee or company in terms of cost and time. Therefore, FDS tasked by the MUDeNR, is to discuss with Malaysian Timber Certification Council (MTCC) on mutual recognition of some of the components in STLVS and FMC to avoid duplication in auditing.

Jelajah bertujuan untuk memberi penerangan kepada peserta industri perhutanan dan perkayuan mengenai polisi Kerajaan terhadap STLVS, STLVS Standard dan pelaksanaannya telah diadakan di (i) Hotel Imperial, Miri pada 12 Mac, (ii) Hotel Promenade, Bintulu pada 14 Mac 2018, (iii) Hotel Kingwood, Sibu pada 19 Mac, dan (iv) Dewan Seminar STIDC pada 27 Mac 2018. Timbalan Pengarah Hutan, Tuan Jack Anak Liam memperkenalkan Standard STLVS dan memaklumkan kepada para peserta bahawa Standard STLVS membenarkan pemegang lesen atau syarikat untuk melaksanakan audit pihak ketiga bagi mengesahkan pematuhan syarikat terhadap keperluan STLVS. Beliau memaklumkan bahawa pengesahan yang dibuat dapat memberi jaminan kepada pembeli bahawa produk kayu dan balak yang dieksport dari Sarawak adalah dari sumber yang sah.

Meeting on *"Issues and Challenges Faced by the Forestry and Timber Industry"*

A meeting on *"Issues and Challenges Faced by the Forestry and Timber Industry"* was called by Dr Haji Wan Lizozman Bin Wan Omar, Permanent Secretary of the Ministry of Urban Development and Natural Resources (MUDeNR) on 2 March 2018 at Wisma Sumber Alam, Kuching. The Meeting was attended by representatives from Forest Department Sarawak (FDS), Harwood Timber Sdn Bhd (HTSB), Sarawak Forestry Corporation Sdn Bhd (SFCSB), Sarawak Timber Industry Development Corporation (STIDC) and Sarawak Timber Association (STA). The Meeting was held to discuss the issues and challenges faced by the forestry and timber industry that were submitted by STA to MUDeNR on 31 July 2017.

Ms Annie Ting, Senior Manager of STA presented the unresolved issues in the field of Forest Management Certification (FMC), Forest Plantation, downstream policy and training in the forestry sector, including new issues such as statutory and administrative charges and manpower. Dr Peter Kho, General Manager of STA appealed to the State Government to look into the unresolved issues faced by the forest plantation industry especially those that are beyond the control of the Licence for Planted Forests (LPF) holders. Without the assistance from the State Government, the LPFs will not be able to achieve the target of 40,000 ha planted areas for 2018 as required by the Catch-up Plan.

Dr Haji Wan Lizozman informed the Meeting that the State Government is firm with its decision to make FMC mandatory by the year 2022 and will facilitate the Forest Management Units (FMUs) to obtain FMC. In order to achieve this, the State Government tasked FDS to work with other agencies including STA to formulate the Certification roadmap for Sarawak, and to harmonise the guidelines for FMC in the *"Green Book"*. He agreed for STA to be one of the members of the FMC Steering Committee. He also informed the Meeting that it is mandatory for all logs and timber products exported from Sarawak to be verified under the STLVS Standard by year 2020.

Officers from FDS shared with the Meeting that a new division will be set up to handle certification matters and trainings such as on Reduced Impact Logging (RIL), Forest Resource Assessment (FRA), Permanent Sample Plots (PSPs), Community Relation Committee (CRC), Free, Prior and Informed Consent (FPIC) as well as Training for Auditors will be conducted and also offered to representatives from the industry. They added that the reference documents used for Forest Management Certification Licence Agreement (FMCLA), a document to be signed between licence holders and FDS upon achieving certification are Forests Ordinance 2015, Forest Rules and License Conditions. Furthermore, elements repeated elsewhere such as Forest Management Plan (FMP), etc have been removed from the latest draft of FMCLA.

The Meeting also discussed on the ongoing disputes and unresolved claims on native customary rights (NCR) made within FMU as well as LPF areas. The Meeting resolved to form a Conflict Resolution Committee (CRC), comprising representatives from the FMU and communities be established. The Meeting recognised that some criterion in the STLVS Standard overlaps with the Malaysian Criteria and Indicators for Forest Management Certification (Natural Forest) [MC&I (Natural Forest)], and undertaking both audits will burden the licensee's company in terms of costs and time. Therefore, FDS, tasked by the MUDeNR, will work together with Malaysian Timber Certification Council (MTCC) to conduct an evaluation on the mutual recognition of some of the components in STLVS and FMC to avoid duplication in auditing.

The Meeting had also agreed for FDS to work with MTCC to address the cut-off date set in the Programme for Endorsement of Forest Certification (PEFC) Meta Standard.

旺利佐兹曼在会议中表示州政府坚决在2022年必须实施森 林管理认证(FMC),并将促成森林管理单位(FMUs)取 得森林管理认证。

Mesyuarat mengenai *"Isu dan Cabaran yang Dihadapi Industri Perhutanan dan Perkayuan"* telah dipanggil oleh Dr Haji Wan Lizozman Bin Wan Omar, Setiausaha Tetap Kementerian Pembangunan Bandar dan Sumber Asli (MUDeNR) pada 2 Mac 2018 di Wisma Sumber Alam, Kuching untuk membincangkan isu-isu berkaitan yang dikemukakan oleh STA kepada MUDeNR pada 31 Julai 2017.

Dr Peter Kho, Pengurus Besar STA memohon Kerajaan Negeri untuk melihat isu-isu yang belum diselesaikan, justeru terus dihadapi oleh industri perladangan hutan terutamanya yang berada di luar kawalan pemegang lesen hutan tanam (LPF). Tanpa bantuan daripada Kerajaan Negeri, pihak pemegang lesen tidak akan dapat mencapai sasaran kawasan tanaman seluas 40,000 ha untuk tahun 2018 seperti yang dikemukakan dalam Pelan Mengejar Target.

Dr Haji Wan Lizozman memaklumkan bahawa Mesyuarat Kerajaan Negeri tetap dengan keputusannya untuk menjadikan Pensijilan Pengurusan Hutan (FMC) mandatori menjelang tahun 2022 dan akan membantu Unit Pengurusan Hutan (FMU) dalam proses mendapatkan Sijil tersebut.

1st Sarawak Ram

The Forest Department Sarawak (FDS) in conjunction with the World Wetlands Day 2018 organised the 1st Sarawak Ramsar Seminar 2018 with the theme "Wetlands for Sustainable Urban Future" on 2 March 2018 at the Hilton, Kuching. Approximately, ninety (90) participants from government agencies, private sectors and civil societies attended the Seminar.

World Wetlands Day is celebrated on every 2 February, to raise global awareness on the importance of wetlands for the people and the planet. As Sarawak moves towards a developed State by 2030, the need to conserve wetlands is becoming more critical. This is due to the importance of wetlands for sustainable urbanisation. Urban wetlands are essential to making cities liveable.

Ramsar is an intergovernmental treaty where it provides the framework for national action and international cooperation for the conservation and wise use of wetlands and their resources.

This Seminar, brought together experts and conservation practitioners, aimed to:

- share experiences and lessons learnt in managing wetlands and other Ramsar sites within Malaysia,
- address issues and challenges towards the effective and efficient management of the Sarawak Ramsar site, and
- explore the possibilities of inter-agencies and other stakeholders' collaboration in managing Sarawak Ramsar site.

Eight (8) papers were presented in the Seminar as follows:

Paper 1: Managing Ramsar Site in Johor – Pulau Kukup and Tanjung Piai Johor

- by Hajah Maziah Fadilah Binti Wan Mohamed, Perbadanan Taman Negara Johor

The speaker spoke about the core business for both national parks which included conservation, research, education and eco tourism. She also briefed the participants of the Seminar on the conservation efforts such as the purchase of operation equipments to overcome the issue of oil spillage and creating continuous community awareness to the public.

Paper 2: Sabah Forestry Department - Steps in Managing Lower Kinabatangan-Segama Ramsar Site

- by Haji Hussin Tukiman, Sabah Forestry Department

The speaker briefed the participants of the Seminar on the development of a 10 year Management Plan (2011-2020) in managing its Kinabatangan-Segama Ramsar site in order to protect and restore key ecosystem services and environmental values. He also spoke about the challenges they have faced in terms of limited operational capacity which included technical skills and financial strength.

Paper 3: Forest Department Sarawak – In Managing Ramsar Site

- by Mr Suliman Haji Jamahari, Forest Department Sarawak

The speaker emphasised on the progress and achievement in managing Kuching Wetlands National Park (KWNP), the State's Ramsar site. The success stories included diverse species of fauna in the national park being recorded, activities such as tourism and community project were encouraged as well as the planting of 87,916 mangrove trees to restore the degraded mangrove forest area.

Paper 4: Flora and Fauna of Kuching Wetlands National Park

- by Professor Dr Gabriel Tonga Noweg and Professor Dr Andrew Alek Tuen, Universiti Malaysia Sarawak

Both presenters presented separately on the distribution of flora and fauna that can be found in Kuching Wetlands National Park (KWNP) Ramsar site and agreed that wildlife tour is the main attraction of the Site. They also mentioned that the flood mitigation channel is the major threat to the mangrove ecosystem.

Paper 5: Tourism Potential Activities at Sarawak Ramsar Site

- by Dr Bolhan Budeng, Ministry of Tourism, Arts,
- Culture, Youth and Sports Sarawak

The speaker spoke about the facilities offered by Kuching Wetlands National Park (KWNP) Ramsar site which can be developed into a preferred tourism activity. He also shared with the participants of the Seminar how tourism activities can benefit both the local community and tourists in terms of economy, assessment of trained and qualified guides and added value factor such as flagship species attractions and unique cultural features.

Paper 6: Agro Pelancongan Berkonsepkan Akuakultur - by Ms Martinah Haji Teridi, Persatuan Nelayan

Kawasan Satang Biru, Telaga Air

The speaker shared with the participants of the Seminar some of their current and proposed projects which have

been implemented such as homestay, providing fishing boats for sports activities and processing of fishery products as well as shrimp, fish and crab breeding.

Paper 7: A Preliminary Fireflies Study at Sarawak Ramsar Site

- by Mr Paulus Meleng, Forest Department Sarawak

The speaker shared with the participants of the Seminar his study on fireflies. The study aimed to come out with an inventory of fireflies as well as to identify potential areas for tourism. He also presented the types and distribution of trees which are favored by the fireflies and their distribution within the project area in the Kuching Wetlands National Park (KWNP). He emphasised on the importance of fireflies conservation because the existence of fireflies is an indication of a healthy forest.

Paper 8: Japan-Malaysia Association Proposed Mangrove Rehabilitation Program

- by Mr Arai Takuji, Japan-Malaysia Association

The speaker spoke on the efforts taken in contributing to the mangrove rehabilitation program. Examples of activities were planting of depterocarpaceae tree species, maintenance, raising seedlings and environmental education program. The Association has established a Friendship Forest Project in Sarawak in 1995 with support from FDS and the local community for reforestation purposes. In addition, research and educational activities had been conducted with the cooperation of Universiti Malaysia Sarawak (UNIMAS) and a few local schools in 2010.

The Seminar ended with the special keynote address by Professor Dr Shigeru Kato, Advisor to the President of Walailak University, Thailand on "Mangroves Restoration Program in Thailand" and a closing ceremony.

Mr Hamden Bin Mohammad, Acting Director of Forests, FDS in his closing speech said that Sarawak is proud for its Kuching Wetlands National Park (KWNP) for being listed as one of the Ramsar sites in an effort towards global conservation. He said that ongoing efforts of replanting mangrove seedlings should be done to restore the mangrove forest area within KWNP that had been damaged. He also thanked the public, private sectors and media for their active participation in promoting the initiative and invited other organisations to participate in the 100,000 mangrove trees journey initiative by FDS. He then presented certificates to bodies and organisations who have contributed to the planting of mangrove seedlings for the 100,000 mangrove trees journey initiative.

Jabatan Hutan Sarawak (FDS) telah menganjurkan Seminar Ramsar Sarawak 2018 yang Pertama dengan tema *"Tanah Lembap untuk Masa Depan Bandar yang Mampan"* pada 2 Mac 2018 di Hilton, Kuching.

Seminar tersebut dianjurkan bersempena dengan Hari Tanah Lembap Sedunia 2018 yang dirayakan setiap 2 Februari untuk meningkatkan kesedaran global tentang kepentingan tanah lembap untuk rakyat dan planet. Kepentingan memulihara tanah lembap di Sarawak adalah kritikal selaras dengan arah tuju yang dihala, iaitu ke arah negara maju menjelang 2030.

Ramsar merupakan perjanjian antara kerajaan yang menyediakan kerangka kerja untuk tindakan nasional dan kerjasama antarabangsa untuk pemuliharaan dan pemanfaatan tanah lembap dan sumbernya.

Seminar ini bertujuan untuk (i) menggalakkan perkongsian pengalaman dan pengetahuan yang diperolehi dalam pengurusan tanah lembap dan tapak Ramsar lain di Malaysia, (ii) menangani isu dan cabaran serta (iii) meneroka kemungkinan kerjasama antara agensi dan pihak berkepentingan lain dalam menguruskan tapak Ramsar di Sarawak.

Lapan (8) kertas kerja telah dibentangkan dalam Seminar seperti yang tersenarai dalam artikel ini.

Encik Hamden Bin Mohammad, Pemangku Pengarah Hutan dalam ucapan penutupan beliau berkata Sarawak berbangga kerana Taman Negara Tanah Lembap Kuching telah disenaraikan sebagai salah satu tapak Ramsar dalam usaha ke arah pemuliharaan global. Beliau juga mengucapkan terima kasih kepada orang ramai, sektor swasta dan media atas penyertaan aktif mereka dalam mempromosikan inisiatif tersebut dan menjemput organisasi lain untuk mengambil bahagian dalam inisiatif FDS untuk menanam semula 100,000 pokok bakau bagi memulihkan kawasan hutan bakau.

International Day

The forests, covering one third of the Earth's land mass, provide valuable ecological, economic, social, and health benefits. On 21 December 2012, the United Nations General Assembly adopted the resolution which declared that 21 March of each year is to be observed as the International Day of Forests (IDF) around the world. Before this, the commemoration was known as World Forestry Day. The change was done to reaffirm and raise awareness amongst people the importance of all types of forests and trees for the good of current and future generations.

The year 2018 marked another memorable state-level IDF celebration for Sarawak. Themed "Forest and Sustainable Cities", which puts emphasis on making our cities greener, healthier, happier places to live, this year's official launching ceremony was held on 31 March 2018, at Sekolah Kebangsaan (SK) Abang Haji Matahir, Sarikei. The event was attended by approximately 400 participants including representatives from the Forest Department Sarawak (FDS), Harwood Timber Sdn Bhd (HTSB), Ministry of Urban Development and Natural Resources (MUDeNR), Sarawak Forestry Corporation (SFC), Sarawak Timber Industry Development Corporation (STIDC), local government officers, teachers, students, and members of the media. Sarawak Timber Association (STA) was represented by Mr Peter Ling Kwong Hung, STA Council member, Dr Peter Kho, STA General Manager as well as staff members of STA Secretariat.

The Deputy Chief Minister of Sarawak Datuk Amar Haji Awang Tengah Ali Hasan who is also the Second Minister of Urban Development and Natural Resources cum Minister of Industrial and Entrepreneur Development in his opening speech said that the State Government acknowledges the value and importance of the forests and the various roles they perform. According to him, the Government is committed in managing its forests holistically, which is reflected in the implementation and enforcement of various strategies such as Permanent Forest Estate (PFE), Totally Protect Area (TPA), curbing illegal logging activities, Sarawak Timber Legality Verification System (STLVS), and Sustainable Forest Management (SFM). He also called upon all timber industry players to align themselves to these changes and be prepared to adopt new processes.

After his speech, the Deputy Chief Minister was invited to officially launch the State's IDF 2018 celebration, where he unveiled a Vatica adenanii sapling and the book "Kuching Wetland National Park". As part of STA's corporate social responsibility (CSR), Mr Peter Ling presented three (3) sets of computers which were handed over by the Deputy Chief Minister to Mr Hishammudin Bin Gimin, the Headmaster of the school hosting the event. During the function, a total of 110 primary and 12 secondary schools in the Sarikei, Meradong, Julau and Pakan Districts also received financial assistance from a project collaboration between Sarawak Timber Industry Development Corporation (STIDC) and STA Mutual Sdn Bhd (STAM), a subsidiary company of STA. The project has been administered by STIDC since year 2012, aiming to provide a more conducive environment for learning and teaching in schools through improving facilities in the selected schools. The financial assistance had been

disbursed in phases, which Sarikei, Meradong, Julau and Pakan Districts were under Phase Seven. So far, a total of 516 primary schools and 90 secondary schools had received financial assistance from this fund. The financial assistance disbursed under Phase Seven has been increased from RM1,000.00 to RM2,000.00 for primary schools and for secondary schools from RM2,000.00 to RM5,000.00.

At the presentation ceremony, Mr Radin Foji Bin Radin Abdul Rahim, Sarikei District Education Officer received a mock cheque in a sum of RM113,000.00, while Mr Ismail Abang Mahamud, Meradong District Education Officer, received a mock cheque in a sum of RM84,000.00, and Mr Asas anak Ranggau, Education Officer of Julau and Pakan District, received a mock cheque in a sum of RM83,000.00. Meeting on Industry 4.0 Awareness Programme for the Timber Industry

A meeting on Industry 4.0 Awareness Programme for the Timber Industry was organised by the Ministry of Industrial and Entrepreneur Development Sarawak (MIED Sarawak) on 14 March 2018 at Wisma Sumber Alam, Kuching. The Meeting was attended by representatives from Forest Department Sarawak (FDS), Ministry of Urban Development and Natural Resources (MUDeNR), Sarawak Forestry Corporation Sdn Bhd (SFCSB), Sarawak Timber Industry Development Corporation (STIDC), University Malaysia Sarawak (UNIMAS) and Sarawak Timber Association (STA). The Meeting was chaired by Mr Suria Bin Bujang, Principal Assistant Secretary of MIED Sarawak.

The objectives of the Meeting were to encourage the timber industry to adopt Industry 4.0 and establish ways to increase the export of timber from Sarawak.

Mr Suria informed the Meeting that the timber industry is moving towards automation systems with minimal input from human operators, by utilising cyber-physical systems such as machines and robotics which is in line with the Fourth Industrial Revolution (IR4) strategy.

The Meeting saw active participation from members, discussing the latest technologies that can ensure the value-added timber products meet international standards and penetrate more overseas markets. In addition, the Meeting acknowledged the importance of R&D for timber industry. Taiwan was highlighted as one of the countries with the strongest R&D and Mr Suria hoped that industry players can learn from them. The Meeting also discussed the possibility of setting up a centre to monitor and test timber products against international standards before granting approval to industry players to mass produce these items for export. However, industry players are faced with problems such as limited resources and funds for R&D and hoped that the Government can assist them, in terms of coming out with favourable policies and funds.

The Meeting emphasised the importance of sustainability and forest conservation and at the same time improving the chain supply management of timber industry through the utilisation of the latest technology in line with Industry 4.0. The Meeting concluded that there is a need for collaboration between STA and MUDeNR in organising a series of roadshows on effective engagement and information on implementing Industry 4.0 in different regions of Sarawak.

苏里亚(译名)先生在会议上告知,透过利用网络物理系 统如机械与机器人,使得木材工业得以迈向自动化系统, 达至最低劳动力操作。这也与工业革命4.0策略(简称IR4)之目的平行。

会议总结砂拉越木材公会与砂城市发展与天然资源部有必 要携手举办一系列有关有效资讯互动路演,以便在砂拉越 不同地区落实该项4.0计划。

Satu mesyuarat mengenai Program Kesedaran Industri 4.0 untuk Industri Perkayuan telah dianjurkan oleh Kementerian Pembangunan Perindustrian dan Usahawan Sarawak (MIED Sarawak) pada 14 Mac 2018 di Wisma Sumber Alam, Kuching. Mesyuarat dipengerusikan oleh Encik Suria Bin Bujang, Ketua Penolong Setiausaha MIED Sarawak.

Objektif Mesyuarat adalah untuk menggalakkan industri perkayuan mengguna pakai Industri 4.0 dan mewujudkan pendekatan untuk meningkatkan eksport kayu dari Sarawak. Encik Suria memaklumkan bahawa industri perkayuan sedang bergerak ke arah sistem automasi dengan input minimum dari pengendali manusia, dengan menggunakan sistem siber-fizikal seperti mesin dan robotik sejajar dengan strategi Revolusi Perindustrian Keempat (IR4).

Mesyuarat menyimpulkan bahawa terdapat keperluan di antara STA dan MUDeNR untuk menganjurkan satu siri roadshow mengenai penglibatan dan maklumat pelaksanaan Industri 4.0 di Sarawak.

Meeting with Head of East Malaysia Region of Human Resources Development Fund

Officers from the STA Secretariat met with Ms Tinah Jerome, Head of East Malaysia Region of the Human Resources Development Fund (HRDF) on 15 March 2018 at Wisma STA, Kuching to discuss how HRDF can facilitate STA members in their human capital development in terms of training, re-skilling and up-skilling as well as leadership development.

Ms Tinah briefed the Meeting on the HRDF initiatives; namely (1) 1Malaysia Outplacement Centre (1MOC), (2) Train and Replace Programme (T&R), (3) Graduates Enhancement Programme for Employability (GENERAtE), (4) Small & Medium Enterprises (SMEs) Up-Skilling Programme and Certification, (5) Value-added Programmes identified by the Sectorial Training Committees (STCs), and (6) Special Fund for Industrial Association Programme and Rural Accelerated Industrial Skill for Employment (RAISE) to address and facilitate human capital development.

Dr Peter Kho, General Manager of Sarawak Timber Association (STA) explained that there is a need to improve the human talent to increase the efficiency of the manufacturing process of timber products as the current rising costs in terms of minimum wage, raw material, limited resources, etc. have affected the industry. He said currently the employers in Malaysia do not have a structured training plan as training is conducted on an adhoc basis. Moreover, employers are reluctant to send employees for training as employees expect a pay rise after the training and if there is no increase in their salaries, they would resign and seek employment with other companies. When employers lost their staff after training, this will affect their productivity. Currently, there is also an acute shortage of skilled labour in the market. In addition, most training programmes conducted are not directly relevant to the forestry and timber industries.

Dr Peter Kho inquired about the status of the Regional Training Committee (RTC). He suggested RTC to look into three (3) aspects of forestry and timber industries; namely (a) manufacturing, (b) plantation and (c) forestry.

He also highlighted that STA members are unable to access to the training programme under 30% pool fund as most training programme are not relevant to the forestry and timber industries. He added that STA Training Sdn Bhd (STAT), a subsidiary company of STA, has been offering skills training development to STA members since 2004 as requested by the State Government. STAT worked together with Forest Industries Training & Education Council (FITEC), New Zealand to develop the Sarawak Modular Training Framework for the forestry and timber industries. Training in twelve (12) prescribed activities such as tree felling, log extraction, log loading, clear fell site preparation, mechanical site preparation, harvesting and etc are currently been offered.

Ms Tinah explained that the 30% pool fund is fully funded by HRDF for the industrial association programme. She informed the Meeting that other industries i.e. hotel and steel in Sarawak have already utilised the 30% pool fund but not the forestry and timber industries. She requested STA to submit the training proposals together with the profile of the training providers who are registered with HRDF to her for consideration. She also encouraged STA members to register with HRDF to tap on the initiatives in training provided by HRDF. She further informed the Secretariat that if STA organises any events for its members, STA can invite HRDF to give a briefing on the 30% pool fund, initiatives and schemes.

Both parties agreed to work together to come out with a relevant training for the forestry and timber industries using the 30% pool fund.

砂拉越木材公会总经理许晋生博士解释说基于成本的提升,就最低薪、原材料、有限资源等而言,都在影响该项领域,因此有必要提高员工才能以提升木材产品生产过程的效率。

他也指出,由于大多数培训计划与林业和木材工业无关, 该会会员无法享有30%的集合资金下的培训计划。

STA Secretariat bertemu dengan Cik Tinah Jerome, Ketua Dana Pembangunan Sumber Manusia (HRDF) Wilayah Malaysia Timur pada 15 Mac 2018 di Wisma STA, Kuching untuk membincangkan bagaimana HRDF dapat membantu ahli STA dalam pembangunan modal insan dari segi latihan, kemahiran semula dan peningkatan kemahiran serta pembangunan kepimpinan.

Dr Peter Kho, Pengurus Besar Persatuan Kayu Kayan Sarawak (STA) menjelaskan bahawa terdapat keperluan untuk meningkatkan bakat manusia bagi meningkatkan kecekapan proses pembuatan produk kayu berikutan peningkatan kos semasa dari segi gaji minimum, bahan mentah, sumber terhad, dan sebagainya yang telah menjejaskan industri.

Beliau juga menekankan bahawa ahli STA tidak dapat mengakses program latihan di bawah 30% dana terkumpul kerana kebanyakan program latihan tidak berkaitan dengan industri perhutanan dan perkayuan.

Cik Tinah minta STA untuk mengemukakan cadangan latihan bersama profil penyedia latihan yang berdaftar dengan HRDF kepadanya untuk dipertimbangkan. Beliau turut menggalakkan ahli STA mendaftar dengan HRDF untuk menikmati inisiatif dalam latihan yang disediakan oleh HRDF.

Kedua-dua pihak bersetuju untuk bekerjasama bagi mewujudkan latihan yang berkaitan untuk industri perhutanan dan perkayuan dengan menggunakan 30% dana terkumpul.

STA Forest Plantation Committee Meeting No 1/2018



Meeting in progress

The STA Forest Plantation Committee Meeting No 1/2018 was convened on 6 March 2018 at Wisma STA, Kuching. The Meeting was chaired by its Chairman, Mr Peter Ling Kwong Hung and attended by seven (7) Committee Members.

Members of the Committee were briefed on the progress of the research and development (R&D) projects funded by STA i.e. Single Nucleotide Polymorphism (SNP) Discovery Research, Biofertiliser Formulation Research, *Falcataria moluccana* Research and Kelampayan Tissue Culture Research.

The Meeting then discussed the results of the studies/ survey conducted in collaboration with State Forestry Agencies; namely weight to volume conversion factor studies for planted tree species, conventional drying study on *Acacia mangium* and planted logs production volume survey. The Meeting also deliberated on issues/matters related to the forest plantation certification, the revision of the planted forest policy, the planted forest endorsement fees and transportation fees, etc.
