STA Prizes 2017

A simple Presentation Ceremony of STA Prizes to two (2) students from the Faculty of Resource Science and Technology (FRST), Universiti Malaysia Sarawak (UNIMAS) was held on 8 November 2017 at DeTAR Putra, UNIMAS in conjunction with the 21st UNIMAS Convocation Ceremony.

STA Mutual Sdn Bhd, (STAM), a subsidiary company of Sarawak Timber Association (STA), has been awarding STA Prizes namely; (i) Best Graduating Student and (ii) Best Final Year Project Paper to students pursuing a degree at FRST, UNIMAS and the Faculty of Forestry, Universiti Putra Malaysia (UPM) since year 2005. The selection for STA Prizes is based on recommendations made by each of the faculties. Each Best Graduating Student will receive a cheque of RM1,000.00, an acrylic plaque and a certificate, whereas the student with the Best Final Year Project Paper will receive a cheque of RM500.00, an acrylic plaque and a certificate.

STA GST Technical Committee Meeting No 3/2017

The STA GST Technical Committee Meeting No 3/2017 was held on 10 November 2017 at Wisma STA, Kuching. The Meeting was chaired by Mr Philip Choo Kwong Hui, Committee Chairman and attended by three (3) Committee Members.

The Meeting received reports on the feedbacks from the Royal Malaysian Customs Department (RMCD) on three (3) issues submitted by Sarawak Timber Association (STA) for

clarification in August this year. The RMCD has agreed to re-consider one of the issues submitted by STA pertaining to the claiming of GST input tax for the acquisition and repair and maintenance of off-road four-wheel drive motor vehicles used in logging and forest plantation areas and requested STA to make a submission to them for consideration.

The Meeting also identified two (2) issues to be submitted for discussion in the next RMCD's GST Implementation Technical Committee Meeting which is to be held in December 2017.

STA Permanent Council Meeting No 2/2017

STA Secretariat had visited the STA Permanent Council members and their nominated representatives in early October to discuss pertinent forestry and trade issues that are affecting the timber industry of the State. The STA Permanent Council and nominated representatives then met twice on 20 October 2017 and 13 November 2017 at Wisma STA, Kuching to discuss further these pertinent issues and the way forward.

After an extensive deliberation on the issues put forward for discussion, the STA Permanent Council and nominated representatives reached a consensus on the way to move forward. Some of the issues discussed were on forest management certification, forest plantation and training.

STA Tea Talk 2017 – "Stingless Bee and It's Relation to Honey Production"

Timber Sarawak Association (STA) had organised an educational talk entitled "Stingless Bee and It's Relation to Honey Production" on 11 November 2017 at Wisma STA, Kuching. The Talk which is open to the general public held once every is year. Dr Peter Kho, General Manager of STA welcomed all the

participants to the Talk and introduced Mr Mohd Fahimee Jaapar who is a senior research officer from Malaysian Agricultural Research and Development Institute (MARDI), Serdang was the speaker of the Talk.

The Talk covered the species of stingless bees found in Sarawak as well as its breeding and rearing. The Talk also covered the process of honey production and the benefits of the honey to the community, based on the speaker's knowledge and experience in research. The topic attracted a total of sixty five (65) participants from different backgrounds and experiences such as researchers, officers, lecturers and students from various tertiary institutions.

The stingless bee, a prolific pollinator agent is an insect from the family of *Apidae* without a sting. There are more than thirty five (35) species of this bee which can be found in Sarawak. *Heterotrigoma itama* is a species of stingless bee which has been domesticated in the honey industry. According to the Malaysian Agricultural Research and Development Institute (MARDI), stingless bee honey is twice as nutritious as ordinary honey.

For centuries, honey is known to be the enemy of diseases. Stingless bee honey is called the *Mother Medicine* and there are an increasing number of traditional practitioners and researchers suggesting its use. Stingless bee honey contains natural antibiotic elements and functions as an anti-oxidant, anti-bacterial and anti-toxic agent.

Launching Ceremony of Pilot Project

The Pilot Projects for Environmental Compliance Audit were launched in a ceremony jointly organised by the Natural Resources and Environment Board (NREB) Sarawak and Sarawak Timber Association (STA) on 9 November 2017 at Hilton Hotel, Kuching. A *Seminar on Environmental Management in the Forestry Sector* was also held in conjunction with the launching of the Pilot Projects.

The Natural Resources and Environment (Audit) Rules, 2008 was made under Section 18(q) of the Natural Resources and Environment Ordinance, 1993 to enhance environmental stewardship and cultivate self-regulation among the private and corporate sectors in Sarawak. The Pilot Projects were initiated to prepare the forestry sector for the full implementation of the said Rules. Eight (8) STA member companies that operates in natural forests and forest plantations, namely (i) Daiken Sarawak Sdn Bhd, (ii) GP Pusaka Sdn Bhd, (iii) Interglobal Empire Sdn Bhd, (iv) Jaya Tiasa Holdings Berhad, (v) Ravenscourt Sdn Bhd, (vi) Shin Yang Forestry Sdn Bhd, (vii) Subur Tiasa Holdings Berhad, and (viii) Tanjong Manis Holdings Sdn Bhd volunteered to participate in the Pilot Projects.

In his welcoming speech, Dato Henry Lau Lee Kong, Honorary Secretary of STA applauded NREB for taking a phased approach in implementing the NRE (Audit) Rules, 2008 as well as the 8 companies for actively playing their roles by participating in the Pilot Projects voluntarily. He added that the close working relationship between STA and NREB is fundamental to ensure the successful implementation of the said Rules and hoped that other State agencies could emulate such approach and work in tandem with the forestry and timber industry towards achieving a common goal; sustainable environment.

Mr Peter Sawal, Controller of Environmental Quality Sarawak mentioned in his speech that the auspicious occasion marked another milestone for the State of Sarawak in the areas of environmental conservation and protection, particularly in the forestry sector. He shared with participants of the Launching Ceremony that since 1997, the year development activities prescribed under the NRE (Prescribed Activities) Order 1997 are required to conduct an Environmental Impact Assessment (EIA), 1,500 EIA reports had been processed and approved. This was followed by the quarterly submission of Environmental Monitoring Report (EMR) to monitor the compliance to the EIA Terms and Approval Conditions.

He added that weaknesses in this current practice which range from unreported non-compliances to the lack of involvement from the company's management particularly in carrying out immediate corrective action or mitigation measures. These weaknesses have led NREB to introduce Environmental Compliance Audit to replace the existing Environmental Monitoring Report (EMR) to enhance the regulation and monitoring of compliance to the Approval Terms and Conditions of the EIA.

of the Event that the State is expected to implement the NRE (Audit) Rules, 2008 for all development sectors in Sarawak by 2019. He said that the compliance to State's environmental rules and regulations are prerequisite for any companies that wishes to be certified under the Malaysian Criteria and Indicators for Forest Management Certification (Natural Forest).

The launching ceremony was attended by approximately 300 representatives from various forestry agencies, timber companies and environmental consultants. This was followed by the signing of Memorandum of Understanding (MOU) between (i) NREB acting on behalf of the State Government as the regulating authority, (ii) STA as the party that provides grant for costs and fees of External Environmental Compliance Audit and (iii) the 8 participating companies that will participate in the Pilot Projects audit.

The Seminar with the theme "*Towards Environmental Sustainability*" consists of two (2) sessions.

Session 1 entitled "*Environmental Policy*", was chaired by Mr Kenny Poon, Principal Assistant Secretary from the Ministry of Urban Development and Natural Resources (MUDNR) saw two (2) presentations being delivered as follows:

1. Environmental Policy of Sarawak: The Way Forward - by Mr Justine Jok Jau, Deputy Controller, NREB

The speaker informed participants of the Seminar that Sarawak's forest policy is to preserve in perpetuity, sufficient forest lands. Economic incentives, marketbased instruments as well as bilateral agreements are some of the instruments used by the government to implement these policies. He also said that the State will gazette thirty (30) new water catchment areas by the end of this year to protect and manage water resources in the State.

2. Environmental Audit: The Implementation Roadmap - by Ms Elizabeth Nyomek, Senior Environmental Control Officer NRER

Control Officer, NREB The speaker highlighted that the implementation roadmap of the EA began with the establishment of Audit Unit in NREB in 2013, followed by the development of guidelines for NRE (Audit) Rules, 2008. Several rounds of discussions with various stakeholders as well as environmental audit trainings were conducted to improve the said Guidelines and build capacity for the conduct of environmental audit. To prepare the project developers for the full implementation of the said Rules, NREB has initiated Pilot Projects to test

run the Guidelines.

 Overview of Environmental Quality Monitoring

 by Ms Valecca Sibuar, Environmental Control Officer, NREB

 The speaker shared with participants of the Seminar that the monitoring of environmental elements i.e. air, noise, waste and water throughout the lifespan of a project implementation or operation is vital in order to identify any significant changes to the quality of environment. She added that for forestry projects, monitoring of water quality is of utmost importance where the State Government has set a target for all rivers in the State to be maintained to at least, Class IIB of the National Water Quality Standard for Malaysia (NWQSM) which means that the river water is safe for recreational use with body contact.

4. Scheduled Waste Management

- by Ms Rafidah Mohamad Annuar, Department of Environment (DOE) Sarawak

The speaker provided an informative presentation on the types of scheduled wastes (SWs) typically found in the forestry and timber industry, the responsibilities of the waste generator (WGs) as well as ways to store, label and dispose these SWs. She added that with permission from DOE as well as a proper and approved treatment facility, some SWs can be treated and recovered on-site.

5. Environmental Issues and Mitigating Measures in Forestry Projects

- by Mr Manaffery Bin Madhan and Mr Mitchell Bay Anak Samuel, Environmental Control Officers, NREB

The speakers highlighted to participants of the Seminar some of the environmental issues in forestry projects that may adversely impact the environment. They also underscored the importance of incorporating relevant mitigation measures suggested in the EIA Approval Terms and Conditions to avoid or reduce these impacts to more acceptable levels.

6. Occupational Safety and Health in the Timber Industry

- by Mr Haizul Afta Bin Masri, Department of Occupational Safety and Health (DOSH) Sarawak

The speaker emphasised the importance of occupational safety and health (OSH) and having a good OSH management system in a company that is involved in high risk activities such as logging. He also highlighted common non-compliances found in the logging industry and the Department's effort in carrying out safety campaigns as well as ground inspections to inculcate OSH culture in workplace and evaluate compliance to OSH requirements.

The presentations proved to be beneficial as the participants, mostly who were from the companies participating in the pilot projects were able to obtain clarifications from the different departments, i.e. DOE, DOSH and NREB and raised other issues relevant to ensure compliance to the EIA's Terms and Conditions.

Projek Perintis untuk Audit Pematuhan Alam Sekitar telah dilancarkan dalam satu Majlis yang dianjurkan secara bersama oleh Lembaga Sumber Asli dan Alam Sekitar (NREB) Sarawak dan Persatuan Kayu Kayan Sarawak (STA) pada 9 November 2017 di Hotel Hilton, Kuching. Satu *Seminar Pengurusan Alam Sekitar dalam Sektor Perhutanan* turut diadakan bersempena Majlis Pelancaran Projek Perintis.

YAB Datuk Patinggi (Dr) Abang Haji Abdul Rahman Zohari bin Tun Datuk Abang Haji Openg, Ketua Menteri Sarawak, dalam ucapan perasmiannya yang dibacakan oleh Datu Len Talif Salleh, Penolong Menteri Perancangan Bandar, Pentadbiran Tanah dan Alam Sekitar berkongsi dengan peserta mengenai audit pematuhan alam sekitar dan berkata Kerajaan mensasarkan menjelang 2019, untuk melaksanakan Peraturan NRE (Audit), 2008 di semua sektor pembangunan di Sarawak. Dialogue on the Draft Natural Resources and Environment (Prescribed Activities) Order, 2017

A Dialogue on the Draft Natural Resources and Environment (Prescribed Activities) Order. 2017 INRE Order, 2017] (PA) was conducted by the Natural Resources and Environment Board (NREB) Sarawak on 29 November 2017 at their Headquarters Kuching. in The Dialogue was

attended by sixteen (16) participants representing various stakeholders such as the Sarawak Oil Palm Plantation Owners Association (SOPPOA), Sarawak Dayak Oil Palm Plantation Association (DOPPA), Sarawak Chamber of Commerce and Industry (SCCI), the Association of Environmental Consultants Sarawak (AECS) and Sarawak Timber Association (STA).

The Dialogue was chaired by Mr Justine Jok Jau Emang, Deputy Controller of Environmental Quality Sarawak, NREB. In his welcoming remarks, he informed participants of the Dialogue that NREB is in the process of drafting the NRE (PA) Order, 2017 to replace the current NRE (PA) Order, 1994. The new draft NRE (PA) Order, 2017 is targeted to regulate small scale activities that are not listed as the Prescribed Activities in the existing NRE (PA) Order, NRE (PA) Order, 2017. She informed the participants of the Dialogue that the draft NRE (PA) Order, 2017 is aimed at:-

- Enhancing the regulation of Prescribed Activities that are environmentally sensitive through Social and Environmental Impact Assessment (SEIA);
- 2. Regulating additional **Prescribed Activities** through Environmental Impact Assessment (EIA); and
- 3. Regulating small scale Prescribed Activities through **Environmental Permit (EP)**.

Guidelines or mechanisms will be developed to facilitate its implementation, particularly on the issuance of Environmental Permit once the draft NRE (PA) Order, 2017 is finalised.

During the Dialogue, Ms Tang Hung Huong, Head of Planning and Development Section of NREB Sarawak presented the draft

STA Forest Plantation Committe

Forest The STA **Plantation Committee** organised a Study Tour to Guangdong and Hainan of Southern China from 11 to 18 November 2017. The main purpose of the Study Tour was to learn: the successful (i) forest plantation establishment and management practices in China,



According to Mr Zhou Yadong, Chief Forest Engineer of Hainan Forestry Department, the land uses in Hainan is clearly demarcated by the Hainan Provincial Government and any changes in the land use require the approval from the Hainan Provincial Government. This

including Research & Development (R&D) on *Eucalyptus*; (ii) the processing and utilisation of *Eucalyptus* plantation logs; and (iii) the industry compliance with government regulations. The Committee hoped that the practices and policies in China, if appropriate, can be considered for adoption in Sarawak forest plantation industry and thus assist in the sustainable development of this industry in the State.

The delegation, led by STA Forest Plantation Committee Chairman, Mr Peter Ling Kwong Hung, comprised twelve (12) members, including Mr Wong Siong Kuan, Senior Assistant Director, Forest Plantation & Reforestation Division of Forest Department Sarawak and Dr Daniel Tan Lee Tung, Lecturer of Swinburne University of Technology Sarawak Campus.

The study tour covered areas in southern part of China including Haikou, Zhanjiang and Guangzhou where Eucalyptus plantations had and have been successfully established. A number of meetings and field visits were arranged for the group with the assistance from Consulate-General of the People's Republic of China in Kuching, Guangdong Forestry Department, Foreign Affairs Office of People's Government of Guangdong Province and Foreign Affairs Office of Hainan Province as well as other relevant agencies, private companies and research institutes.

In 2016, the Chinese Government announced its zerodeforestation policy to totally ban logging from natural forests for protection and conservation purposes. The planted forests have thus become one of the important sources of raw material supply in the country. Due to limited area available in China for farming, the tree plantations are distributed in mosaic-like patterns, clustered between other land uses such as agricultural cropland and fruit orchards.

The Chinese Government provides strong support and invests heavily in the infrastructures to help the development of the forest plantation industry in the country. The provision of incentives or subsidies (cash or in the form of free seedlings) to the farmers and companies had accelerated the rapid establishment of forest plantations. has ensured the uninterrupted tree planting programme in the province. He added that no royalty and cess is collected from the plantation logs. However, sales tax is collected from the timber products and this income is channelled back to the industry through the provision of incentives for forest plantation development.

Professor Dr Chen Shaoxiong, Deputy Director of China Eucalypt Research Centre (CERC) informed the group that China has established 69 million hectares of forest plantation of various tree species. The total areas planted with Eucalyptus species is 4.4million hectares or 6.38% and the volume of Eucalyptus harvested is 25million m³/ year. He added that the *Eucalyptus* has a ready market in China and the *Eucalyptus* industrial supply chain covered seedling, fertiliser, processed wood products (wood chip, pulp & paper, veneer, plywood, medium/high density fibre board, furniture etc), non-timber forest products (essential oil, honey, polyphenols etc), and biomass.

The importance of sustained funding and focused R&D were reiterated in all areas that have been visited. The dedicated R&D agencies, i.e. China Eucalypt Research Centre (CERC) and Research Institute of Tropical Forestry (RITF) have been assigned to conduct research, provide technical support and advice as well as provide improved planting materials for the planters. This encouragement has been further enhanced through the establishment of committee/alliance/group comprising local and international scientists, planters and relevant stakeholders dedicated to resolve the issues faced by the *Eucalyptus* planters.

Through focused research by RITF, the yield of *Eucalyptus* hybrid has been increased from 6m³/ha/year in 1970 to 22m³/ha/year in 2010. The current highest average mean annual increment recorded by Asia Pulp & Paper (APP) in Hainan is about 30m³/ha/year. However, this is still below the average yield of 30-40 m³/ha/year in Brazil. Another achievement through focused research is from CERC whereby they developed a *Eucalyptus* clone that is resistance to pests and diseases as well as to typhoon.

e's Study Tour to Southern China

In China, especially in Hainan and Guangzhou, the lack of manpower and high costs of production, including high land rent and labour costs, have affected the profitability of the forest plantation industry and as a result, many planters have stopped tree planting. In view of this, Professor Dr Xu Daping, Director of RITF has advocated the planting of long-rotation high-value native species as the *Eucalyptus* produced cannot compete with Brazil (higher MAI) and Indonesia (cheaper labour and land rent). However this practice has not been picked up by the industry as the return on investment is unknown due to market restrictions and timing uncertainties.

Signing of Memoranda of Understanding betwee Sarawak Timber Industry Develo Sarawak Timber Association and the Launch Wood Products Processing Programme and C

In line with the aspiration of the Sarawak State Government to expand the downstream processing of the timber industry in the State, the University College of Technology Sarawak (UCTS) will be offering a new Bachelor of Technology (Hons) in Wood Products Processing Programme for the upcoming 2018/2019 student intake. This 4-year (8 semesters) Programme was developed in collaboration with Sarawak Timber Industry Development Corporation (STIDC).

UCTS, with the cooperation of STIDC and Sarawak Timber Association (STA) will also establish a Center of Excellence for Wood Engineered Products (CeWEP) to carry out intensive research on wood engineered products. CeWEP acts as a catalyst that will bring about an increase in the participation and engagement of the local timber industry as well as the local communities in the manufacturing of value-added timber products in Sarawak.

This new Programme and CeWEP were launched in a ceremony organised by UCTS on 20 November 2017 at UCTS, Sibu. In conjunction with this Launching Ceremony, two 5-year Memorandum of Understandings (MOU) between (i) UCTS and STIDC as well as (ii) UCTS and STA, were also signed and exchanged during the Ceremony.

The main objectives of the MOU are:-

 To encourage cooperation between UCTS and STA in the fields of Timber and Timber Products; and any other areas related to education, training, research, innovation and social that will benefit the parties, industry and society at large;

- To encourage cooperation leading to formal agreement between UCTS and STA towards the development and establishment of a Center of Excellence for Wood Engineered Products at UCTS;
- To enter into a formal agreement which will enable students from UCTS to obtain sponsorship from STA upon such terms mutually agreeable by both UCTS and STA;
- To involve STA and its members as industrial advisors in the related fields for UCTS; and
- To enter into a formal agreement that will enable students from UCTS to undergo their industrial training in STA member companies upon such terms mutually agreeable by both UCTS and STA.

In his welcoming speech, Professor Dato' Dr Abdul Hakim bin Juri, Vice Chancellor, UCTS informed participants of the Event that the Bachelor of Technology (Hons) in Wood Products Processing puts UCTS as the only university in Malaysia offering a programme that focuses on wood products processing. He believed the graduates with this degree will address the requirements by the industry of skilled manpower who knows the anatomy, properties, processing techniques, product designs, production technologies and etc of the species from both natural and planted forests in Sarawak. The CeWEP will focuses on research and development activities as well as innovation works on engineered products from planted tropical timber species.

DatukAmarAwang TengahAli Hasan, Deputy Chief Minister, Minister of Industrial and Entrepreneur Development as well as Second Minister of Urban Development and Natural Resources in his speech, stressed that in line with the State Master Plan to encourage more downstream processing of value-added products, the State has reduced the export of logs to 20% and the utilisation of more plantation material grown in Sarawak.

He further mentioned that the State is also focusing Research & Development (R&D) on fast growing species for the forest plantation programme in the State. The timber industry is urged to come forward and collaborate with the Government and educational institutions to ensure the industry is able to remain as one of the major industries in Sarawak.

Dr Wan Tarmeze highlighted the design capabilities, consistency of products, environmental issues and availability of engineered lumber.

HRDF Dialogue with Re

The Pembangunan Sumber Manusia Berhad (PSMB) held a Human Resource Development Fund (HRDF) Dialogue with registered employers on 2 November 2017 at Hilton Hotel, Kuching. Approximately 110 participants attended this Dialogue.

The objective of the Dialogue was to discuss feedback, inputs and recommendations by members for improvements that correspond with the Government's national agenda which is to achieve 35% skilled Malaysian workforce by the year 2020.

In his welcoming remarks Dato' CM Vignaesvaran Jeyandran, Chief Executive (CE) of HRDF, said that this Dialogue is conducted every year as a channel for communication between HRDF and employers. HRDF wants suggestions or critiques directly from employers on their services and training schemes or any concerns which employers may have for HRDF to further improve on their services. He briefed participants of the Dialogue on the roles and functions of HRDF as an agency under the Ministry of Human Resources (MoHR) as well as on existing training schemes/training programmes offered by HRDF. He highlighted that under the PSMB Act 2001, HRDF has the power to send people to jail for up to 2 years for not paying the levy or abuse the usage of the levy. However, this has yet to be enforced. He said that HRDF will backdate all the levies due for those employers who are eligible to register but have not done so. Currently, there are 20,654 employers registered with HRDF but there are 900,000 establishments in Malaysia. HRDF now covers all sectors in Malaysia such as services, manufacturing and mining except construction and finance. According to him, almost 80% of the HRDF registered employers are Small Medium Enterprises (SMEs) and one of the reasons for the implementation of the 30% pool fund was to uplift the knowledge and skills of SMEs. He said in order for the local economy to grow, a strong SME is required.

He also informed participants of the changes implemented by HRDF. The changes are that HRDF:

 Had conducted Corporate Social Responsibility (CSR) programmes for the industries using their own finances raised and not from the HRDF levy. CSR programmes include as water purification projects in Sabah and Sarawak, projects on reading and writing for students living in the outskirts who have zero per cent of passing Primary School Evaluation Test (UPSR), etc.

- Is actively taking care of their staff welfare by revising their policy on matters such as providing yearly medical check-up for staff above forty (40) years of age, discouraging low back chair and etc. to be an exemplary organisation where other organisations can follow.
- Emphasises on the importance of transparency and openness where companies can now choose their own training providers. Employers can obtain a list of training providers, programmes and course fees in the HRDF website at www.hrdf.com.my. HRDF also plans to revamp its website and improve its services to members.
- Has set up the Sectorial Training Committee (STC) and Regional Training Committee, chaired by the industry people to determine the kinds of training required by the industries. HRDF has requested employers association to inform HRDF on the types of training needed and they will give funds to them to appoint their own training providers. In future, HRDF will request the STC to conduct a training need analysis of the industry.

Some of the points of concern raised by the participants of the Dialogue are the (a) limited training programmes in Sarawak, (b) limited qualified trainers, (c) transfer of levy from a company that is closing down to another company, and (d) insufficient grant to train employees.

Opening Ceremony of the Global Timber Conference 2017

The second Global Timber Conference 2017 (GTC) was held from 6 to 8 November 2017 at Pullman Hotel, Kuching. The GTC themed "*Innovation and Market Driven Strategies: Keystones to Sustainable Growth*" organised by Confexhub and supported by the State Government of Sarawak, Sarawak Timber Industry Development Corporation and Sarawak Tourism Board drew delegates from over ten (10) countries.

In his opening speech, Deputy Chief Minister, Datuk Amar Awang Tengah Ali Hasan representing the Chief Minister of Sarawak mentioned that the timber industry is important to Sarawak, contributing RM5.9 billion worth of exports in timber and timber products last year. This accounted for approximately 27% of Malaysia's total timber exports. He also mentioned that the State Government will make it mandatory for all timber concessions in Sarawak to obtain forest management certification in order to enhance sustainable forest management in the State. The State Government has also strengthened the Sarawak Timber Legality Verification System (STLVS) by coming out with a formal standard to cater for independent third- party verification to ensure timber & timber products from Sarawak are produced in compliance with the laws and regulations of Sarawak.

A total of 529 participants, mostly entrepreneurs from Small and Medium Enterprises (SMEs) attended this Forum. The main objective of this Forum was to share the latest information related to the current development and initiatives that will be carried out by relevant government agencies.

However, users especially those from Small and Medium Enterprises (SMEs) are advised to attend courses offered by SME Corporation Malaysia on how to start business online and digital marketing. The Federal Government has allocated funds for the development of e-Commerce.

5. Cloud Affairs: Cybersecurity, Fintech Adoption and Blockchain Technology

Participants of the Forum were introduced to Blockchain technology, which is a distribution ledger technology. Commercial bank such as Maybank Group accepted the trading of bit coin using the Blockchain technology, which is network secured and not hackable. Those who have doubts on web fraud may refer to www.mycert.org.my for authentication.

Currently, eCommerce contributed 6.74% to the Gross Domestic Product (GDP) of Malaysia while in other countries, it is at 20%. Before the closing ceremony, Mr William Chin Fuh Taur, a young entrepreneur presented a paper on "Global Trend on eCommerce and Digital Economy".

During the closing ceremony, Dato Sri Wong Soon Koh, Minister of International trade and eCommerce Sarawak cum Second Minister of Finance Sarawak informed participants of the Forum that MiTEC is geared up to play a role in transforming Sarawak into digital economy and to join the network of Information and Communications Technology (ICT). However, all stakeholders must adapt to the changes and support this bold move. This year alone, seven (7) workshops/seminars forums on eCommerce were organised in Kuching, Sibu and Miri.

Meanwhile, the Right Honourable Datuk Patinggi (Dr) Abang Haji Abdul Rahman Zohari bin Tun Datuk Abang Haji Openg, Chief Minister of Sarawak mentioned that to become a developed state by 2020, the State must rely on digital technology to derive high income and to optimise its resources. He also explained in detail three (3) areas of eCommerce namely; (i) the history; (ii) pre-requisite and environment that enable eCommerce to be managed and run; and (iii) areas that should be looked into where everyone plays a part in this transformation stage.

The Chief Minister also announced that a digital village which costs RM30 billion will be established in Samajaya while another few innovative hubs will be set up in Sarikei, Betong, Bintulu, Limbang and Lawas. In Kuching, one of the innovative hubs is I-Com Square. In few years to come, Sarawak will set up its own Digital Free Trade Zone (DFTZ) in Kuching for the local entrepreneurs.

Roadshows on Forests (Nursery) Rules,

Forest Department Sarawak (FDS) organised two (2) Roadshows on Forests (Nursery) Rules, 2017, one each in Sibu and Miri. The Roadshow Sibu was conducted on 21 in November 2017 at FDS's Regional Office, Wisma Forest Sanyan whereas the Roadshow in Miri was conducted on 23 November 2017 in the Meeting Room of Miri Regional Forest Office at Komplexs Islam Sarawak, Miri. Approximately forty (40) participants from the Ministry of Urban Development and Natural Resources (MUDNR), FDS's Regional Forest Officers, Sarawak Forestry Corporation (SFC), Department of Agriculture (DoA) Sarawak, Sarawak Timber Industry and Development Corporation (STIDC), Harwood Timber Sdn Bhd (HTSB), Licence for Planted Forests (LPF) Holders and STA Secretariat attended each Roadshow.

Mr Wong Siong Kuan, Senior Assistant of Director of Forests, Forest Plantation & Reforestation Division. FDS, in his opening remarks told participants that the Forests (Nursery) Rules, 2017 was made under Section 113(1)(w) of the Forests Ordinance, 2015. It applies to all nurseries established for forest plantation purposes, with the exception of transit nurseries. The Rules had been approved by the State Cabinet on 22 June 2017 and came into force on 1 August 2017. FDS is expected to implement the Rules on 1 January 2018, when the procedures for the importation of seeds and planting material will be enforced. This process will involve

a few agencies i.e. FDS, SFC, DoA and Royal Malaysian Customs Department Sarawak (RMCD). He also stressed that the Rules will ensure (i) imported planting materials, including those collected elsewhere in Sarawak are of high quality; (ii) pest and disease-free planting materials; and (iii) optimum yield and productivity of the tree crops.

Mr Kos Anak Amud, Senior Executive Forester, Forest Plantation & Reforestation Division, FDS, briefed the participants of the Roadshow on the Forests (Nursery) Rules, 2017 and highlighted the main features of the Rules as follows:

- i. All forestry nursery owners are required to register with FDS.
- ii. It is the responsibility of the nursery owners to liaise with the relevant authorities for the importation of seeds and/or other planting materials.
- iii. All the imported planting materials must be supported by relevant documents certifying they are pest and disease free.
- iv. A registration fee of RM500 is to be charged to the nursery owner before a registration certificate is issued. The certificate is to be renewed annually with a fee of RM200.
- v. Renewal of the certificate can only be considered if there is no contravention to the Forests (Nursery) Rules, 2017.
- vi. The nursery owner is liable to be fined or compounded according to the rates as specified in the

Rules if he is found to have contravened any clause of the Rules.

He also elaborated on the roles of the implementing agencies in importation planting of materials as well as the inspection and

monitoring of nursery. He then invited the representatives from DoASarawak and SFC to brief participants on their respective roles in implementing the Forests (Nursery) Rules, 2017.

Paddy Anak Jiob, Assistant Mr Agriculture Officer, Plant Biosecurity and Quarantine Division, DoA Sarawak, highlighted to the participants of the Roadshow the procedures for importation of seeds and/or planting materials into Sarawak. He stressed that all consignments must be treated prior to the importation, to prevent the entry and spread of foreign plant pests and diseases into the State. Each consignment must also have a Phytosanitary Certificate issued by the country of origin of the planting material. He added that an import permit is also needed for every consignment. The application fee for an import permit is RM15. The permit is valid for three (3) months and it can only be extended one time. He also mentioned that no soil material is allowed with planting materials during the importation of, i.e. for seedlings. He suggested the only alternative way is to use the sterilised peat moss, if applicable.

FDS has appointed SFC to do the seed viability and health screening tests for all imported seeds.

The Meeting also discussed the possibility of using the DoA's application form for import permit as a basis for applying for approval from the Director of Forests to import planting materials, to avoid having to fill in the same information twice.

The participants of the Roadshow raised their concerns on the seed testing to be conducted by SFC, on a consignment basis. Amongst the questions raised were:

- 1. Types of screening tests to be carried out on the seeds
- 2. Costs of seed screening testing
- 3. Time frame needed to complete the seed tests
- 4. 4. Storage of the seeds during seed screening testing

Mr Wong hoped that SFC could provide clarification on the concerns raised by the participants of the Roadshow by 10 December 2017. The Meeting also revised information required in the "Application for Permit to Establish a Nursery for Licence for Planted Forests" and "Application for Approval of Planting Material Procurement" forms, the final draft copy of which will be circulated to those attending for further comments by the following week.

Her Excellency Maria Castillo Fernandez, Ambassador and Head of Delegation of the European Union (EU) to Malaysia and her delegation visited Sarawak Timber Association (STA) on 13 November 2017 at Wisma STA, Kuching. The delegation comprised Mr Nicholas Dross, Head of Economic and Trade Relations as well as Ms Shamala Joachim, Trade Officer. They were received by Dato Henry Lau, STA Honorary Secretary, Dato' Tiong Ing, STA Council member, STA members and staff of the STA Secretariat.

Ms Annie Ting, Senior Manager of STA briefed the delegation on the background of STA, statistics on Sarawak's timber production and trade, timber sustainability and Sarawak's timber legality assurance system, that is, the Sarawak Timber Legality Verification System (STLVS). She also shared with them the concerns faced by timber industry in Sarawak on the Forest Law Enforcement, Governance and Trade (FLEGT) Voluntary Partnership Agreement (VPA).

Fifty-third Session of the Intern

fifty-third The session of the International Tropical Timber Council (53rd ITTC), and the Associated Sessions of the four (4) Committees; namely Finance and Administration (CFA); Economics, Statistics and Markets (CEM); Forest Industry (CFI); and Reforestation and Forest Management (CRF) were held from 27 November 2017 to 2 December 2017 in Lima. Peru.

The 53rd ITTC was honoured to have the presence of the President of the Republic of Peru, H.E. Pedro Pablo Kuczynski Godard at the opening ceremony on 27 November 2017. In his opening address, he highlighted that it is of fundamental importance to

conserve and sustainably manage the forest resources of Peru for the future of the country. He also commented that the position of Peru is clear, which is to protect and conserve its forests for future generations. The other speakers at the opening ceremony included Mr Pablo Benjamin Quijandría Salmón, Vice Minister, Ministry of Agriculture and Irrigation, Peru, representing Minister José Manuel Hernández Calderón; Mr Tabi Agyarko (Ghana), the Chairperson of 53rd ITTC; and Mr Gerhard Dieterle, the Executive Director of the International Tropical Timber Organization (ITTO).

After the opening ceremony, the Council was addressed by Mr Benito Owusu-Bio, the Honorary Deputy Minister of Lands and Natural Resources. Ghana: Mr John Leigh, the Executive Director of Peru's National Forestry and Wildlife Service (SERFOR); Dr Eva Müller, the Director of the United Nations Food and Agriculture Organization (FAO) and the Chair of the Collaborative Partnership on Forests (CPF); Mr Manoel Sobral Filho, the Director of the United Nations Forum on Forests (UNFF) and video message by Mr John Scanion, the Secretary General of the Convention on the International Trade in Endangered Species (CITES).

During the week of the 53rd ITTC, the caucus sessions for Producers and Consumers, and the Council addressed amongst other issues, organisational matters, 52rd ITTC's

decisions on impairment of funds as well as the future of the ITTO and issue of rotation between producer and consumer country in the selection of the Executive Director. The Council also discussed the Biennial Work

Programme for the years 2018 – 2019, the draft Guidelines for Achieving Gender Equality and Empowering Women (GEEW), and the ITTO-CITES programme to improve country capacity to implement CITES listings of tropical timber species. It was noted that European Union (EU) provides EUR 7 million to the CITES Secretariat to implement the CITES Tree Species Programme and there was a call for all ITTO members to consider making financial contributions to ensure the continuation of the partnership between both CITES and ITTO. CITES has taken over ITTO as the implementing agency of the EU for the ITTO-CITES programme. The Council received reports on ITTO collaboration works the other organisations; namely the Convention on Biological Diversity (CBD) and the international Union of Forest Research Organization (IUFRO).

The CRF discussed new projects and pre-projects, reviewed completed projects as well as policy work on the dissemination and application of the ITTO Voluntary Guidelines for the Sustainable Management of Natural Tropical Forests; cooperation and collaboration between ITTO African member and countries on criteria and indicators; fire prevention and management in tropical timber-producing forests; the conservation, restoration and sustainable management of mangrove implementation ecosystems; of

guidelines for the management of secondary tropical forests; and developments in the Union Nations Framework Convention on Climate Change (UNFCCC) regarding forests as well as their potential implications

for tropical forests and the world tropical timber economy.

The CFA discussed matters in relation to the draft Biennial Administrative Budget for 2018 and 2019; the status of the Administrative Account, the Special Account, and the Bali Partnership Fund; and the Auditor's Report.

The joint meeting of the CEM and CFI discussed completed projects, as well as the status of policy work on market access; forest and timber certification; and strengthening the participation of the private sector in ITTO work. This joint committee also received a report from FLEGT VPA Independent Market Monitoring (IMM), an initiative of the EU and ITTO designed to support the implementation of bilateral voluntary partnership agreements (VPAs) between the EU and timber-supplying countries. VPAs are a key element of the EU's Forest Law Enforcement. Governance and Trade (FLEGT) Action Plan, which defines the EU's policy for promoting legal logging and the trade of legally licensed timber. It was noted that Indonesia became the first country to obtain a FLEGT licence under its VPA with the EU in November 2016. After the first year in operation of issuing FLEGT licence, the IMM reported the following findings as highlighted in the daily report of 53rd ITTC:

- Indonesia experiences minimal immediate effect of the licensing system to either boost or impair timber trade.
- Indonesian trade with the EU has changed very little since the first licences were issued in November 2016.
- Indonesia's share of the EU market has remained stable.

The Annual Market Discussion for 2017 under the theme "Sharing Experiences on Promoting Investment in Tropical Timber Industries and

The Council took note of China's initiative to look into the legality of the supply chain for timber and to organise a workshop involving the participation of private sector, with close working relationship with the ITTO Trade Advisory Group (TAG) which will be held in June 2018 in China. The Council was also informed of the international symposium on *"the Promotion of Deforestation-Free Global Supply Chain to Contribute to Halting Deforestation – Challenges of Private Sector for Forest Conservation as the Key to Achieving the SDGs and Aichi Biodiversity Targets" which will be co-organised by the Forestry Agency (Ministry of Agriculture, Forestry and Fisheries) of Japan, FAO and ITTO in January 2018 in Tokyo, Japan.*

The Council elected Mr Zhang Zhong Tian (China) as the Chairperson and Mr John Leigh (Peru) as the Vice-Chairperson of 54^{th} ITTC to be held in November 2018 in Yokohama, Japan and also agreed to hold 55^{th} ITTC in Lomé, Togo.

Preparatory Meetings on Environmental Compliance Audit

Two Preparatory Meetings on the implementation of Environmental Compliance Audit (ECA) were jointly organised by the Natural Resources and Environmental Board (NREB) and Sarawak Timber Association (STA) to facilitate the eight (8) participating STA member companies; namely (1) Daiken Sarawak Sdn Bhd, (2) GP Pusaka Sdn Bhd, (3) Interglobal Empire Sdn Bhd, (4) Jaya Tiasa Holdings Berhad, (5) Ravenscourt Sdn Bhd, (6) Shin Yang Forestry Sdn Bhd, (7) Subur Tiasa Holdings Berhad and (8) Tanjong Manis Holdings Berhad on 22 November 2017 in Miri and 24 November 2017 in Sibu. These companies had signed the Memorandum of Understanding (MOU) with NREB and STA for implementing ECA on 9 November 2017 in the Launching Ceremony of Pilot Projects for Environmental Compliance Audit at Hilton Hotel, Kuching. The two Meetings were also attended by officers from Sarawak Forestry Corporation and Forest Department Sarawak.

In both Meetings, officers from NREB spoke on the pilot projects, MOU and provided an insight to the roles and responsibilities of each party of the MOU. They also briefed the representatives of the companies on the process, procedures and requirements of the ECA in accordance with the NRE (Audit) Rules 2008 and its Guidelines, provided information on the implementation roadmap of the pilot projects for ECA and discussed on the schedule for the implementation.

It was also agreed by the forestry agencies to streamline the requirements stipulated in the mitigation measures and also the documents that are needed during the audit process.
