Sarawak played host the 15th Malaysian to Forestry Conference from 20 to 24 October 2008. Themed 'Addressing Global Demands and Expectations in Forestry', the triennial Conference was attended by 360 participants from Peninsular Malaysia, Sabah and Sarawak. The Conference, carrying six sub themes namely global changes and forestry, sustainable forest management, deforestation

and forest degradation, environmental services. forest plantation and forest product industry and trade, provided a platform for officers from the three regions to exchange views, information and experiences in matters pertaining tо administration, management, planning and development of forestry in the country.

YAB Pehin Sri Haji Abdul Taib Mahmud, Chief Minister of Sarawak in his officiating address, read by YΒ Tuan Haii Mohd Naroden bin Maiais. Assistant Minister of Planning and Resource Management Sarawak, said Sarawak has identified 65 Forest Management Units (FMUs) with total of 4.435 million area hectares. To date, two FMUs had been certified by the Malaysian Timber Certification Scheme

(MTCS), namely Sela'an - Linau and Anap Muput. Other FMUs were in various stages of preparation for certification.

"The effect οf globalisation and its impact on forestry posed a n increasing demand on forest resources. We need to replenish and use the resources as a source for development. Therefore, there is a need to harvest the forest through the application o f environmentally friendly techniques such as Reduced Impact Logging (RIL) using helicopter and comply with the provision o f the Forest Management Plan" he said.

He added that sustainable development is all about borrowing resources from the future generation and finding ways to give back the resources to them in good or even better conditions.

Meanwhile, Datu Haji Len Talif Salleh, Deputy Permanent Secretary, Ministry of Planning and Resource Management, Director of Forests and Managing Director/Chief Executive Officer Sarawak Forestrv Corporation and General Manager of STIDC in his welcoming speech called participants on to articulate, deliberate and to come up with clear solutions, not only those current pertaining to issues but also future issues such as global warming, water

resources, sustainability, climate change, biodiversity conservation, certification, illegal logging, carbon credits, chain of custody, carbon sequestration and land rights.

He also highlighted that the forestry sector had grown to be so dynamic that it requires the expertise of various professions. Structural changes are taking place within the Forest Department Sarawak and the complementary roles of other agencies such as Sarawak Forestry Corporation and STIDC.

The Conference received a total of 35 working papers and 23 posters.

REVISED FIRST SCHEDULE OF THE FORESTS ORDINANCE [SECTION 52(2)] ON RATES OF ROYALTY FOR PRODUCE TAKEN UNDER LICENCE

STA had received DF Circular No.5/2008 from Forest Department Sarawak with regards to the revision in the First Schedule of the Forests Ordinance [Section 52(2)] on Rates of Royalty for Produce taken under Licence. DF Circular No. 5/2008 will take effect on 1 January 2009.

The original copy of the Forest Timber License needs to be brought to the respective Regional Forest Office (Kuching/Sibu/Bintulu/Miri) either on 25 or 26 November 2008 for cancellation of the old First Schedule and replacement with the revised First Schedule.

PLASTIC TAGS FOR LOGS AND POLE SIZE TIMBER

STA had received DF Circular No.6/2008 from Forest Department Sarawak with regards to the plastic tags for logs and pole size timber. The DF Circular No 6/2008 shall replace DF Circular 5/95 and 4/97 whereby the Forest Department Sarawak will implement a revised Coupe and Block tag for logs, which incorporate Alpha-numeric Log Production Identity (LPI) number. This revision is aimed at improving the monitoring, tracking and control of both Log Production and Royalty Assessment. DF Circular No. 6/2008 will take effect on 1 January 2009. RESTRICTION ORDER ON THE EXPORT OF WOOD RESIDUES

STA had received a Registration Circular No.3/2008 from the Sarawak Timber Industry Development Corporation (STIDC) dated 1 August 2008 which reads:


"Please be informed that any exportation of wood residues requires prior approval from STIDC. This restriction order shall include wood of any species, shapes, sizes, wood slabs, off-cut, log ends, centre core, rejected veneers, plywood trimmings, sawdust, wood particles, wood wool and woodchips.

This restriction is also added into the STIDC's Conditions & Restrictions under Para 4.6 and is enforced with immediate effect."

Did you also know that...

Bilateral trade between India and Malaysia grew 29.41% year-on-year to US\$ 8.53bn (EUR 5.92bn) in 2007. According to Ashok K Kantha, the Indian High Commissioner to Malaysia, on 24 September 2008, the figure is predicted to each over US\$ 10bn by end-2008. LABORATORY ACCREDITATION SCHEME -REGISTRATION OF HEAT TREATMENT FACILITY

The Department of Agriculture Sarawak (HQ) informed STA that The Plant Protection and Quarantine Division, Department of Agriculture, Kuala Lumpur had agreed to give exemption to Syarikat Sime-Sirim Technology Sdn Bhd and Wehaya Sdn Bhd. which means that the Department of Agriculture (DoA), Sarawak would recognize the calibration service provided by them for registering heat treatment facility.

However, DoA Sarawak (HQ) has advised these two companies to register with the Malaysian Laboratory Accreditation Scheme (Skim Akreditasi Makmal Malaysia) as when the said Scheme is fully implemented, DoA Sarawak (HQ) will only recognise calibration done by companies registered with SAMM.
