# STA Council Meeting No.6/2022

The STA Council held its Meeting No. 6/2022 on 15 December 2022 via video conferencing. The meeting was presided over by Dato Henry Lau Lee Kong, STA Chairman and attended by Vice Chairman Dato' Sri Patrick Wong Haw Yeong, Honorary Secretary Mr Wong Ting Chung, Honorary Treasurer Mr Philip Choo and twenty six members of the Council.

The Council in this meeting resolved to close the voting process for the amendment to Clause 8(1)(a)(i) of STA Constitution as required by the Registry of Societies which requires Unanimous Assenting Vote of all categories at a General Meeting, upon obtaining the requisite consent from two-thirds ( $\frac{2}{3}$ ) of all members in the Furniture & Other Woodworking, Log Marketing, Panel Products, Sawmilling and Timber Products Marketing categories respectively to approve and ratify the amendment.

Voting for the amendment were kept open and Member's Postal Ballots were made available to the members in these five (5) categories who were absent at the Annual General Meeting (AGM) held on 30 September 2022 (AGM 2022), to allow collection of their votes to continue after AGM 2022 in accordance with the resolution made by STA members at the AGM 2022. All other amendments had achieved the requisite approvals in accordance with the STA Constitution at the AGM 2022.

The Council received reports from the various Category Committees and Working Committees and discussed activities and direction to be undertaken by STA in the coming years. Besides that, the Council also approved the budget for STA to facilitate and carry out the activities and work for year 2023.

The Council had approved financial contributions totaling RM200,000.00 to the following two (2) members for achieving forest management certification under the Malaysian Timber Certification Scheme in their respective Forest Management Units:

The Council also approved one (1) application from Polima Forest Bintulu Sdn Bhd under the Forest Plantation Category for the conversion of Associate Member to Member.

The Council resolved to call the next Annual General Meeting of the Association on 29 March 2023 in accordance with Clause 7(1)(a) of the STA Constitution.

## Visit to RT-Paulownia Plantation and Tissue Culture Laboratory

Forest Department Sarawak (FDS) and STA visited the R-T Paulownia Plantation and Tissue Culture Laboratory under the TSG Green Sdn Bhd on 9 December 2022.

The group, led by Mr Jack Ak Liam, Deputy Director of Forest was received by Dato Chris Chung Soon Nam, Founder and Group Chief Executive Officer of TSG Green Sdn Bhd.

The group visited the TSG Green Nursery and Research and Development (R&D) Centre at Kota Samarahan as well as the TSG Green R-T Paulownia tissue culture laboratory at Titanium Tower, Kuching. During the visit, Dato Chung briefed the group members on the operation of the nursery and tissue culture laboratory as well as the R-T Paulownia tree planting programme. He also shared findings obtained from various R&D trials conducted on R-T Paulownia and the market potential of this species.

## **Engagement Session with Training Coordinators**

STA Training Sdn Bhd (STAT), the appointed Training Provider under the *Forests (Trained Workmen) Rules, 2015* held a virtual engagement session with training coordinators, administrators and managers on 14 December 2022.

Ms Suzie Adee, Training Officer (Administration) shared that STAT is registered as a Training Provider with Human Resource Development Corporation (HRD Corp).

With that, training costs such as course fees and travelling expenses for skills sets offered by STAT are now claimable by the registered employers from the Human Resource Development levy contributions upon completion of training under the HRD Corp Claimable Course Scheme.

Hence, with effect from 1 January 2023, STAT will start charging course fee of RM500 per day per skills set for STA members and RM1,000 for non-members along with travelling expenses specifically air tickets, transportation, accommodation and allowance of the trainers/assessors.

Participants were also briefed on the steps involved in utilising the levy for providing training which included nomination of training, grant application and approval, confirmation of training schedule, as well as claim application and submission.

The newly elected Committee members then held its first Committee Meeting and received updates on the plywood industry.

Members acknowledged that the plywood production and export has decreased significantly over the years, in tandem with reducing volume of log production and

members are looking at other alternatives to sustain their plywood production. They also hoped that the Government could provide the industry with clearer direction on Sarawak forest plantation so that they could gauge the volume of planted timber available for the plywood industry.

STA members endeavor to strategise and maintain closer trading relationship with Japan, Sarawak's largest plywood importer. In addition to that, Committee members also discussed compliance to Clean Air Regulations 2014, received latest update of European Union Deforestation-free Regulation (EUDR).

# National Timber Industry Strategic Plan Monitoring Workshop (NTISP)

Malaysian Timber Industry Board (MTIB) launched the National Timber Industry Strategic Plan (NTISP) 2021-2025 on 13 June 2022. Following that, MTIB organised an NTISP Monitoring Workshop on 12 December 2022 at Bangi Resort Hotel, Kuala Lumpur to obtain information and input from agencies, institutes, nongovernment organisations and industry pertaining to the implementation of activities planned under the strategic objectives of NTISP.

In his opening speech, Mr Haji Kamaruzaman Othman, Director General of MTIB informed that the NTISP was developed in line with the National Agricommodity Policy 2021-2030 (DAKN2030) to provide continuous support to the timber industry and ensure that the timber industry remains competitive in the challenging global market. This is imperative in order for the industry to achieve the targets set out in the national Shared Prosperity Vision 2030 which centred on maximising economic potential through value-added industry, advanced technology and equitable distribution of income.

Dr Hajah Emelia Fantoza Saraih, Deputy Secretary, Strategic Planning and International Division, Ministry of Plantation and Commodities (MPC) briefed on the five (5) core thrusts of the DAKN2030, namely sustainability, productivity, value creation, market development and inclusivity, as well as the fourteen (14) strategic and eleven (11) flagship programmes formulated across the eight (8) sub-sectors of

agricommodity.

Participants of the workshop were then divided into five (5) groups based on the five core strategics of NTISP, namely (i) raw materials and industrial sustainability; (ii) technology, innovation and industry support; (iii) human capital and productivity; (iv) market development and trade; and (v) increased Bumiputera involvement to discuss on the activities and programs planned for the timber industry.

Mr Goh Chew Yew, President of Malaysian Timber Association (MTA) chaired its Executive Committee (EXCO) Meeting No 4/2022 on 19 December 2022 at Aloft Hotel, KL Sentral to deliberate the draft report on Malaysia Timber Industry Roadmap (MTIR).

The appointed consultant, Mr Yong Teng Kong presented the draft report to the EXCO members who then agreed to rearrange the vision statement as *"Towards a Sustainable, Innovative and High Value Industry by 2030"*. EXCO members also reviewed the draft report and made several recommendations for actions by the Government. These inputs will be incorporated into the final draft report and reviewed again in the next EXCO meeting.

## Seminar on Compliance with Timber Industry Regulations (Formaldehyde Emission Level from Panel-based Products)

The Malaysian Timber Industry Board (MTIB) organised a seminar to gather feedback and comments from relevant stakeholders on its draft Guidelines on Compliance with Timber Industry Regulations (Formaldehyde Emission Level from Panel-based Products). The Seminar took place at MTIB Conference Hall, Menara PGRM Kuala Lumpur on 6 December 2022.

In the speech by Mr Haji Kamaruzaman Othman, Director General of MTIB, read by Ms Roslina binti Idris, Deputy Director General (Development & Commercial), he shared that the Regulation is not meant to burden any parties but rather to protect the health of Malaysian consumers from exposure to high level of formaldehyde in various products especially timber products.

Mr Mohd Zamakhsyary Bin Mustapa, Senior Assistant Director (Industry Development Section), MTIB informed participants that manufacturer of panel-based products such as plywood, particleboard and fibreboard from Sabah and Sarawak would also need to adhere to this Guideline when exporting to Peninsular Malaysia and Labuan Territory.

Mr Wan Suhaimi Bin Wan Chek, Assistant Senior Officer (Economic Affairs) introduced MTIB Certification Body Unit. The Unit, accredited by Malaysian Standard Department, is tasked to develop and implement the Product Certification System as well as carry out audit assessment and issue certificates to companies that comply to the standards' need.

Ms Nor Liza Mat Yasok, Director of Fibre and Biocomposite Center (FITEC) also took the opportunity to introduce the role that FITEC plays in the development of fibre and bio-composite industry in Malaysia as well as few types of laboratory testing facilities including types of formaldehyde emission testing.

In concluding the seminar, MTIB acknowledged that panel-based products manufactured in Sarawak and Sabah either produce no formaldehyde or low formaldehyde emission level.

# SayD'SignersSarawak Closing Ceremony

Saradec Management Sdn Bhd (SARADEC), a wholly-owned subsidiary company of Sarawak Timber Industry Development Corporation (STIDC) has been mandated to operate and manage Sarawak Young Designers Programme, also known as *SayD'SignersSarawak*.

*SayD'SignersSarawak* is a two-year skill design training programme developed in a collaborative effort between STIDC, Saradec, and Institut Teknologi Bandung ITB. The fully customized design training programme aims to equip young talented designers with all necessary skills and knowledge in furniture design. The programme requires the designers to undertake their final year at the Faculty of Art and Design (FSRD) ITB in Bandung, Indonesia, where they would refine their knowledge and skills in furniture design through hands-on experiences.

To date, four (4) batches of *SayD'SignersSarawak* participants have undergone furniture design training programme at Faculty of Fine Arts and Design, ITB and a closing ceremony for the programme was held at Pullman Hotel, Bandung, Indonesia on 6 December 2022.

Deputy Premier of Sarawak cum Minister of International Trade, Industry and Investment, Datuk Amar Awang Tengah Ali Hasan attended the event on behalf of Premier of Sarawak, Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari Bin Tun Datuk Abang Haji Openg and handed over training completion certificates to 26 participants

from the second, third and fourth batch of the programme.

The Premier of Sarawak, in his speech read by Datuk Amar Awang Tengah Ali Hasan highlighted Sarawak's plans to develop furniture parks in Kuching and Tanjung Manis in line with the Post COVID-19 Development Strategy (PCDS) 2030 of advancing the downstream industries of the forestry sector through high value-added products such as engineered wood products and furniture. Therefore, investors from Indonesia are welcomed to explore investment opportunities in Sarawak's furniture industry or any other timber related industries.

Consul-General of the Republic of Indonesia in Kuching, Mr Raden Sigit Witjaksono shared that the furniture design training programme at ITB was implemented as a result of a memorandum of understanding signed between

The first group of *SayD'SignersSarawak* participants began training in 2019 and SARADEC has prepared more young designers from Sarawak to undergo training in 2023, in line with the vision and mission of the Sarawak Government to produce 100 trained young designers by 2030.

The ceremony ended with a tour to a mini exhibition displaying the prototypes of easy chairs and life-sized products designed by the graduates.

# Global Timber Index Platform Report Press Conference and International Workshop on Global Timber Market Trend

The International Tropical Timber Organisation (ITTO) has been promoting the Legal and Sustainable Supply Chains (LSSC) Programme to enhance tropical timber supply chains to meet increasing demand for sustainability and assurance that products are from legal source.

In an effort to implement the LSSC Programme, ITTO, in collaboration with the Macao Trade and Investment Promotion Institute (IPIM) carried out an activity on "Supporting the Establishment and Operation of the Global Timber Index (GTI) Platform for Building Legal and Sustainable Forest

Building Legal and Sustainable Forest Products Supply Chains".

The activity was designed to establish and operate a GTI platform to facilitate business information, data exchange and collaboration among stakeholders, with a view of building legal and sustainable forest products green supply chains and increasing the trade in legally and sustainably produced forest products within a stable, transparent and predictable business environment.

Malaysia has been identified as one of the six (6) pilot producing countries with the Ministry of Plantation and Commodities (MPC) as its focal point. The other five (5) pilot producing countries are Indonesia (Asia), Gabon and Congo (Africa) and Brazil and Mexico (Latin America). China participated in the GTI platform as consuming country, with the participation of approximately 150 enterprises/companies.

A hybrid press conference on GTI Platform was jointly organised by ITTO and IPIM and hosted by the Secretariat of Global Green Supply Chain Initiative (GGSC) on 8 December 2022 at the Venetian, Macao SAR China. Ms Sheam Satkuru, Executive Director of ITTO commended all stakeholders on the release of the pilot countries' first monthly GTI index report.

The International Workshop on Global Timber Market Trends was held immediately following the release of the GTI report, with the participation of timber enterprises and associations, organisations, experts and scholars. In the Workshop, participants discussed opportunities and challenges for the global timber industry in the post-epidemic era and trends in global timber markets.

Ms Annie Ting Chief, Chief Executive Officer of STA was one of the presenters at the workshop. She presented a paper on "*Brief Introduction to STA and Sarawak timber Industry*" during the Workshop.

# EU Deforestation-free Regulation (EUDR)

The European Commission (EC) published a proposal aimed at curbing deforestation and forest degradation driven by the expansion of agricultural land on 17 November 2021. This initiative is part of a set of European Union (EU) Green Deal legislative proposals to among others, stop deforestation.

Subsequently, on 6 December 2022, the EU Council, its Commission and the European Parliament reached an agreement on a new law, called the EU Deforestation-free Regulation (EUDR) that will ensure goods placed on the EU market will no longer contribute to deforestation and forest degradation in the EU and elsewhere in the world.

The EUDR has included seven (7) commodities within the scope of the EU Regulation i.e soy, beef, palm oil, wood, cocoa, coffee and rubber. It also covers some derived products such as leather, chocolate and furniture. It states that any of these commodities associated with lands deforested after 31 December 2020 will be prohibited in the EU market.

Like the EU Timber Regulation, the EU defines those obligated by the EUDR as 'operators' and 'traders'. Operators, namely companies who first place products in the single market, will be required to carry out due diligence on their supply chains to ensure that these products are deforestation and forest-degradation-free or have been produced in accordance with the relevant legislation of the country of production. Traders, on the other hand, will be responsible for storing and sharing information on their supply chain to operators.

The Regulation specifies requirements for each step of the due diligence process which encompasses an obligation to collect information on their supply chains, perform risk assessments and implement risk mitigation actions where necessary. This includes obtaining geo-localisation information on forest/farm production plots. A central database of risk assessments or country benchmarks will be developed by the EC to help classify countries as presenting low, standard or high risk of producing commodities or products that are not deforestation-free or in accordance with the legislation of the producer country. Obligations for operators and authorities will vary according to the level of risk of the country or region of production, with simplified due diligence duties for products coming from low-risk and enhanced scrutiny for highrisk areas.

Malaysia does not view the EUDR in a favourable light. Dato' Sri Haji Fadillah Bin Haji Yusof, Deputy Prime Minister and Minister of Plantation and Commodities of Malaysia has issued a media statement on 23 December 2022 stating the unilateral initiative will have detrimental effect on free and fair trade, and potentially result in adverse impacts on global supply chain.

The Regulation places additional burdens on Malaysian palm oil exporters to the EU market, specifically additional traceability requirements and data that must be provided to end-customers based in the EU. He called for the EU to commit to genuine engagement with producing countries.

STA, along with other associations in the forestry and timber sector had previously raised their concerns on the Regulation through MTA in August 2022. The position paper from the Malaysian timber industry criticise, among many others, the absence of dialogue between the EU and producer countries and definitions used and the lack of respect on other countries' sovereignty.

The industry is also dismayed with the non-recognition of sustainable forest management practices and certification schemes as tools to comply with the Regulation.

## Asia Climate Summit 2022

International Emissions Trading Association, in collaboration with International Carbon Action Partnership and the International Energy Agency organised the Asia Climate Summit 2022 in Singapore from 7 to 8 December 2022.

With theme "Carbon Markets for Net Zero: An Era of Growth, Convergence, Innovation and Opportunity", the Summit provided a forum for in-person and online participants to review progress across Asia in building new and expanded carbon markets as well as take stock of the evolving net zero landscape and clean growth opportunities in the region.

Among some of the key highlights from the 2-day event is that the Voluntary Carbon Market (VCM) is an important complementary and low-cost tool to help accelerate climate mitigation globally while contributing to economic growth. However, more work needs to be done to build quality and integrity into the VCM.

Additionally, the decisions to deploy finances to carbon offset projects are often influenced by uncertainties around carbon tenure and the presence of key elements such as permanence, economics and quality.

Therefore, with the global demand for carbon offsets estimated to grow forty-fold between now and 2050, to 5.2 billion tons of carbon dioxide equivalent, governments are urged to address barriers to investment so that finance can be leveraged to where it can have the most impact, particularly in advancing global climate action and ambition.

## MEF Webinar on Occupational Safety & Health (Amendment) Act 2022 and Cases of Unfair Dismissal Claims

The Malaysian Employers Federation (MEF) organised a webinar on 6 December 2022 to keep its members in the Sabah and Sarawak region abreast on matters pertaining to Occupational Safety and Health (OSH) and cases of unfair dismissal claims.

A briefing on newly gazetted Occupational Safety and Health (Amendment) Act 2022 (OSHA 2022) was delivered by Mr Haji Anis Fahmy Bin Pauzi, OSH Senior Consultant of MEF who also shared that OSHA 2022 would be enforced in June 2023 and is applicable to all places of work in Malaysia except domestic employment, armed forces and work onboard ships. OSHA 2022 imposes new duty on employers to develop and implement procedures to deal with emergencies and formulate OSH policy. An OSH coordinator is to be appointed if there are five (5) or more employees at place of work. Dr Dzulzalani Bin Eden, Senior Consultant – Industrial Relations of MEF highlighted in his presentation that with effect from January 2021, the Industrial Relations (Amendment) Act 2020 accorded the Director-General of Industrial Relations (DGIR) the power to refer dismissal cases straight to the Industrial Court if the DGIR is satisfied that there is no likelihood of a conciliation settlement. Referral by the Minister of Human Resource is no longer required.

This amendment has shortened the time taken to finalise unfair dismissal cases and enables both the employer and the employee to appoint any other person, except an advocate or solicitor, to represent them at conciliation meetings.

Dr. Dzulzalani also reminded participants that employers are prohibited from prematurely retiring employee before he or she attains the minimum retirement age of 60 years old under the Minimum Retirement Age Act 2012 (Act 753). 马来西亚雇主联合会(MEF)于 2022年12月6日举办线上研讨 会,让沙巴和砂拉越区域的会员 了解有关职场安全与健康(OSH) 和不公平解雇索赔案件的最新资 讯。

The Malaysian Employers Federation (MEF) organised a hybrid meeting on 5 December 2022 which was attended by 20 members of MEF East Malaysia Region. The meeting was chaired by Dr. Dzulzalani Bin Eden, Senior Consultant – Industrial Relations of MEF, aimed at sharing information on the Industrial Relations Act 1967 (Amendment 2020) (Act A1615) and changes in the work process by the Department of Industrial Relations (DIR) Sarawak.

DIR Sarawak was represented by its Chief Assistant Director, Ms Chong Chun Nee. She briefed on the amendments to the Industrial Relations Act 1967 (Act 177) and informed that the Minister of Human Resources (Minister) has made amendments to Act 177 vide Act A1615 and has, vide Gazette Notification

She highlighted some key areas of amendments, such as repealing the discretionary powers of the Minister under Sections 9 and 20(3) to filter cases to be referred to Industrial Court. Such power was instead given to the Director General of Industrial Relations (DGIR).

Another salient change is the DGIR is now empowered under Section 20(3) to refer representations on dismissal by a workman to the Industrial Court for an award, when he is satisfied that there is no likelihood of settlement under Section 20(2).






