The STA Certification Committee held its first meeting of the year on 9 May 2025 at Wisma STA, Kuching. During the meeting, the Committee expressed its appreciation for the contributions made under the leadership of the late Mr Wong Ting Chung, who passed away earlier this year. Following the passing of Mr Wong, the Committee elected Mr Nelson Bijack James Chas as the new Committee Chairman.

Several key topics were discussed during the meeting, including enrichment planting, updates on the proposal to list Shorea spp. in Appendix II of the Convention on International Trade in Endangered Species of Wild Fauna and Flora, and the timber legality assurance system.

The Board of Honorary Advisers (BHA) and Board of Directors (BOD) of STA Mutual Sdn Bhd held their respective meetings on 9 May 2025 and 13 May 2025 respectively.

During these meetings, the five (5) members of the BHA and three (3) members of the BOD unanimously approved a scholarship worth RM12,500.00 to Mr Melvin Ayom anak Lawan, a student currently pursuing a Diploma in Forestry at Universiti Putra Malaysia, Bintulu Campus. In addition, they also considered and approved financial assistance to several charitable organisations.

### **Timber Legality Assurance System** (TLAS) Strengthening Study Project

As global demand for legal timber grows, Malaysia is taking proactive steps to enhance its Timber Legality Assurance System (TLAS). Spearheaded by the Ministry of Plantation and Commodities (KPK) through the Malaysia Timber Industry Board (MTIB), the TLAS Strengthening Study Project aims to strengthen and align Malaysia's TLAS framework with international trade standards.

Running from 1 February to 31 August 2025, the project is led by consultancy firm 27 Advisory Sdn Bhd (27 Advisory). It emphasises stakeholder engagement, interregional collaboration, and benchmarking against global best practices.

To support this initiative, forestry agencies and timber industry representatives from Peninsular Malaysia, Sabah, and Sarawak, headed by Malaysian Timber Association (MTA) conducted a working visit to the Sabah Forestry Department (SFD) Headquarters in Sandakan on 6 May 2025. The visit facilitated open discussion on TLAS implementation.

The group was welcomed by Mr Indra Purwandita Sunjoto, Deputy Chief Conservator of Forests (Planning & Management). Officers from each region shared experiences on TLAS practices, compliance verification processes, and digitalisation initiatives in forest data and licensing systems. This exchange of ideas reinforced the importance of regional collaboration in enhancing national timber legality framework. The meeting concluded with all three forestry departments, Sarawak Timber Industry Development Corporation (STIDC), Harwood Timber Sdn Bhd (HTSB), and MTIB recognising significant value in the forum's outcomes and agreed that the MTA shall continue to facilitate this forum.

Following the working visit, Focus Group Discussion (FGD) under the project was held on 8 May 2025 at Citadines Uplands, Kuching. Organised by MTIB, the session aimed to validate findings, identify improvements to the existing TLAS, and review a draft framework tailored to Sarawak's context.

The session gathered key stakeholders from Sarawak, including the Ministry of Natural Resources and Urban Development (MUDeNR), **Forest** Department Sarawak (FDS), STIDC, HTSB, and STA. Facilitated by 27 Advisory, the discussion examined local implementation of the Sarawak Timber Legality Verification System (STLVS) and its integration into a broader national framework.

The session also highlighted international best practices, including timber legality verification systems, supply chain integrity, and trade compliance. The Sarawak group pointed out that the National TLAS proposed by the consultant may cause confusion in the market, as the STLVS is already well accepted by buyers. The National TLAS should incorporate the existing TLAS frameworks from all three regions without attempting to harmonise them, as each framework is already credible and recognised in the market. Any proposed changes would need to be brought to the State Cabinet for consideration, in light of Sarawak's autonomy in forestry governance. Moreover, each region is at a different stage of development and operates under its own laws and regulations.

Similar FGDs were also conducted in Peninsular Malaysia and Sabah, gathering feedback from regional stakeholders. Insights gathered, were compiled into a draft interim project report. This report was then shared with stakeholders for review and comments.

On 23 May 2025, the Inter-Agency Sarawak Committee on Forestry and Timber Industry convened at Wisma STA, Kuching to review the draft interim report. The meeting was chaired by Mdm Tessy Nimos, Head of the Forest and Wildlife Division at MUDeNR, and attended by officers from FDS, STIDC, Harwood Timber Sdn Bhd, and the STA Secretariat.

**Participants** provided constructive feedback to refine the report, ensuring the framework accurately reflects Sarawak's unique legal and operational landscape. This finalised feedback was submitted by STIDC to MPC and MTIB.

Lembaga Perindustrian Kayu Malaysia (MTIB) di bawah Kementerian Perladangan dan Komoditi (KPK) sedang menerajui Projek Kajian Pengukuhan Sistem Jaminan Kesahan Kayu (TLAS) bagi menyelaraskan kerangka kesahan kayu Malaysia dengan piawaian perdagangan antarabangsa. Sebagai sebahagian daripada inisiatif ini, agensi perhutanan dan wakil-wakil industri daripada seluruh Semenanjung Malaysia, Sabah dan Sarawak telah mengadakan lawatan ke Jabatan Perhutanan Sabah di Sandakan pada 6 Mei 2025 bagi bertukar pandangan tentang pelaksanaan TLAS dan usaha pendigitalan.

Susulan lawatan tersebut, sesi Perbincangan Kumpulan Fokus yang pertama telah diadakan pada 8 Mei 2025 di Kuching, di mana para pemegang taruh Sarawak menyuarakan sokongan terhadap model TLAS kebangsaan sambil menekankan keperluan untuk mengekalkan kebebasan operasi di peringkat negeri bagi memastikan pengiktirafan antarabangsa.

Jawatankuasa Antara Agensi Sarawak mengenai Perhutanan dan Industri Perkayuan telah meneliti draf laporan interim projek pada 23 Mei 2025 dan maklum balas akhir telah dikemukakan oleh STIDC kepada KPK dan MTIB bagi tujuan penambahbaikan selanjutnya ke atas kerangka TLAS kebangsaan.

隶属于马来西亚种植及原产业部(KPK)的马来西亚木材工业局(MTIB)正在主导木材合法性保 证系统(TLAS)强化研究项目,旨在使马来西亚的木材合法性框架与国际贸易标准接轨。作 为该项目的一部分,来自马来西亚半岛、沙巴和砂拉越各地的林业机构和工业代表于2025 年5月6日访问位于山打根的沙巴森林局,就TLAS的实施和数字化转型交换见解。

在访问之后,首次焦点小组讨论于2025年5月8日在古晋举行。砂拉越的利益相关者表示支 持联合TLAS模式,同时倡导州级运营独立性,以确保获得国际认可。

砂拉越森林和木材工业跨机构委员会于2025年5月23日审查该项目的中期报告草案,并将 最终反馈由砂拉越木材工业发展机构(STIDC)提交给KPK和MTIB,以进一步完善马来西亚的 TLAS框架。

### Field Visit to the Research Plots at Samarakan, Bintulu

On 21 May 2025, Ms Tchin Boon Ling, Member Services Officer joined the Forest Department Sarawak (FDS) on a field visit to the research plots in Samarakan, Bintulu. The primary objective of the visit was to assess the current condition and performance of various tree species, as well as to explore strategies for future management and practical applications within Sarawak's industrial forest plantation landscape.

Guided by Mr Paul Valentine, General Manager of Sarawak Planted Forests Sdn Bhd, the group toured several research plots. Among the sites visited were those developed under the Falcataria moluccana research project, previously funded by STA.

The visit also included a forward-looking discussion on how to maximise the value of these research plots. Key proposals included the establishment of seed production areas and integration of research outcomes into industrial forest plantation initiatives.

## Engagement Session on the Implementation of MyTLAS towards European Union Deforestation-free Regulation (EUDR) Compliance

The Engagement Session on the Implementation of MyTLAS towards European Union Deforestation-free Regulation (EUDR) Compliance was organised by Malaysian Timber Industry Board (MTIB) on 15 May 2025 at Sunway Putra Hotel, Kuala Lumpur. The session was attended by about 140 participants from government agencies, timber industry players and associations, including STA.

The session aimed to update stakeholders on the strengthening of MyTLAS and preparations for compliance with the EUDR within the industry, focussing on timber supply chains in Peninsular Malaysia.

Four (4) presentations were delivered:

## (a) Status of MyTLAS Implementation and Preparation towards EUDR

Ms Sunita binti Muhamad, Senior Deputy Director of MTIB's Licensing and Inspectorate Division outlined MyTLAS procedures, including company registration, physical inspection, and certification. Companies must use only legal timber, perform due diligence, and keep transaction records for two years. EUDR compliance demands additional documentation such as removal

passes, harvesting licenses, scientific names, geolocation, and certification. She also shared timber export statistics, noting the top markets as the USA, China, Japan, Singapore, and Australia.

#### (b) Preparation by AP-MyTLAS in the Peninsular Malaysia Forestry Department

Ms Nor Halizah binti Ab Halim, Head of Forest Certification at the Forestry Department of Peninsular Malaysia discussed their preparedness efforts. The Department can now include QR codes on removal passes for geolocation tracking. Challenges remain in providing scientific names for over 1,300 tree species, requiring improved digital and dendrology skills. Other challenges include procuring high-precision GPS equipment, improving digital tracing, ongoing staff training, and costly, time-consuming data coordination across states. Additionally, obtaining approvals for the release of confidential geolocation data adds to the complexity. Given the high compliance costs, there may be a need to review existing tax rates and fees related to forest products.

#### (c) Geolocation Data Requirements for EUDR Compliance

Mr Muhammad Annizam bin Mohd Mohtar, Principal Assistant Secretary of the Strategic Planning and International Division at the Ministry of Plantation and Commodities explained the detailed geolocation data requirements under EUDR, including precise latitude and longitude coordinates, and polygon mapping for plots larger than four hectares. He noted security restrictions on sharing certain geospatial data per Department of Survey and Mapping Malaysia guidelines, recommending alternative mapping sources like MyLOT, Google Maps, and the EU Forest Observatory.

## (d) TEAM Intelligence Mission to the European Union (EU) and United Kingdom

Mr Chua Song Fong, President of the Timber Exporters' Association of Malaysia shared insights from a November 2024 mission to the EU. Stakeholders raised concerns over free, prior informed consent. Recommendations included speeding up removal pass digitalisation, providing detailed technical data on Malaysian tree species, and encouraging MTIB to engage EU authorities to promote MyTLAS-EUDR.

Sesi itu menampilkan empat pembentangan yang bertujuan untuk memaklumkan kepada pihak berkepentingan mengenai usaha memperkukuh MyTLAS dan persediaan ke arah pematuhan EUDR, memfokuskan kepada rantaian bekalan kayu di Semenanjung Malaysia.

STA hosted a reception on 8 May 2025 at Izzy's, Kuching, to welcome the delegates attending the 2025 International Timber Club JIV HOO-HOO Convention, organised by the Malaysia Timber Industry Club 275.

The convention brought together approximately thirty five timber industry professionals, including delegates from Australia, Canada and Malaysia. As part of HOO-HOO International, a global organisation founded in 1892 in Arkansas, USA dedicated to uniting members from all sectors of the forest products industry, this event provided a valuable platform for sharing knowledge and strengthening industry ties.

The reception at Izzy's offered a relaxed and friendly environment where about fifteen STA members and staff, led by Dato' Sri Patrick Wong, STA Honorary Secretary, interacted with the visiting delegates. The event was a great platform to foster connections, exchange ideas, and celebrate the collaborative spirit that defines the wood products sector.

## Malaysia Strengthens EUDR Readiness through Strategic Mission to Belgium, the Netherlands, and the Czech Republic

The Malaysian Timber Association (MTA), in collaboration with the Malaysian Timber Council (MTC), successfully concluded an industry-led mission to Brussels, Utrecht, and Prague from 18 to 24 May 2025. The mission aimed to enhance Malaysia's engagement with the European Union Deforestation-free Regulation (EUDR) and to strengthen the timber sector's readiness its implementation.

Led by Mr George Yap, MTA President, the delegation included Mr Yong Teng Koon, MTA Advisor, along with MTA members from Malaysia's three regions: Mr Chua Song Fong, President of the Timber Exporters' Association of Malaysia, Mr Tu Kui Foh, Vice President of the Sabah Timber Industry Association, and Ms Annie Ting, Chief Executive Officer of STA. MTC was represented by Mr Khairul Anwar, Director of Strategic Planning & Sustainability, and Mr Gopi Tanikudy, Regional Head of MTC Europe.

Coordinated by MTC's Europe Regional Office, the delegation engaged in high-level meetings in Brussels and Utrecht with the EU Competent Authorities, European Commission officials, Members of the European Parliament, and key stakeholders in the European timber industry. Discussions reaffirmed Malaysia's commitment to sustainable forest management and responsible timber trade, while highlighting the importance of transparency and inclusivity in the EUDR country benchmarking process.

A key highlight was the meeting on 21 May 2025 with Mr Patrick Child, Acting Director-General of the Commission's European Directorate-General Child Environment. Mr acknowledged Malaysia valued partner and welcomed the country's constructive participation in the EUDR process. The delegation was informed that the EUDR country benchmarking results would be released on 22 May 2025. While no formal appeal mechanism exists for the benchmarking decisions. stakeholders may seek legal recourse through the European Court of Justice.

The delegation also sought clarification on the EU's guidance document regarding the submission of annual due diligence statements, noting the ambiguities in its practical implementation.

Meetings with European timber industry representatives revealed that several EU Member States, including Germany and Austria, are unlikely to meet the EUDR implementation deadlines (31 December 2025 for large operators and traders, and 30 June 2026 for micro and small enterprises). Many stakeholders attributed the delays to stringent and, in some cases, impractical regulatory requirements in the agriculture and forestry sectors. As a result, pressure is mounting for the EU to reconsider, revise, or delay certain aspects of the regulation to enable a more feasible and effective implementation.

The delegation expressed disappointment with the European Commission's announcement on 22 May 2025, which classified Malaysia as a 'standard risk' country under the EUDR benchmarking process. This designation has significant consequences, as it subjects Malaysian timber products to more stringent due diligence requirements by EU importers, placing them under heightened regulatory scrutiny compared to timber from countries classified as 'low risk,' such as Papua New Guinea and Vietnam.

The mission concluded in Prague, where the delegation participated in the Wood Industry Associations from Central and Eastern Europe (CEE) Conference on 23 May 2025. Co-hosted by the Forestry and Wood-Processing Companies Association of the Czech Republic and the Association of the Austrian Wood Industries, the conference brought together policymakers, researchers, and industry leaders to discuss shared challenges and opportunities across the European wood value chain.

Mr Patrik Mlynář, Director General of the Forestry Section at the Czech Ministry of Agriculture, opened the conference by emphasising the critical role of the wood industry in addressing global environmental

challenges, especially in light of climate change and increasing demand for sustainable resources. He stressed the importance of crossborder collaboration to ensure the sustainable management of forest resources.

In a video message, Ms Vrecionová, Veronika Member of the European Parliament and Chair the Committee Agriculture and on Development, Rural underscored the EU's commitment in supporting practices greener within the forestry and wood industries. She highlighted the EU's role in shaping policies that balance environmental sustainability with economic growth.

The conference brought together influential voices from across the forestry, academic, industry, and policymaking spheres.

Speakers addressed a broad spectrum of issues, including the need for stronger cross-sector collaboration within the wood value chain, the growing impact of climate change on forest ecosystems, and the challenges surrounding raw material availability. Discussions also highlighted the economic importance of the forestry sector and called for coherent, long-term policy frameworks to support the sustainable management of forest resources throughout the region.

Mr Yong Teng Koon presented "Malaysia's Perspective on EUDR – Impact & Readiness." He reiterated Malaysia's commitment to sustainable forest management and underscored the country's proactive efforts to align with the EUDR. He also called for practical and inclusive implementation frameworks that recognise the efforts of responsible producer countries.

The conference provided a valuable platform for fostering regional and international cooperation, reinforcing a shared commitment to sustainability, trade fairness, and climate resilience within the forestry and timber sectors.

Dari 18 hingga 24 Mei 2025, Persatuan Perkayuan Malaysia (MTA) dan Majlis Perkayuan Malaysia (MTC) telah mengetuai misi strategik ke Belgium, Belanda dan Republik Czech bagi memperkukuhkan kesiapsiagaan industri terhadap Peraturan Bebas Penyahutanan Kesatuan Eropah (EUDR). Delegasi tersebut telah berinteraksi dengan pegawai EU dan pemegang taruh industri bagi menegaskan komitmen Malaysia terhadap pengurusan hutan secara lestari, menjelaskan keperluan pematuhan serta menyokong proses pelaksanaan yang adil dan inklusif. Misi tersebut berakhir di Prague pada persidangan industri kayu serantau, yang memperkukuh kerjasama global dalam mempromosikan perdagangan kayu yang mampan dan bertanggungjawab.

### PwC Malaysia's 2025 Transfer Pricing & Stamp Duty Seminar

PricewaterhouseCoopers (PwC) Malaysia conducted its 2025 Transfer Pricing & Stamp Duty Seminar on 5 May 2025 at the Borneo Cultures Museum in Kuching. In his opening address, Mr Keegan Ong, Partner, Tax at PwC Malaysia, emphasised the significance of OP Rejang, a recent initiative by the Inland Revenue Board (IRB) in Sarawak aimed at strengthening tax compliance. He also noted the IRB's move towards digitalisation, particularly through the introduction of e-invoicing, which promotes greater transparency and efficiency.

The seminar provided timely insights into recent updates in transfer pricing and the transformation of the stamp duty regime. Mr Desmond Goh, Partner, Transfer Pricing, provided an overview of the Malaysian Transfer Pricing Guidelines 2024 and Transfer Pricing Audit Framework, focusing on transfer pricing documentation requirements and audit readiness. The MPTG 2024 also provides exemptions to relieve certain

individuals and companies from complying with Contemporaneous Transfer Pricing Documentation.

On the stamp duty front, Ms Cynthia Ng, Director, Tax, discussed the forthcoming Stamp Duty Self-Assessment System (SDSAS), which represents a major shift in compliance obligations. Effective 1 January 2026, the responsibility for computing and paying stamp duty will shift from the IRB to taxpayers, who must accurately assess and remit the duty based on the relevant instruments or agreements, including employment contracts. The IRB has also issued a Stamp Duty Audit Framework, effective 1 January 2025, which outlines audit and investigation procedures, including guidelines for voluntary disclosure.

The speakers offered valuable perspectives and practical guidance, drawing on

extensive experience to help participants navigate the evolving tax compliance landscape on transfer pricing and stamp duty. They stressed the importance of accuracy and timeliness in tax submissions, cautioning that noncompliance or incorrect returns could lead to severe penalties, including substantial fines or imprisonment.

## Stamping of Employment Contracts

Starting 1 January 2025, the Inland Revenue Board of Malaysia (IRBM) has intensified enforcement of the Stamp Duty Act 1949 (Act 378) through the implementation of the Stamp Duty Audit Framework. This move has brought new urgency to a long-overlooked compliance requirement: the stamping of employment contracts.

Under the audit framework, the IRBM will examine company documents, including employment contracts, offer letters, and transfer letters, dating back three years from 1 January 2025. This retrospective scrutiny has caught many employers by off guard and raised concerns over potential penalties for non-compliance.

To address growing concerns, the Malaysian Employers Federation (MEF) organised a nationwide online briefing for its members on 26 May 2025. The session was conducted by Datuk Haji Shamsuddin Bardan, Advisor to MEF.

Datuk Shamsuddin explained that under the Act, duty is payable on "instruments" listed in the First Schedule. The term "instrument" is broadly defined as every written documents, which encompasses employment contracts, offer letters, transfer letters, and any documentation involving an offer and acceptance of employment.

While the stamp duty for each employment contract is relatively modest at RM10, the issue is one of widespread non-compliance as many companies have never stamped their employment agreements. Exemptions apply only to contracts where the employee earns RM300 or less per month, a figure that is widely seen as outdated and no longer reflective of Malaysia's current wage landscape.

Under current regulations, employment contracts must be stamped within 30 days of execution. Failing to meet this requirement triggers financial penalties:

Delay Period	Penalty
After 30 days but	RM50 or 10% of the stamp
within 3 months	duty, whichever is higher
More than 3	RM100 or 20% of the stamp
months	duty, whichever is higher

Given that most companies have accumulated years of unstamped employment contracts, the potential costs of retrospective compliance can be significant, especially for organisations with large workforces. Datuk Shamsuddin shared that MEF is in active dialogue with the IRBM, and there is ongoing consideration for penalty waiver if employers stamp outstanding contracts by 31 December 2025.

Recognising the logistical and financial challenges employers face, MEF as well as STA intend to propose an extension of the waiver deadline to 30 June 2026.

Additionally, MEF will advocate for an upward revision of the RM300 monthly income exemption threshold, which no longer reflects current wage levels. MEF also invited members to share feedback and challenges, as part of ongoing advocacy efforts on behalf of employers.

Bagi menangani kebimbangan tersebut, Persekutuan Majikan-Majikan Malaysia (MEF) mengadakan taklimat dalam talian pada 26 Mei 2025, di mana Datuk Haji Shamsuddin Bardan menjelaskan bahawa kontrak pekerjaan mesti disetem dalam tempoh 30 hari untuk mengelakkan penalti. Duti setem sebanyak RM10 dikenakan bagi setiap kontrak, dengan pengecualian untuk pekerja yang berpendapatan RM300 atau kurang sebulan.

马来西亚内陆税收局(IRBM)已加强对1949年印花税法令(第378号法令)的执法,要求雇主在雇佣合约上盖章,而且目前全国大多数合约尚未加盖印花。为回应业界的关切,马来西亚雇主联合会(MEF)于2025年5月26日举行线上简报会,并由拿督哈芝沙姆苏丁在会上说明,雇佣合约必须在30天内盖章,以避免受到处罚。每份合约的印花税为马币10令吉,惟月薪马币300令吉或以下的员工则可获豁免。

## MEF East Malaysia (Sarawak) Regional Meeting No. 5/2025

The Malaysian Employers Federation (MEF) East Malaysia (Sarawak) Region held its fifth meeting on 22 May 2025, with Ms Dayang Jamillah binti Tun Abang Muhd Salahuddin, Consultant of Industrial Relations at MEF Sarawak, facilitating the session.

The meeting included an informative session on the latest developments in the Occupational Safety and Health Act (OSHA) 1994, presented by Ms Norliyana binti Ahmad Zainuri, Assistant Factory & Machinery Inspector from the Enforcement Section of the Department of Occupational Safety and Health (DOSH) Sarawak.

Ms Norliyana discussed the significant changes introduced by the OSHA (Amendment) Act 2022, which now applies to all workplaces, excluding domestic service, the Malaysian Armed Forces, and work on ships. She emphasised the importance of designating an Occupational Safety and Health Coordinator from among employees. The amendment also introduced key updates to the role of Safety and Health Officers, who are now restricted to working at a single workplace.

Additionally, Ms Norliyana also highlighted the increased penalties of up to RM500,000 for non-compliance with the OSHA regulations, underscoring the serious legal consequences for failing to adhere to safety standards.

## Labour Day 2025 Sarawak Level Celebration

The Sarawak-level Labour Day 2025 celebration, themed "Pekerja Cemerlang, Sarawak Maju Makmur" was held on 18 May 2025 at the Hikmah Exchange Event Centre in Kuching. The event was jointly organised by the Sarawak Premier's Department and the Malaysian Trades Union Congress (MTUC) Sarawak Division.

In his opening speech, MTUC Sarawak Chairman Haji Zaidi bin Nasar highlighted the rising demand for specialised skills in today's fast-evolving, technology-driven economy. He stressed that employees remain vital, but must upskill continuously and be fairly compensated, aligning with Sarawak's vision of becoming a high-income state by 2030.

While officiating the event, the Premier of Sarawak, Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari bin Tun Datuk Abang Haji Openg highlighted Sarawak's unique labour framework and confirmed that the Sarawak Labour Ordinance (SLO) has been harmonised with the Malaysian Employment Act and is now aligned with the International Labour Organisation (ILO) standards. This harmonisation was done with careful consideration to safeguard the rights of Sarawakian employees.

He also emphasised the importance of data-driven and well-coordinated management, particularly in relation to foreign labour. These efforts are essential to ensuring that labour policies remain responsive and aligned with Sarawak's long-term socio-economic objectives. He noted that Sarawak's ambition to become a high-income

state depends on the willingness of its workforce to embrace change, upskill and lead the state's economic transformation.

Also speaking at the event, Datuk Gerawat Gala, Deputy Minister in the Sarawak Premier's Department (Immigration, Labour and Management Unit), outlined recent labour law reforms.

Datuk Gerawat emphasised that these reforms are not merely legal updates, but reflect Sarawak's core values in upholding dignity in labour, employee rights and social justice. A balanced approach supporting both employers and employees will foster long-term stability, higher motivation and productivity.

Mr Phang Pin, Industrial Relations Officer at the Sarawak Labour Department, presented 16 key amendments to the SLO. With the exception of Part IVA relating to employees' minimum standards of housing, accommodation and amenities, all other amendments came into effect on 1 May 2025 covering all employees.

The event also celebrated outstanding contributions in the workplace, including presentations of the Outstanding Employee Award and Cheeriest Union Contingent, along with cultural performances that added a celebratory and unifying spirit to the occasion.

### MTA Task Force on Industrial Tree Plantation Engages with the Malaysian Timber Council

At its Executive Committee Meeting held on 14 April 2025 in Kota Kinabalu, Sabah, the Malaysian Timber Association (MTA) took a significant step toward ensuring the long-term sustainability of the timber industry by establishing a Task Force on Industrial Tree Plantations (ITP). This move underscores the crucial role that ITPs play in securing a steady raw material supply for Malaysia's timber sector. The Task Force is led by Mr Abdul Rahman Khan, Deputy President of the Sabah Timber Industry Association, and includes Ms Annie Ting, Chief Executive Officer of STA, as one of its four members.

On 19 May 2025, the Task Force held a pivotal meeting with the Malaysian Timber Council (MTC) at Menara PGRM 1, Kuala Lumpur. The meeting saw active participation from members and secretariats of both the Task Force and the MTA. as well as senior officers from the MTC.

In her welcome address, Mdm Noraihan Abdul Rahman, Chief Executive Officer of MTC, expressed her support for the Task Force and provided updates on the development of a comprehensive Framework for Community Tree Farming (CTF) and ITP. Developed with support from a consultant under the Task Force on CTF and ITP (TFCI), the framework aims to centralise all relevant information at the national level, providing structured guidelines to enhance the planning, implementation, and execution

of both CTF and ITP programmes. Once completed, it will be submitted to the relevant ministries for approval.

Mr Rahman thanked the MTC for arranging the meeting with the Task Force. He emphasised the need for understanding the unique challenges faced by Malaysia's three regions, especially in relation to CTF and ITP initiatives. Factors such as legislation, land size, regional conditions, and soil quality must be carefully considered when designing a framework that can be effectively implemented across Malaysia's diverse landscapes. He also shared valuable insights from his company's approach to ITPs, including their inter-crop project with local communities and methodology for assessing the long-term economic viability of ITP ventures.

The meeting included a briefing from the appointed consultant on the framework's background, objectives, and methodology, and expected outcomes. The session sparked constructive discussions, with participants identifying areas within the framework that could benefit from further improvement or re-evaluation. The dialogue also explored opportunities for collaboration to ensure a coordinated and effective document development process.

To strengthen this effort, the MTA Task Force welcomed MTC's invitation for Mr Rahman to join the TFCI. This collaboration will aid in identifying and addressing critical areas within the framework for CTF and ITP. Moreover, both parties agreed to develop a strategic action plan once the framework is finalised. This collaborative plan will focus on key issues such as legislation, policy, and financing, with a region-specific approach, tailored to the unique practices and requirements of each area.

### Establishing a Weight-to-Volume Conversion Factor for Planted *Gmelina arborea* in Sarawak

In 2024, the Forest Department Sarawak (FDS), in partnership with Samling Reforestation (Bintulu) Sdn Bhd and STA, initiated a study to develop a reliable weight-to-volume conversion factor for planted *Gmelina arborea* in Sarawak. The aim was to ensure greater consistency in timber royalty calculations and reporting.

The study combined field measurements and laboratory analysis to produce accurate, site relevant data. Areview meeting was held on 13 May 2025 at FDS headquarters

in Kuching, chaired by Mr Semilan anak Ripot, Deputy Director of Forests (Forest Management). Representatives from all collaborating organisations, including the STA Secretariat, were in attendance.

During the meeting, Mr Teng Xin Yao, Research Officer with FDS presented the study's findings and the proposed conversion factor. Following a detailed technical discussion, stakeholders reached consensus on the recommended conversion factor, which will be submitted for formal approval.

Once adopted, the conversion factor will serve as a standardised reference for to ensure consistency and fairness

in the calculating of timber royalties for planted *Gmelina arborea* throughout.

## STA Participates in Sub-TWG Meetings for Malaysia's Forest Carbon Offset Programme

The Malaysia Forest Fund (MFF), under the Ministry of Natural Resources and Environmental Sustainability, is spearheading the development of the Forest Carbon Offset (FCO) Programme, an initiative designed to incentivise forest conservation and climate action through market-based mechanisms.

To guide the technical development of the FCO Programme, MFF has convened a Technical Working Group (TWG) comprising representatives from government agencies, industry stakeholders, and subject matter experts. STA is represented in the TWG by Mr Ling Tiing Tchin, with support from his alternate representative, Ms Freda Emmanuel, Member Services Officer.

Among the four (4) core methodologies developed, namely (i) Afforestation, Reforestation and Restoration (ARR), (ii) Reducing Emissions from Deforestation and Forest Degradation (REDD), (iii) Improved Forest Management (IFM) and (iv) Wetland Restoration (WR), the STA Carbon Committee has identified IFM and REDD as priority focus areas. In preparation for the Sub-TWG meetings, STA members convened an internal discussion to review MFF's draft materials and provide preliminary feedback. Concerns were raised regarding the risk of environmental harm if carbon licences are issued over areas potentially reclassified as Shifting Agriculture, as well as the proposed use of insurance to address non-permanence risks.

The Sub-TWG meetings on IFM and REDD were held on 30 April 2025 and 2 May 2025 respectively. KPMG Malaysia, the lead consultant appointed to develop the methodologies shared findings from a benchmarking study that compared REDD frameworks and definitions used by various standards, including Verra, the American Carbon Registry, and Thailand's

Voluntary Emission Reduction framework.

A key discussion point involved buffer requirements, which serve as safeguards against risks that may compromise the permanence of carbon benefits. The consultant shared benchmarking insights and preliminary recommendations for the FCO Programme, drawing on approaches adopted by existing international standards. Sub-TWG members also worked in breakout groups to match project types with different forest classifications.

The draft methodology will be circulated to TWG members for further review and feedback.

## Workshop on Exploring Carbon Market Opportunities in Sarawak & ASEAN

In conjunction with the Argus Asia Carbon Conference, the Malaysia Carbon Market Association (MCMA), in partnership with Sarawak Energy Berhad (SEB) and Bursa Malaysia, successfully hosted a capacity building workshop titled "Exploring Carbon Market Opportunities in Sarawak and ASEAN" on 28 May 2025 at the Borneo Convention Centre Kuching. The event, held under the flagship of the Ministry of Energy and Environmental Sustainability of Sarawak took place one day prior to the regional conference, drawing participation from government agencies, private sector stakeholders, including STA, financial institutions and civil society organisations.

The session commenced with a welcoming remark by Hajah Siti Aisah binti Adenan, Senior Vice President of Corporate Services at SEB, who highlighted the critical role of carbon markets in facilitating Malaysia's transition to a low-carbon economy. Hajah Siti Aisah also stressed the importance of transparency and environmental integrity in the development of robust carbon credit systems, to prevent challenges such as double counting and greenwashing.

Dr Renard Siew, President of MCMA, opened the workshop by sharing MCMA's vision of establishing a credible and collaborative national platform to support the growth of Malaysia's carbon ecosystem. He emphasised the importance of inclusive stakeholder engagement and capacity building to unlock the full potential of carbon markets. This was followed by a comprehensive presentation by Dr Wei-Nee Chen, Head of Carbon Market at Bursa Malaysia, who introduced the fundamentals of carbon markets and the ASEAN Common Carbon Framework (ACCF). She highlighted the varied stages of carbon market development across ASEAN member states and called for greater regional alignment and interoperability to create a cohesive and efficient ASEAN carbon market. Dr Chen also addressed the importance of enabling policy frameworks, especially as Malaysia prepares to implement a carbon tax in 2026, urging the government to balance ambition with practicality to avoid unintentionally undermining a carbon project's eligibility criteria.

A key highlight of the workshop was the ASEAN Plenary Panel, moderated by Mr Steve Tan, Vice President of Business Development at Argus Media. The panel featured distinguished speakers from regional carbon market associations and networks, including Dr Riza Suarga from the Indonesia Carbon Trade Association, Dr Renard Siew from the MCMA, Mr Anshari Rahman from the Singapore Sustainable Finance Association and Ms Natalia Ria from the ASEAN Alliance on Carbon Markets. Discussion centred on the need for clear and consistent climate policies across ASEAN to attract long-term investment and foster regional carbon market integration of carbon markets.

Participants also engaged in a series of presentations from Mr Tan Win Sim, Regional Representative for East and Southeast Asia at Verified Carbon Standard (VERRA), who introduced Verra's new CCS methodology (VM0049) and Scope 3 Standard for carbon accounting. Mr Soon Hun-Yang, the Chief Executive Officer of Eco-


Ideal Consulting and Mr Francois Blignaut, Carbon Project Lead at SaraCarbon also took the opportunity to share their experiences in developing and implementing carbon projects on the ground, highlighting both the technical and regulatory challenges as well as the opportunities for delivering environmental and social cobenefits.

The workshop concluded with a shared understanding that while the carbon market presents promising opportunities, there are still challenges to be addressed, particularly in the context of Sarawak. To move forward effectively, more open and continuous discussions are needed at the state level to build capacity, align stakeholders, and ensure that Sarawak is well-positioned to participate meaningfully in the evolving carbon landscape.

# ENVIRONMENTAL COMPLIANCE AUDIT TRAINING

The second part of the Environmental Compliance Audit (ECA) training course was successfully organised by STA Training Sdn Bhd (STAT) in collaboration with the Natural Resources and Environment Board (NREB) from 6 to 8 May 2025, at Wisma STA Kuching. The part 2 training covers identifying and overcoming challenges during audits, case studies, review of audit reports, and examinations. The training was delivered by an experienced trainer, Mr Justine Jok Jau Emang.

The ECA training course aims to provide a thorough understanding and practical application of the ECA process to meet the requirements of the Natural Resources and Environment (Audit) Rules, 2008, and the associated guidelines as well as to promote self-regulation within the industry players. This training will enable qualified personnel to be registered as Environmental Auditor with NREB and to conduct internal audits, migrating from the existing Environmental Monitoring Reports (EMR) submission.

With effect from 1 July 2024, it is mandatory for the forestry sector in Sarawak to implement the ECA, replacing the submission of the Environmental Monitoring Report. For agriculture (oil palm plantation), quarry, and mining sectors, it will come into effect on 1 January 2027.






