STA hosted a delegation from the Finnish Smart Forestry on 7 October 2024, led by Mr Mohamed Farid, Senior Advisor at Business Finland. This initiative, organised by the Business Finland in collaboration with the Embassy of Finland, represented a significant opportunity to share Finland's advanced forestry technologies and explore potential collaborations aimed at enhancing sustainable forestry practices in Sarawak.

The visit commenced with a tour of the STA Exhibition Centre, followed by a meeting at the STA office, where the delegation engaged with STA members and senior officials from the Sarawak Timber Industry Development Corporation (STIDC). Mr Brian Yeo, STA Senior Manager of Finance and Administration, welcomed the delegation and facilitated introductions among the participants.

Ms Miriam Hong, STA Manager for Membership, Manufacturing, and Trade, presented an overview of STA's profile, detailing the support offered to the sustainable forestry and timber industry while highlighting current trends and emerging opportunities in the sector.

A Talk on Timber Industry Development in Sarawak – Private Sector Perspective

Ms Annie Ting, Chief Executive Officer of STA was invited to speak to Bachelor of Forestry Science students at Universiti Putra Malaysia Bintulu Campus on 4 October 2024. The event coincided with the students' participation in a two-week forest camp, a vital component of their forestry education.

In her presentation, Ms Ting provided an overview of STA, detailing its objectives, organisational structure, and subsidiary companies. She highlighted various initiatives undertaken by STA to support certification of natural forests and plantations. She outlined the training programmes for forest workers, as well as the development of Reduced Impact Logging (RIL) handbooks. The presentation also covered collaborative research efforts between STA and institutions such as UNIMAS, Swinburne University of Technology, Sarawak Campus, and the Sarawak Forestry Corpoation, focusing on forest plantation management.

During her talk, Ms Ting provided valuable insights into forest management practices in Malaysia, particularly the certification of forest areas and the Sarawak Timber Legality Verification System. She also shared on the products of the Sarawak timber industry while discussing the economic contributions of the industry through premiums, State Sales Tax, and Corporate Social Responsibility (CSR) initiatives.

She also spoke on the challenges faced by the timber industry, such as compliance with the European Union's Deforestation-Free Regulation, rising operational costs, and changing resource availability. She encouraged students to explore career opportunities within the forestry and timber sector, highlighting the industry's need for fresh perspectives to drive sustainable practices.

The talk created an engaging atmosphere, with students actively participating through questions and discussions, which showed their genuine interest in STA's initiatives and commitment to community engagement.

The Malaysian Timber Council (MTC), incollaboration with STA organised an *"Industry Training on ESG Framework for the Malaysian Timber Industry – from Framework to Action"* for members of STA at Wisma STA, Kuching from 2 to 3 October 2024. The training, conducted by Mr Supun Nigamuni and Mr Melvin Ku from Control Union (Malaysia) Sdn Bhd, is a follow up from a previous training session held in December 2023 and aimed to provide essential tools and knowledge to the forestry sector in incorporating effective environmental, social and governance (ESG) principles into their daily operations.

Mr Khairul Anwar, Director of Strategic Planning and Sustainability Division of MTC addressed the participants and informed that the ESG framework, developed by the Malaysian Timber Association (MTA), represents a comprehensive and industry-specific approach to ESG standards. Tailored to the unique needs of the timber industry across all three (3) regions of Malaysia, the framework sets the benchmark for ESG assessment, measurement and reporting.



He added that as global markets increasingly prioritise companies with strong ESG commitments, the framework will help improve supply chain management and ensure that timber-based manufacturers remain competitive on the world stage.

Ms Annie Ting, Chief Executive Officer of STA underscored in her welcoming remarks that sustainability represents a fundamental shift in industry practices. She noted that

the partnership between STA, MTC, MTA, government agencies and industry stakeholders is essential for creating a resilient, competitive, and responsible forestry sector.

The 2-day training introduced participants to the ESG framework, with alignment to global standards such as the Global Reporting Initiative and the Simplified ESG Disclosure Guide for small and medium enterprises (SMEs), developed by the Capital Markets Malaysia. The training focused on practical applications of the ESG framework's material topics guiding participants on how to begin implementation. They were also provided with industry-relevant case studies and a practical template to aid data collection, ultimately facilitating ESG disclosures for their companies.

Tree, Log and Timber Identification Training Course

The STA Training Sdn Bhd (STAT) in-collaboration with the Forest Department Sarawak (FDS) had conducted Tree, Log and Timber Identification Training Course solely for 14 FDS staff from 30 September 2024 to 4 October 2024 at Oriental Evermore Hotel in Sarikei.

In the welcoming remarks by Ms Annie Ting, Chief Executive Officer of STA cum Manager of STA, she welcomed all participants to the training and expressed gratitude to FDS for collaborating with STAT in organising this training. She highlighted that the training encompasses a broad range of competencies and knowledge areas that support forestry experts, timber traders, and woodworkers in identifying species through botanical characteristics, cross-section examination, and wood anatomy. The identification can be challenging for a number of reasons.

Identification Challenges: Species diversity Overlapping and variation chracteristics

Inexperience

Therefore, continuous hands-on training and technological application are essential for enhancing accuracy and identification skills, particularly in diverse environments.

Human error

Madam Runi anak Sylvester Pungga, Senior Assistant Director, Research and Development Division of FDS in her opening speech mentioned that this training was organised as part of the project 12th Malaysia Plan project entitled "Artificial Intelligence (AI) and Forensic Timber Identification for Forest Protection and Revenue Generation" under the scope of capacity building. The training was intended to provide FDS staff the up-skilling, re-skilling as well as to equip them with new knowledge and technology that will eventually lead to more effective, reliable, systematic, precise and more importantly quick result in identification of tree, log and timber. She hoped that the participants could learn and be more skillful, agile and adapt the techniques in their scope of work.

Besides that, Madam Runi had also proposed to have another aspect of collaboration beyond timber with STA that related to conservation of plants such as wild orchids. She highlighted that most of the orchids are epiphytic that lives on trees including commercial timber trees. As part of the forest biodiversity, it is important to include the orchids in the effort of conservation. She gave an example of orchid nursery established at Anap-Muput FMU, whereby FDS managed to rescue and collect the orchids affected by timber harvesting and nurtured them at the nursery. Through that effort, FDS eventually found a new orchid species in the FMU and named it after our Honourable Premier, Bulbophyllum abangjoei.

The five (5) days training was conducted by STAT Trainer, Mr Sumbang Rani and assisted by Mr Ginda Uli. The training covered both theoretical and hands-on training. The practical for identifying trees took place at Sebangkoi Rimba Park in Sarikei, while the log identification exercise was conducted at Logpond Collection Distribution Centre Tanjung Genting in Bintangor. In the classroom, participants were taught on a hands-on workshop on timber identification, which cover the use of instruments and identification methodologies.

Hari Alam Sekitar Negara 2024 - Sarawak Level Celebration

Natural Resources and The Environment Board (NREB) organised the Sarawak level celebration of "Hari Alam Sekitar Negara 2024", an annual event celebrated every 21 October. This occasion aims to foster a culture of environmental education and awareness across the country while honouring individuals and organisations that have made significant contributions to the conservation and preservation of the environment.

In his welcoming address, Datu Jack anak Liam announced the NREB's initiative to establish Environmental Clubs (Kelab Pencinta Alam Sekitar). in all primary and secondary schools. Currently, there are 484 such clubs, but the NREB has set an ambitious goal to expand this number to 700 by 2025, with a long-term target of 1,461 clubs by 2030. Datu Jack explained that the NREB plans to allocate RM2,000 per club to support environmental activities and programmes and achieving this goal will require an estimated RM13 million in funding, benefitting around 187,685 students across Sarawak. He also encouraged corporate bodies to consider financially supporting or sponsoring these clubs to ensure their sustainability, emphasising that this initiative aims to cultivate a generation that values and prioritises environmental responsibility.

The event was attended by Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari bin Tun Datuk Abang Haji Openg, the Premier of Sarawak who announced in his officiating speech, the introduction of two (2) new regulations under the Environment (Reduction of Greenhouse Gases Emission) Ordinance, 2023. The Certified External Auditors Eligibility and Registration Regulations 2024 will establish stringent standards for environmental audits by requiring auditors to be registered and accredited, ensuring the authenticity and reliability of audit reports. These reports will serve as valuable data sources for monitoring compliance with environmental standards.

The second regulation, the Burning and Emission Regulations 2024, will focus on flaring practices within the oil and gas sector. The Premier shared that oil and gas facilities emit flares that release pollutants, and the new regulation, which will come into effect in 2025, will enforce limits on these emissions to prevent adverse environmental impacts, such as excessive heat or explosion risks. He also highlighted the importance

of the NREB in overseeing these activities, ensuring that facilities remain within the permissible emission limits.

During the event, The Premier also approved an allocation of RM13.722 million to support NREB in its target of establishing Environmental Clubs in Sarawak primary schools secondary and across Sarawak over the next six (6) years. The event concluded with the presentation of awards for the Choral Speaking 2024, Competition the Zero Food Waste Video Competition, the Anugerah Media Alam Sekitar Sarawak 2024, and the Anugerah Sekolah Lestari Alam Sekitar, celebrating the efforts of individuals and institutions dedicated to environmental sustainability and awareness in Sarawak.

Engagement Session for the 13th Malaysia Plan

The Federal Ministry of Economy, led by its Minister Mr Rafizi Ramli, held an engagement session at the Pullman Hotel, Kuching on 30 October 2024 to gather Sarawak's inputs for the 13th Malaysia Plan, which will shape national development from 2026 to 2030. This engagement, part of a broader series of state-level sessions running from September to December 2024, follows similar sessions in Selangor, Kuala Lumpur, and Melaka.

This series aims to share the RMK13 framework at the state level and collect feedback on Malaysia's development priorities, challenges, and future direction from a broad spectrum of stakeholders, including government leaders, industry players, academics, and civil society. Mr Rafizi explained that the insights gathered will help the Ministry allocate development resources across states, balancing Malaysia's economic capacity with its strategic goals.

The RMK13 framework is designed to guide Malaysia toward becoming a high-income, developed nation through inclusive and sustainable development. It emphasises high-value industries that incorporate advanced technologies, aiming to cultivate a competitive workforce with higher wages and improved living standards. Prioritising sustainable socioeconomic growth, RMK13 also seeks to bolster resilience against climate change and disasters, while protecting natural resources and the environment. Good governance underpins the plan, ensuring government services remain transparent, efficient, and grounded in integrity.

Mr Rafizi assured that the Ministry will balance allocations equitably, ensuring that all states receive the necessary funding to address developmental disparities. He noted that many projects in Sarawak are already underway, with both federal and state governments aligned on long-term objectives, which will help accelerate progress over the next five years.

Over the next two months, the Ministry of Economy will continue engaging with various sectors to shape a comprehensive RMK13 that is responsive to local and national priorities. Stakeholders can also provide feedback through the official RMK13 portal at https://rmk13.ekonomi.gov.my/.

20th Malaysian Forestry Conference

The Sabah Forestry Department (SFD) hosted the 20th Malaysian Forestry Conference (MFC) from 29 to 30 October 2024 at the Sabah International Convention Centre (SICC) in Kota Kinabalu. With the theme *"Harmonising Forestry Towards Sustainability"*, the conference brought together more than 300 forestry personnel from all three regions, government officials, NGOs, and other stakeholders, including STA, to discuss key issues in forest management and conservation across Malaysia.

The event also provided a platform for exchanging ideas on critical forestry topics, including policy and governance frameworks, climate change adaptation, biodiversity conservation, and community engagement. Over the two days, three keynote speakers and 24 technical papers from forestry experts across Sabah, Sarawak, and Peninsular Malaysia highlighted the latest trends and innovations in sustainable forestry practices.

The Chief Minister of Sabah, Datuk Seri Panglima Haji Hajiji bin Haji Noor, officiated the opening by striking the MFC mallet, marking the official launch of the event. This year's conference also coincided with the Sabah Forestry Department's 110th anniversary, celebrating a century of forest protection and conservation in the state.

A significant highlight of the conference was the launch of the Sabah Mangrove Action Plan (SMAP) 2024-2033, aimed at enhancing the management and conservation of Sabah's mangrove forests, which make up 60% of Malaysia's total mangrove area. The action plan aligns with the state's Blue Economy Agenda and focuses on biodiversity, coastal protection, and climate change mitigation.

The conference also featured an exhibition showcasing various forestry initiatives, projects, and achievements from across Malaysia, providing a space for networking and knowledge-sharing among forestry professionals, policymakers, and the attendees.

The MFC, which began in 1966, rotates every two years among Malaysia's three forestry regions: Sabah, Sarawak, and Peninsular Malaysia. The next MFC will be hosted in Sarawak in 2026.

The meeting underscored a shared commitment to advancing forest plantation initiatives and fostering sustainable practices that could benefit the forest plantation sector. It was agreed that the two sides would reconvene to discuss costing and related matters on ITP once every six months.

He explained that the HRD-TDF is a comprehensive framework designed to establish a pool of competent trainers by implementing a standardised quality benchmarks which includes three (3) categories:

i. Trained-The-Trainer Certified Trainerii. Trained-The-Trainer Exempted Traineriii. HRD Corp Accredited Trainer

Additionally, he also emphasised that in line with the Training Providers' Circular No. 1/2023 dated 14 December 2023, only HRD Corp Accredited Trainers will be eligible to conduct training under various HRD Corp schemes starting 1 January 2025.

ASEAN Carbon Forum 2024 – Development of Carbon Crediting Program and Carbon Projects

In preparation for Malaysia's chairmanship of Association of Southeast Asian Nations (ASEAN) in 2025, the Ministry of Natural Resources and Environmental Sustainability (NRES), through the Malaysia Forest Fund (MFF) and in collaboration with the World Bank Group and Permian Malaysia organised the "ASEAN Carbon Forum 2024 -Development of Crediting Programme and Carbon Project" at Kuala Lumpur Convention Centre on 9 October 2024. The Forum, held in conjunction with the International Greentech & Eco Products Exhibition and Conference Malaysia 2024, aims to encourage discussions among policymakers and implementing agencies from ASEAN countries, particularly on the development of offsetting programmes and carbon crediting systems.

Mr Nik Nazmi bin Nik Ahmad, Minister of the Ministry of NRES officiated the event in the presence of Datuk Dr. Ching Too a/l Kim, Secretary General of the Ministry of NRES and Dato' Indera Mohd Ridza bin Awang, member of the MFF's Board of Trustee. In his opening speech, Mr Nik Nazmi shared that one of the strategies that the ASEAN region has outlined in its journey towards a low-carbon future focuses on establishing reliable and common standards, with priority in developing a viable carbon market. He added that the Ministry of NRES is evaluating the integration of a Carbon Pricing Instrument and developing the National Climate Change Bill, the National Carbon Market Policy, and through the MFF, the national carbon crediting system.

Dato' Indera welcomed representatives of ASEAN member states as well as heads of departments, agencies and statutory bodies to the forum, emphasising that its focus extends beyond the technicalities of carbon credit systems to address the broader challenge of transitioning to a sustainable future. He noted that Southeast Asia, one of the most climate-vulnerable regions, has the potential to harness carbon markets to not only reduce emissions but also spur economic growth, particularly in key sectors like agriculture and manufacturing. He further highlighted the crucial role of governments in establishing regulatory frameworks and fostering innovation to ensure In the dialogue session on "Carbon Crediting Systems and Offsetting Programmes: Supply and Demand", Mr Taisei Matsuki from the World Bank, advised the Malaysian government to target specific sectors for carbon pricing instruments and uphold high carbon credit integrity to draw investment. Madam Suhaini Haron, Senior Director from MFF highlighted that forest restoration and improved forest management can generate carbon credits if greenhouse gas reductions are effectively quantified. However, high costs, technical gaps, and data reliability pose challenges. To address these, MFF is conducting a feasibility study for a domestic carbon credit system focused on high integrity.

Dr. Ir. Syaiful Anwar, Senior Policy Analyst from Indonesia's Ministry of Environment and Forestry and Ms Sim Wi-Min, Director of Singapore's National Environment Agency discussed their nations' diverse climate policies. Dr. Ir. Syaiful emphasised Indonesia's national climate registry, while Ms Sim shared insights on Singapore's pioneering carbon tax legislation, aimed at guiding businesses toward low-carbon transitions. Ms Yap Mun Ching, Chairman of Malaysia's Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA), introduced the programme that was launched in 2017 by the International Civil Aviation Organisation to address cross-border aviation emissions with participation from ASEAN countries.

Dr. Wei-Nee Chen, Head of Bursa Carbon Exchange (BCX) presented the ASEAN Common Carbon Framework (ACCF), facilitating an interoperable carbon market across the region by 2025. She highlighted challenges on the supply side which included project bottlenecks under stringent standards, and demandside challenges such as market fragmentation and green washing concerns. She added that BCX is partnering with the World Bank to establish a compliant carbon market by 2025. She noted support from the Malaysia Carbon Market Association, which plans to collaborate with regional counterparts to enhance carbon market efforts.

In the subsequent sharing session, developers from Malaysia's Kuamut Rainforest Conservation and Indonesia's Cilacap Blue Carbon projects stressed the necessity of strong policy backing and expert project management to sustain carbon initiatives across ASEAN.

Meeting of the Technical Working Group for Forest Carbon Offset Guidelines

The Ministry of Natural Resources and Environmental Sustainability (NRES), through the Malaysia Forest Fund (MFF), is developing a national crediting system designed to align with Malaysia's unique environmental context while actively supporting the country's commitment to maintaining over 50% forest cover, alongside fulfilling the objectives of the National Policy on Biological Diversity and Malaysia's Nationally Determined Contributions.

Known as the Forest Carbon Offset (FCO), the initiative will facilitate the transfer of forest-based emissions reduction or removals to buyers in the form of carbon credits, enabling organisations to offset their carbon emissions. Following the conclusion of a feasibility study, a Technical Working Group (TWG) was established, comprising experts from government agencies, private sector, civil societies, non-governmental organisations and academia to provide insights and recommendations on the development of FCO guidelines. STA was also invited to participate as a TWG member, providing industry insights to help ensure effective guidelines that align with best practices.

The TWG held its inaugural hybrid meeting on 2 October 2024, chaired by Ms Suhaini Binti Haron, Senior Director of Corporate Development & Strategy at MFF. During the session, TWG members received overview of the draft guidelines prepared by MFF and were invited to review and contribute feedback to refine the guidelines further in preparation for the next meeting.




Second Project Steering Committee Meeting for ITTO-funded projects

The Second Project Steering Committee (PSC) Meeting for two (2) International Tropical Timber Organization (ITTO) projects was held on 10 October 2024 at the Pullman Hotel, Miri, Malaysia.

The two projects discussed were:

- i. PD902/19 Rev.3 (F) Management of the Upper Baram Forest Area (UBFA) for Conservation and Sustainable Development with Involvement of Local Communities, Upper Baram, Sarawak, Malaysia; and
- ii. PP-A/59-352 Community Empowerment in Forest Management and Forest Landscape Restoration in Upper Baram, Sarawak, Malaysia.



The meeting was co-chaired by Mr Semilan Ripot, Deputy Director of Forests, Forest Department Sarawak (FDS); Ms Sheam Executive Director Satkuru, of ITTO; and Mr Mazlan bin Othman, Senior Undersecretary of the Ministry of Plantation and Commodities. Representatives from the donor country, Japan, joined the meeting virtually, while various government agencies, local communities, non-governmental organisations (NGOs), and STA representatives attended in person.

A key development at the meeting was the formal request from the Sarawak Government, through the FDS, to terminate the first project (PD902/19 Rev.3 (F)), which had faced significant implementation challenges. These challenges included interference from both local and international NGOs, as well as evolving and conflicting aspirations among project stakeholders.

The project, which was approved by the International Tropical Timber Council (ITTC) during its 57th session in November–December 2021, officially commenced in September 2023. It was funded by the Government of Japan, the Bruno Manser Fonds (BMF), and the Canton of Basel, Switzerland. Ms Sheam acknowledged the request and emphasised that the termination process would be handled in accordance with ITTO's standard procedures.

Presentations were made by project leaders Madam Evelyn Jugi and Dr Alexander Kiew anak Sayok, who provided updates on the progress of both projects. They highlighted several successful outcomes, especially in terms of community empowerment and the promotion of sustainable forest management practices. Madam Evelyn Jugi shared examples of local community engagement, noting that community-based ecotourism training sessions had been conducted in Miri, which involved 39 participants from 19 villages. These sessions focused on building skills related to ecotourism and sustainable development. Additionally, she reported on capacity-building initiatives that included training in electric wiring, wood carpentry, and furniture fabrication.

She also highlighted the positive impact of a benchmarking visit to Koperasi Pelancongan Batu Putih in Kinabatangan, Sabah, and the Rainforest Discovery Centre, which provided valuable insights into best practices in ecotourism and forest conservation. Furthermore, she mentioned the completion of minor improvements to community infrastructure, contributing to the overall well-being of local residents.

The meeting also included a financial report for both projects, providing transparency on the use of funds and the ongoing financial management of the initiatives. Following the financial presentation, a question and answer session was held, allowing stakeholders to raise questions and share feedback.

Prior to the PSC meeting, a field visit was conducted from 7 to 9 October 2024 to Ba Data Bila village in Upper Baram, where project leaders and stakeholders met with local communities to discuss the impacts of the projects. During the visit, community members expressed their thoughts and feelings about the projects, offering valuable insights into the challenges and successes on the ground. The feedback gathered during this visit was important in shaping the discussions at the PSC meeting, ensuring that the voices of local communities were heard.

Workshop on the Formulation of Environmental Policy for Sarawak

The Sarawak Government, through the Natural Resources and Environment Board (NREB) is in the process of formulating an Environmental Policy for Sarawak. On 24 October 2024, Chemsain Konsultant Sdn Bhd, the appointed consultant for the underlying study, presented the draft policy to a diverse group of stakeholders at a workshop held at the Imperial Hotel, Kuching. The attendees included representatives from non-governmental organisations and private sector entities, offering a broad spectrum of perspectives on the draft policy. The workshop provided an essential platform for gathering feedback to refine the policy further, incorporating insights from civil society and key stakeholders

In his opening remarks, read by Mdm Rahmah binti Biak, Deputy Controller, Datu Jack anak Liam, the Controller of Environmental Quality Sarawak, underscored the importance of the workshop as a key milestone in the journey of finalising the policy. He emphasised that the policy's goal is to protect the environment and Sarawak's precious resources while driving sustainable economic development.

He highlighted that stakeholder input is vital to ensuring the policy is comprehensive, balanced and practical, reflecting not only the government's perspectives but also the views of the civil society and other key stakeholders. He further explained that the draft policy represents months of rigorous work by the NREB, involving extensive research and close collaboration with various ministries and agencies across Sarawak all focused on advancing our shared environmental priorities – ensuring clean air, water and soil, along with the preservation of biodiversity.

The draft policy presented at the workshop sets forth a strategic framework for balancing environmental preservation with sustainable development in Sarawak. Through the consultative process, the NREB aims to finalise a policy that genuinely addresses Sarawak's unique environmental challenges while aligning with its vision for long-term environmental sustainability. Kerajaan Sarawak, melalui Lembaga Sumber Asli dan Alam Sekitar (NREB) sedang menggubal Dasar Alam Sekitar untuk Sarawak. The briefing is part of MTIB's initiatives to disseminate information, with Mr Saiful asserting that promoting fair competition will ultimately benefit the timber industry. Mr Muhammad Syairazi bin Md Aliman, Assistant Director of the Policy and Communication Division at the Malaysia Competition Commission (MyCC), noted that MyCC, a statutory body under the Ministry of Domestic Trade and Cost

of Living, was established by the Competition Commission Act 2010 (Act 713) to enforce the CA 2010, which aims to enhance consumer welfare, promote fair business practices, and support economic development.

The Malaysian Timber Industry Board (MTIB) conducted a

He highlighted that fair competition compels to become more efficient, enterprises innovative, and responsive to consumer demand. The advantages include competitive pricing, improved products, wider choices for consumers, and enhanced overall efficiency in the economy. He further stressed that the CA 2010 is designed not to protect enterprises but to ensure that these entities compete freely and fairly. Additionally, CA 2010 does not apply to commercial activities regulated by the Communications and Multimedia Act 1998, the Energy Commission Act 2001, the Petroleum Development Act 1974, and the Malaysian Aviation Commission Act 2015. Lastly, he clarified that Anti-Competitive Agreements, which involve collusion among enterprises to avoid competition, need not be documented formally; such agreements can include informal, oral arrangements made in various settings, even simple understandings signified by a nod.

The briefing continued with a presentation by Mr Mohd Hasbullah Mohd Faudzi, Assistant Director and Head of the Investigation & Enforcement Division of MyCC. He explained that monopolies often arise when companies

with a deep understanding of market dynamics choose to manipulate the market, sometimes through cartels, which is a partnership among companies that conspire to control prices to their advantage.

Mr Mohd Hasbullah also shared several cases penalised under the CA 2010 and addressed common misconceptions. He clarified that MyCC does not function as a price control authority and emphasised that monopolies are not inherently illegal. He encouraged participants to reach out to MyCC for free consultations regarding any issues they may encounter.

Seminar on Environmental Management for Sustainability

In celebration of its 30th anniversary, the Natural Resources and Environment Board (NREB) hosted a seminar titled *"Environmental Management for Sustainability"* on 31 October 2024 at Imperial Hotel, Kuching. The seminar brought together over 150 participants from government agencies, NGOs, and the private sector, highlighting a shared commitment to advancing environmental stewardship.

In his welcoming remarks, Datu Jack anak Liam, Controller of Environmental Quality Sarawak, underscored the importance of collaborative action in addressing climate change. He noted that the seminar's theme, *"Mitigating Climate Change for a Clean and Green Sarawak,"* aims to deepen understanding of environmental management practices, promote dialogue across sectors, and reinforce a collective commitment to sustainability.

The seminar featured distinguished speakers, including Madam Kamisah binti Mohd Ghazali, Head of the Resilient Environment Division at Iskandar Regional Development Authority (IRDA), Johor who shared insights from Iskandar Malaysia's pioneering green initiatives, focusing on enhancing ecological resilience, promoting green mobility, and fostering a lowcarbon society. She highlighted the importance of capacity building, environmental education, and youth empowerment in creating a vibrant and sustainable community as part of Iskandar Malaysia's ongoing green transition.

Mr Ahmad Farid bin Mohammed, Deputy Undersecretary of the Climate Change Division at the Ministry of Natural Resources and Environmental Sustainability (NRES), outlined Malaysia's climate resilience strategy, emphasising initiatives in renewable energy, sustainable forestry, water and food security, and public health protections. He also introduced Malaysia's National Adaptation Plan (MyNAP) and the upcoming Climate Change Bill, expected in 2025, which will strengthen climate governance and lay the groundwork for a national carbon market policy.

At Sarawak's level, Dr. Kho Lip Khoon, Head of Corporate Development and Economy at the Ministry of Energy and Environmental Sustainability Sarawak, detailed Sarawak's ambitious goal to achieve net-zero carbon emissions by 2050. He also discussed the 2023 Environment (Reduction of Greenhouse Gases Emission) Ordinance, which regulates greenhouse gas emissions and supports carbon capture and trading initiatives.

Ir. Dr. Angelia Liew, Advisor (Climate Change, Energy and Sustainable Development) in the Department of the Premier of Sarawak introduced Public Sustainability Reporting (PSR) as a vital tool in Sarawak's green economy transition. She explained that PSR will enhance transparency, accountability, and data-informed decision-making across government agencies, aligning with international standards. It will also allow Sarawak to monitor its sustainability progress, attract green investments, and address challenges like data standardisation.

Adding to the discourse on sustainable solutions, Mr Stephen Chin, Group CEO of Trienekens (Malaysia) Sdn Bhd, explored Waste-to-Energy (WTE) technology as a critical component of sustainable waste management. He explained how WTE systems convert waste into energy, such as electricity and biofuels, supporting the shift to a circular economy and reducing landfill reliance.

A notable milestone of the event was the launch of the Environmental Impact Assessment Consultants Management System (EIACMS), designed to streamline environmental consultancy processes. This initiative represents a forward step in ensuring efficient, transparent, and effective environmental management in Sarawak.

Meeting of MEF East Malaysia Region Members No. 10/2024 - Key Changes to Malaysian Labour Laws 2024

The Malaysian Employers Federation (MEF) East Malaysia (Sarawak) Region convened its 10th meeting of the year on 28 October 2024, presided over by Mr Asarah bin Sahimun, Consultant-Industrial Relations of MEF Sabah. The online session focused on *"Key changes to Malaysian Labour Laws (Laws): Changes, Issues and Challenges in Employer-Employee Relations in Malaysia-Industrial Relations Act 2020"* presented by Dato' Hj Jalaldin bin Hj Hussain, Senior Principal Consultant-Industrial Relations at MEF.

The presentation highlighted the significant amendments to the laws i.e. Industrial Relations (Amendment) Act 2020, Trade Unions (Amendment) Act 2024, Industrial Relations Regulations 2024 and Trade Union Regulations 2024. Key points discussed were:

- i. Amendments to Part III of the Industrial Relations (Amendment) Act 2020;
- Changes to collective bargaining (CB) and collective agreement (CA), specifically Section 13(3);
- iii. Updates on references under Section 20;
- iv. Amendments regarding the powers of the Industrial Court under Section 29;
- v. Deletion of Section 33A concerning appeals to the High Court and Court of Appeal; and
- vi. Amendments to punishment provisions under Section 4.

Seminar Lembaga Sumber Asli dan Alam Sekitar bertajuk "Pengurusan Alam Sekitar untuk Kelestarian" menekankan kelestarian alam sekitar dan tindakan iklim. Penceramah menekankan matlamat bersih-sifar Sarawak, strategi ketahanan iklim Malaysia, dan inisiatif hijau Iskandar Malaysia. Acara juga menyaksikan pelancaran sistem Penilaian Kesan Alam Sekitar, bertujuan untuk menambah baik pengurusan alam sekitar dan menggalakkan ketelusan.

Dato' Hj Jalaldin informed that these amendments were gazetted by the Ministry of Human Resources on 15 September 2024 and aim to enhance the principles of freedom of association, CB and CA. He also acknowledged the challenges presented by the Industrial Relations Act, which has been in force since 1 January 2021. These challenges include the necessity for a thorough understanding of the amendments and their implications for human resource practitioners and companies, particularly regarding union recognition and the management of CB and CA. He emphasised that these complexities highlight the importance of MEF's membership, which provides assistance and support to members in navigating these issues together.

Foreign Workers Seminar: Economic Contributions and Security Threats

The Ministry of Home Affairs (MOHA) organised the Foreign Workers Seminar: Economic Contributions and Security Threats on 15 October 2024 at the Federal Government Administrative Centre, Putrajaya.

In his welcoming address, Mr Lokman Effendi bin Ramli, Chief Executive of Institute of Public Security of Malaysia (IPSOM), highlighted that the seminar aimed to assess the economic and security impacts of foreign workers in Malaysia and to disseminate information on foreign workers' policies to the non-governmental organisations (NGOs) and companies. He emphasised IPSOM's intention to leverage the seminar's outcomes to enhance collaboration among MOHA, relevant ministries, NGOs, and companies employing foreign workers.

In his inaugural speech, Mr Anuar Zaki bin Bakar, Secretary of Immigration Affairs MOHA, highlighted that contemporary Malaysia, as a rapidly developing nation in this 21st century, requires an influx of labour, including skilled, semi-skilled, and unskilled foreign workers, to support essential sectors such as agriculture, construction, and manufacturing and to drive the country's economic development. He added that while promoting economic growth, it is crucial not to overlook security and public order, especially considering data from the Immigration Department of Malaysia, which indicates that there are approximately 2.4 million active holders of temporary work visit passes, which warrants careful consideration.

Additionally, Mr Anuar highlighted the Malaysia Madani concept, under which MOHA has developed its Foreign Workers Management (FWM) policy based on four key principles, namely reducing migration costs, expediting the FWM process,

ensuring the welfare of foreign workers, and protecting the interests of all parties involved. In line with the Ministry's commitment to providing efficient services to the public and industry stakeholders, it has recently improved processing times for hiring foreign workers from about 29 months to about 15 months, while also re-establishing the One Stop Centre for FWM to streamline bureaucracy.

Moreover, MOHA acknowledged that numerous industries rely on foreign workers and reminded all parties that employing illegal immigrants, constitutes an offense under the Immigration Act. He concluded by expressing the hope that this program will serve as a platform for the exchange of information and recommendations regarding FWM policies that support economic growth while safeguarding national security.

The seminar featured presentations from Mr Ayub bin Abd Rahman from Immigration Department, Ms Nurul Aainaa binti Mohamed Nasir from Ministry of Economy, and Mr Azmi bin Yusof from Crime Investigation Department. They provided insights into the economic contributions of foreign workers, security threats, safety issues, and related crimes, with the goal of promoting effective management and balanced policies that maximize economic benefits in conjunction with protecting the safety and welfare of local communities.

The Ministry of International Trade, Industry, and Investment (MINTRED) Sarawak, in collaboration with the Ministry of Education, Innovation, and Talent Development Sarawak (MEITD), the Malaysia Productivity Corporation (MPC), and the Regional Corridor Development Authority (RECODA) organised Series 5 of the Industry Continuous Professional Development (iCPD) on 23 October 2024 at Imperial Hotel, Kuching.

The iCPD Series 5, launched by Dato Sri Roland Sagah Wee Inn, Minister for MEITD, served to assist the people of Sarawak in identifying relevant training courses that enhances their skills and knowledge, thereby improving their marketability and preparing them for long-term career success and employability opportunities. This initiative also aims to collect data on industry-specific skill requirements and strengthen collaboration between institutions and industry stakeholders in developing talent. Additionally, Dato Sri Roland witnessed the exchange of the Memorandum of Understanding between MEITD and MPC, which symbolises a commitment to advancing talent development and cultivating a skilled, competitive workforce for the future.

In her opening remarks, Dr Mazrina binti Mohamed Ibramsah, Deputy Director General of MPC, highlighted that the iCPD initiative aligns with the government's vision of fostering a competitive workforce capable of meeting industry demands as well as driving innovation and productivity, thereby steering Sarawak toward a more prosperous future.

Several speakers shared their knowledge and expertise with the participants. Ts Grenson Philip Angkok, Senior Assistant Director of Skills Development Department, provided an overview of the Malaysian Skills Certification System,

which is awarded through accredited training programmes that include apprenticeship training offered by various industries and institutions.

Mr Nickson Jampang, Associate-Stakeholder **Engagement of Human Resource Development** Corporation (HRD Corp), presented on the Industrial Training Scheme and HRD Corp Claimable Courses, outlining the training grant application process, which includes planning, applying, training, and claiming. Ms Nur Munirah binti Mustafa Kamal, Assistant Manager Talent Development Section & People Productivity Division of MPC outlined Academia in Industry Programme, which uses a place-and-train concept for local talent development through skills recognition.

Mr Abdul Hafidz Ali, Manager of Workforce Development at Sarawak Skills Kuching, presented on the Recognition Prior to Experiential Learning Programme, an assessment method that allows workers to receive official recognition for skills and experiences acquired through their work. Mr Larry Ong, Manager of Chemsain HRD Sdn Bhd, provided an overview of Chemsain's diverse business areas, which encompass environmental services. sustainability, occupational safety and health, monitoring, and drone technical services. Mr Chai Chong Foong, Head of Section, Investigation & Prosecution Section DOSH, also took the opportunity to present the guidelines for Occupational Safety and Health Coordinators in accordance with Section 29A of the Occupational Safety and Health Act 1994.

Capacity Building: Workshop on Strengthening Forest Management Certification

The Forest Department Sarawak (FDS), in collaboration with the Sarawak Timber Association (STA), successfully organised the Workshop on Strengthening Forest Management Certification for Natural Forests and Forest Plantations in two sessions—on 10-11 October 2024 at Mercure Miri City Centre and 17 October 2024 at Wisma STA, Kuching.

The capacity building workshops aimed to enhance participants' understanding of forest management certification processes and strengthen the implementation of Reduced Impact Logging (RIL) methods for sustainable forestry. The workshops brought together forestmanagers, government officials, and industry stakeholders to discuss key topics, including legal frameworks, management planning, harvesting operations, and social responsibility in the certification process.

Logging (RIL). This session underscored the significance of RIL guidelines, which are designed to reduce damage to residual stands, protecting biodiversity, and ensuring the long-term sustainability of forest ecosystems.

Additionally, the workshop in Miri covered critical legal obligations governing forest management, and economic aspects of forest management. The workshop also addressed the importance of social conflict resolution mechanisms and the Forests (Trained Workmen) Rules 2015, ensuring that forestry personnel are trained and equipped to manage forestry operations effectively.

By strengthening forest management practices and promoting responsible certification, this workshop marks an important step for capacity building towards ensuring the long-term sustainability of both natural forests and forest plantations in Sarawak.

A central focus of the workshops was the development of Forest Management Plans for natural and forest plantations, which are vital to achieving sustainable forest management and meeting certification standards. It emphasised on the importance of comprehensive management plans, covering key components such as management plan prescriptions, forest research, harvesting operation and impact assessments. These plans ensure responsible forestry operations while promoting environmental sustainability and social inclusion.

Another key highlight was the session on harvesting operations and Reduced Impact

Dialogue Session Between the Deputy Minister of Transport Malaysia and Sarawak Maritime Industry Players

The Ministry of Transport Sarawak (MOTS) and the Ministry of Transport Malaysia (MOT) coorganised a dialogue session on 11 October 2024 at the Sheraton Hotel in Kuching. Chaired by the Deputy Minister of Transport Malaysia, Datuk Haji Hasbi Bin Haji Habibollah, the dialogue session was attended by key stakeholders from Sarawak including STA.

In his welcoming remarks, Dato' Henry Harry Jinep, Deputy Minister of Transportation (Marine and Riverine) for Sarawak, underscored the maritime sector's vital role in connecting Sarawak with Peninsular Malaysia, particularly in transporting essential goods such as food, vehicles, and medicines. He noted that the liberalisation of the cabotage policy in 2017 failed to reduce prices, leading to its reinstatement to support local maritime growth and safeguard the domestic shipping industry in Sarawak. He also highlighted the Sarawak government's commitment to enhancing maritime infrastructure, particularly in shipbuilding and ship repair (SBSR), with 68 of Malaysia's 100 shipyards located in the region.

Datuk Haji Hasbi, in his opening remarks, reinforced the shipping and maritime sector's critical role Malaysia's economy, noting that 90% of trade activities are conducted via sea transport. He pointed out that Malaysia's fourth-place ranking in the Liner Shipping Connectivity Index among Asia Pacific countries, underlining the nation's readiness as a potential global shipping hub. The reinstated cabotage policy on 1 June 2024, aims to strengthen the local maritime sector and boost the SBSR industry, a vital contributor to Sarawak's economy, where approximately 80% of new ships are constructed.

The dialogue featured three presentations on the reinstatement of the cabotage policy, thirdparty marine liability insurance for non-convention vessels, and bunkering standard operating procedures. Perlindungan dan Indemniti Malaysia Sdn Bhd (P&I Malaysia) was introduced as a special purpose vehicle established to provide affordable marine liability insurance for small ship operators under 300GT. Additionally, applications for bunkering activities will be available online starting 1 November 2024 to streamline processes and reduce bureaucracy.

Stakeholders voiced concerns about high freight costs and inefficiencies stemming from the reinstated cabotage policy, citing issues like double handling and excessive shipping charges imposed by local companies that hinder competitiveness. There were urgent calls for infrastructure upgrades at Sarawak's ports to improve trade potential, emphasising the necessity for increased competition, improved facilities, and regulated shipping charges to support local industries.

In response to these challenges, both MOTS and MOT proposed a special technical session to engage various stakeholders in finding solutions.

Sarawak Timber Industry Demands Proof, Not Baseless Accusations

The Sarawak Timber Association (STA) is outraged by the recent unfounded allegations made in a report issued by Human Rights Watch and several Sarawak-based non-governmental organisations (NGOs) against the Sarawak timber industry.

They had alleged that Sarawak's millions of hectares of ancient rainforests are at risk of being razed for timber and oil palm plantations supplying international markets leading to deforestation and violations of Indigenous peoples' rights.

STA maintains that these claims are a blatant attempt to tarnish the reputation of an industry that has made significant strides in sustainable forest management (SFM).

Sarawak's commitment to SFM is evident through the State's stringent sustainable policies, conservation efforts, and community engagement initiatives, in collaboration with international bodies including the ITTO. Guided by these policies, the industry actively adopts certified practices, implements responsible harvesting methods, and invests in sustainable technologies, resulting in numerous certified Forest Management Units and adherence to international standards. We have also worked tirelessly to ensure free, prior, and informed consent (FPIC) from affected communities.

STA has always welcomed and consistently supported the NGOs as third-party observers to monitor the well-being of the industry. So why the sudden call for this damaging classification? Why should Sarawak be labelled as "high risk" due to one isolated incident? Have the NGOs engaged in dialogue with the Sarawak government and STA to make any effort to verify their claims before making sweeping allegations and demanding for Sarawak to be labelled as high risk over the whole industry? Is it not an unjust and vicious act to label the whole industry as high risk over one allegedly unjust act? If indeed proven to be so on the one specific incident, then punish that act accordingly not genocidally put everyone in the same cage.

STA urges the EU to at least conduct a full investigation into these allegations, involving all relevant stakeholders and determine whether the concerns raised are genuinely reflective of the industry at large. The future of Sarawak's timber industry, and the livelihoods of the thousands of people it supports, depends on a balanced and just decision, not one driven by isolated cases.

The Sarawak timber industry is a vital contributor to the nation's economy and the livelihoods of thousands of people. A hasty decision to label Sarawak as "high risk" based solely on unfounded allegations would be a grave injustice that could bring tremendous harm to Sarawak and the people's livelihood. Is this the modus operandi of the NGOs or is this what the NGOs want to see?
