

conjunction with In the Category and Committee meetings, a workshop was held to provide an avenue for Associate Professor Dr. Ho Wei Sena, Project Leader from University Malaysia Sarawak (UNIMAS) to share the historical development and progress of the Kelampayan projects funded by STA since 2013.

He also took the opportunity to provide guidance to interested

STA forest plantation members on the proper method of acclimatising Kelampayan seedlings at plantation nursery.

The Kelampayan seedlings are obtained from the selected candidate plus tree and mutant clones derived from the STA-funded R&D projects granted to UNIMAS, and are propagated using the bioreactor system procured with funding from STA R&D Funding.

Participants of the workshop also discussed on working plan to properly establish, manage and coordinate the Kelampayan field trials at STA member companies' areas.

Study Visit to the Institute of Forest Tree Improvement and Biotechnology in Vietnam

Datu Hamden Bin Haji Mohammad, Director of Forests, Forest Department Sarawak (FDS) recently led a 21-member delegation from FDS, Sarawak Timber Industry Development Corporation, Harwood Timber Sdn Bhd, Sarawak Planted Forest Sdn Bhd and STA on a study visit to the Institute of Forest Tree Improvement and Biotechnology (IFTIB) in Hanoi, Vietnam from 17 to 21 October 2022.

The 5-day visit was organised to (i) gain insight on the tree improvement programmes and research and development (R&D) management framework in Vietnam, (ii) observe the planted timber harvesting and processing system practised locally; and (iii) understand Vietnam's policy and mechanism on the participation of small holders in forest plantation.

The delegation was welcomed by Dr. Nguyen Duc Kien, Director of IFTIB who shared knowledge and experience on tree breeding and improvement programmes undertaken by IFTIB. Both parties also discussed forest plantation development in Vietnam and Sarawak, structure and operation of the Vietnamese Academy of Forests Sciences (VAFS) and its forest research institutes. Opportunities for research collaboration between FDS and IFTIB were also explored.

During the visit, Dr Kien accompanied and provided briefing to the delegation at every visiting location namely (i) research institutes and laboratories under VAFS at Yen District; (ii) *Acacia* polyploidy research plot, sawmill and veneer processing factories, smallholder *Eucalyptus* and *Acacia* plantations at Bac Giang City; and (iii) Centre for Experimental Breeding and Technology Transfer, IFTIB at Ba Vi District which includes visits to demonstration plots of *Acacia* hybrid and seed orchard of *Acacia auriculiformis*.

Following the successful visit, Datu Hamden agreed to form a working group on forest plantation R&D consisting of Sarawak forestry agencies and industry players including STA.

The working group will work closely to enhance and execute R&D planning and strategy for a better development of Sarawak forest plantation.

Workshop on *Acacia mangium* Plantations and Industries in Sarawak

STA, in collaboration with Forest Department Sarawak (FDS) organised a workshop on 13 October 2022 at Wisma STA, Kuching to gather data and information required by Fibre and Biocomposite Development Centre (FIDEC) for their study on *Acacia mangium* plantations and industries in Sarawak. FIDEC, a research unit of the Malaysian Timber Industry Board (MTIB), is carrying out the study to understand the process flow of *Acacia mangium* from plantation establishment to processing at mills as well as determine the potential and availability of *Acacia mangium* bark residues supply for tannin extraction at commercial level.

In her welcoming speech, Ms Annie Ting, Chief Executive Officer of STA informed that the Workshop is a continuation from the online briefing on the study given by FIDEC on 13 April 2022. She added that the Workshop also served as a platform to learn about the process flow from Acacia plantation harvesting to mill operations in Sarawak as well as experience

of bark tannin extraction in South Africa.

Ms Zarina in her opening speech hoped that a good way forward can be obtained from the Workshop and thanked the Licence for Planted Forests (LPF) holders for demonstrating full cooperation towards the study.

Approximately thirty (30) participants of the Workshop received a briefing on the study from Dr Yeoh Beng

Hoong, Deputy Director of FIDEC and benefitted from the sharing session presented by Mr Paul Valentine, General Manager of Sarawak Planted Forests Sdn Bhd; Mr Ling Tiing Tchin, General Manager of Zumida Sdn Bhd; Mr Francois Blignaut, Assistant General Manager (Reforestation) of Samling Reforestation (Bintulu) Sdn Bhd; and Mr Nicholas Andrew Lissem, Assistant General Manager of Sarawak Timber Industry Development Corporation.

Dr Yeoh then led a discussion on questionnaire prepared for the study and assisted representatives from relevant LPF companies present in filling up the questionnaire form. The Workshop also resolved to organise a field visit at the end of November 2022 for FIDEC to observe the best location for *Acacia* bark extraction along the harvesting operation and processing at mill.

STA Council Meeting No.5/2022

The STA Council for the term 2022 and 2023 held its inaugural meeting on 28 October 2022 via video conferencing since taking office on 30 September 2022. Dato Henry Lau, STA Chairman presided over the meeting which was attended by Honorary Secretary Mr Wong Ting Chung, Honorary Treasurer Mr Philip Choo and twenty four (24) members of the Council.

The Council put on record STA's appreciation to Dato Sri Wong Kie Yik, KBE for his dedicated long service to the Association over for the last seven (7) terms. He hoped that with the support of the members of the Council, the Association will continue to carry out its existing roles as well as to enhance its position in view of the changes of circumstances in the timber industry.

The Council respected Tan Sri Datuk Ling Chiong Ho's decision to decline his appointment as Vice Chairman for the term 2022 and 2023 and after some deliberation, the Council deferred the appointment of another Vice Chairman to the next Council meeting.

The Council deliberated extensively on the state of the timber industry in Sarawak as well as reviewed the roles of STA going forward. As the current economic situation is still very unpredictable and coupled with the lack of promising factors on the domestic front, the strength of recovery for the timber industry is highly uncertain. The Council therefore resolved that to waive the annual subscription payable by all members for all categories for year 2023.

The Council approved financial contribution amounting to RM100,000.00 to Polymore Timber Sdn Bhd for achieving forest management certification under the Malaysian Timber Certification Scheme in 38,984-hectare Segaham Forest Management Unit (FMU) on 4 October 2022. The financial contribution is given to STA members whose forest timber licence obtained the Malaysian Timber Certification Scheme or any recognised forest management certification schemes

As of 31 October 2022, there are sixteen (16) certified natural forests and six (6) certified forest plantations in Sarawak covering a total area of 1,481,122.35 hectares.

Workshop on Development and Assessment of Sustainable Livelihood Index for Forest-Dependent Communities in Sarawak

Forest Department Sarawak and Universiti Malaysia Sarawak (UNIMAS) are conducting a study to develop a sustainable livelihood index for forest-dependent communities in Sarawak. The objectives of the project are to carry out the study on the current practice on sustainable forest management in Sarawak focusing on the sustainable livelihood index; to formulate, develop and quantify the localised sustainable livelihood index for monitoring and improvement of forest dependent community in Sarawak; and to create a platform for knowledge transfer programme for and sustainable engagement among stakeholders.

A Workshop was held on 19 October 2022 at Hotel Maligai, Kapit to identify and develop suitable indicators as a follow-up consultation process to deliberate on the preliminary results obtained from the visits to sites consisting of several longhouses within Kapit division, which were conducted prior to this.

The Workshop was facilitated by Madam Evelyn Jugi and Dr Florianna Michael and attended by relevant Government agencies, communities, licensee holders and STA.

During the session, participants were divided into groups to discuss on the five indicators identified i.e economy, social, human, physical and natural.

The result of this study will provide insights of the livelihood sustainability and vulnerability in relation to their dependency on forest resources and the availability of alternative livelihood strategies. MIDA Engagement and Sharing Session

The Malaysian Investment Development Authority (MIDA) organised an engagement and sharing session on 21 October 2022 at its office in Kuala Lumpur which attracted physical attendance of 110 representatives and virtual participation from 600 representatives from chambers, trade association and private sectors throughout Malaysia.

Mr Sivasuriyamoorty Sundara Raja, Deputy Chief Executive Director, Investment Promotion and Facilitation, MIDA in his welcoming remarks shared that MIDA had, in 2013, carried out talent facilitation programme to create opportunities for the youth in meeting the demand for more skilled talent for the economy to move up the value chain.

He added that MIDA has been instrumental in generating high value employment opportunities for quality investment projects in the country through continuous collaborations with stakeholders from related government ministries, agencies and industries.

Ms Aziwati Ismail, Deputy Director, Industry Talent Management & Expatriate Division, MIDA spoke about job matching and information sharing sessions regularly carried out through the Industry Career Talk & Career Fair. She also highlighted on the Internship Facilitation, a programme aimed at ensuring continuous supply of skilled local talent to the industry by linking private companies with talents.

Participants were informed by Ms Afidah Mastor, Senior Deputy Director, Industry Talent Management & Expatriate Division of MIDA that in 2003, MIDA was mandated by the Government to evaluate the application for expatriate post in the manufacturing and services sectors. She further elaborated on

the scope, criteria and difference between key post and term post. While a key post can be held indefinitely by a foreigner, a term post is a post approved for a specific period of time and is subject to the unavailability of Malaysians to fill up the post.

Ms Kasthuri Bai Venugopal, Head of Immigration Office (Expatriate Division) in MIDA underlined the differences between approving agencies

and regulatory agencies in the expatriate application and the difficulty faced in obtaining employment pass is mainly due to delay in documentation process.

A number of issues were raised by participants in the engagement and sharing session such as delay in the application process, online application system that are not user friendly, inadequate services.

Webinar on Carbon Markets and Carbon Pricing Instruments

The Malaysian Sustainable Finance Initiative organised a webinar on *"Carbon Markets and Carbon Pricing Instruments"* on 27 October 2022 with the goal to further the understanding of Malaysian financial sector intermediaries on carbon markets and developments in carbon pricing instruments.

The line-up of speakers, consisting of professional experts in the field of carbon and sustainability who have been involved in discussions on green policies in Malaysia and climate change law in the European Union (EU) along with independent consultant responsible for developing opportunity for carbon related standards, attracted over 300 participants.

Ms Arina Kok, Partner in the Climate Change and Sustainability Services of Ernst & Young (EY) Consulting Sdn Bhd highlighted that carbon market and the ability to offset emissions is a vital part of realising the 2015 Paris Agreement's target of limiting the impact of climate change to 2 degree Celsius above pre-industrial level. 195 countries, including Malaysia are signatories to the Paris Agreement. She added that carbon market is expected to develop rapidly to support this commitment and there are four (4) different ways to decarbonise, namely science based targets, carbon neutral, carbon negative and net zero.

The role and contribution of carbon credits were also elaborated in her presentation with competitive advantage being one of the outcomes driving businesses towards low-emission efforts and solutions. She highlighted that Malaysia is set to launch Voluntary Carbon Market (VCM) exchange by the end of 2022 with Bursa Malaysia intending to offer standardised carbon credit products for trading via a rules-based VCM exchange. The supply of carbon credits is to be sold by way of auction to interested buyers.

Ms Kasia Klaczyńska, Leader of EY EU Green Deal, Centre of Excellence and EY Centre for Climate Policy introduced how carbon pricing can be structured and roles that financial institutions play in carbon markets. It was learned that financial institutions can act as a provider of capital for decarbonisation projects, market maker, trader or investor in voluntary carbon projects.

Mr Andrew Howard, Senior Director, Climate Policy and Strategy at Verra helped participants understand the carbon verification standard.

Verra is an independent, non-profit organisation that develops and manages standards to help private sector and countries achieve ambitious sustainable development and climate action goals. One of the standards developed at Verra is the Verified Carbon Standard (VCS) Programme, world-leading greenhouse gas (GHG) crediting programme, which allows certified projects to turn their GHG emission reductions and removals into tradable carbon credits.

He added that companies move into carbon crediting projects to, among many others, supplement work on their own climate footprints, drive finance into effective climate action in host countries and add benefits to communities, biodiversity and sustainable development. Under the VCS Program, the Verified Carbon Units (VCUs) issued are real, measurable, independently verified and uniquely numbered.

Inisiatif Kewangan Mampan Malaysia telah menganjurkan webinar *"Pasaran Karbon dan Instrumen Penetapan Harga Karbon"* pada 27 Oktober 2022 untuk mendalami perantara sektor kewangan Malaysia mengenai pasaran karbon dan perkembangan dalam instrumen penetapan harga karbon. Perkongsian oleh pakar-pakar profesional membantu peserta memahami pertumbuhan pasaran karbon global, implikasi instrumen harga dan piawaian pengesahan karbon.

Debriefing Session on European Union Deforestation-Free Products Regulation (EUDR)

The European Union Deforestation-Free Products Regulation (EUDR) was announced in November 2021 by the European Commission (EC) in its effort to minimise consumption of products coming from supply chains associated with deforestation or forest degradation.

The new Regulation includes a much wider range of impact commodities, namely soy, beef, palm oil, wood, cocoa and coffee and is set to replace existing European Union Timber Regulation.

In addition to that, the definition of deforestationfree sets a cut-off date of 31 December 2020 which means that no commodities and products in the scope of the Regulation would be allowed to enter or exit the EU market if they are produced on land subject to deforestation or forest degradation after that date.

In early September 2022, a delegation of six (6) members from Malaysian Timber Council (MTC) and Malaysia Timber Association (MTA) comprising Mr Goh Chee Yew, President of MTA; Mr Yong Teng Koon, Consultant of MTA; Ms Noraihan Abdul Rahman, Chief Operations Officer of MTC; Ms Aimi Lee Abdullah, MTC's Advisor on Sustainability Issues; Ms Pang Suet Kum, Senior Executive Officer of Malaysian Wood Industries Association, and Mr Gopinathan Tanikudy, MTC Europe Regional Head engaged with selected European Union (EU) members of the Parliament and relevant stakeholders in Europe in a bid to better understand the EUDR.

Following the visit by MTC and MTA delegation to Europe on EUDR, a debriefing session was held on 14 October 2022 to share key findings from the visit. The session was attended by over 70 participants both physical and online.

Ts. Haji Muhtar Suhaili, Chief Executive Officer of MTC, stated in his welcoming remarks that Malaysia regards EU as an important market and MTC has, since the proposed Regulation was announced, organised several engagement session with stakeholders from all three (3) regions of Malaysia impacted by the Regulation as well as with representatives from the EC.

He also disclosed that a position paper to express the Malaysian timber industry's view on EUDR, signed by MTA members and MTC, had been

presented to the Ministry of Plantation Industries and Commodities.

This was followed by a presentation from Mr Goh who introduced the EUDR, highlighted Malaysia's export of timber products to Europe, the institutional structure of the EU as well as way forward and recommendations.

In the discussion that ensued, it was shared that the cut-off date was revised to 31 December 2019 and the EC has introduced much stricter requirements into the proposed Regulation, particularly on native customary rights, workers' rights as well as free, prior and informed consent.

Some possible implications arising from the EUDR were also highlighted and while every effort should be taken to meet the requirement, there is a growing concern that social and environmental barriers are being created in export.

STA took part in the Malaysia Wood Processing and Furniture Production Machinery Exhibition (FPM) 2022 from 6 to 9 October 2022 at Setia City Convention Centre (SCCC), Shah Alam, Selangor. The biennial event was organised by Malaysian Woodworking and Machinery Association (MWMA) in collaboration with Expoworks Sdn Bhd.

Themed "One stop to optimise profitability for wood and furniture production", the event served as a platform for industry players from the furniture, wood and woodworking business to connect, exchange views and showcase new innovations.

The opening ceremony was officiated by Dato' Sri Dr. Wee Jeck Seng, Deputy Minister in the Ministry of Plantation Industries and Commodities (MPIC) who shared his hope for new opportunities to emerge from the exhibition as the timber industry builds its resilience, in line with the National Agricommodity Policy (DAKN) 2021-2030.

Workshop on the Revision of Malaysian Standard (MS) 1714 by Working Group of Visual Strength Grading

Members of the Working Group (WG) under Technical Committee (TC) 1 – Timber met on 31 October 2022 at Department of Standards Malaysia (DSM), Cyberjaya to review the proposed amendments to Malaysian Standard (MS) 1714 – Specification for Visual Strength Grading of Tropical Hardwood Timber.

The Workshop, chaired by Dr Mohd Nor Zamri Mat Amin, Director of Industry Development, Malaysian Timber Industry Board (MTIB), discussed and deliberated on comments/suggestions made during the previous workshop held in November 2019 by TC/V/1 – Timber. The WG reviewed the whole content of the standard and was informed that the MS 1714 shall apply to tropical hardwood timber graded in Malaysia and abroad for seasoned timber either rough sawn or dressed, preservative treated or untreated. A few recommendations were put forward by the WG, one of which is for the DSM to extend the review period of MS 1714 at a maximum allowable period of one-year.
