STA Council Meeting No. 3/2024

The STA Council for the term 2024 and 2025 convened for its inaugural meeting on 6 September 2024 at Wisma STA Kuching. The session, presided over by Dato Henry Lau Lee Kong, Chairman, was attended by Honorary Secretary Mr Wong Ting Chung, Honorary Treasurer Mr Philip Choo, and seventeen other Council members.

The Council received comprehensive updates from various Category and Working Committees, along with reports on the progress of industrial tree plantation research projects funded by STA. One of the key highlights is the proposed an outreach programme in Sibu and Bintulu, to be conducted with Sarawak Timber Industry Development Corporation. This initiative aims to engage plywood manufacturers, provide update on the latest government regulations and market requirements, and gather valuable feedback for future improvements.

Looking ahead, the Council discussed two important capacity-building initiatives in collaboration with the Forest Department Sarawak. The first, a Reduced Impact Logging (RIL) and Forest Management Plan (FMP) Training, is scheduled in October 2024 in Miri and Kuching. This training will focus on preparing comprehensive FMPs for both natural and industrial forest plantations and will address RIL practices according to the RIL Guidelines for Ground-based Timber Harvesting in Sarawak.

The second initiative, the Biodiversity Observation for Land and Ecosystem Health (BOLEH) Workshop and Technical Training, will take place

from in November 2024. This workshop aims to provide in-depth training on the BOLEH method, a cost-effective tool for monitoring carbon and biodiversity within forest management units. The BOLEH method, successfully implemented in other regions, offers a quantitative assessment of ecosystem health and biodiversity at the landscape level.

Meetings of STA Subsidiary Companies

The Boards of Directors of STA subsidiary companies, namely STA Training Sdn Bhd (STAT) and STA Enterprises Sdn Bhd (STAE) held their respective meetings on 2 September 2024. These meetings presided over by Dato Henry Lau Lee Kong, Chairman and conducted via video conferencing are summarised as follows:

STAT

The STAT Board of Directors had convened its 2nd Meeting virtually this year on 2 September 2024. The Directors deliberated and approved various items pertaining to the training courses and administrative matters. From 1 March 2024 and 31 August 2024, a total of 30 workmen in 5 prescribed forestry activities (PFA) and 75 in non-PFA were trained and found competent.

The Board was also informed on the appointment of STAT as training provider by the Natural Resources and Environment Board (NREB) to conduct Environmental Compliance Audit Training and Environmental Quality Monitoring (EQM) Training. Since then, STAT had conducted two (2) ECA Trainings and two (2) EQM

trainings with total of 111 participants. The Boards also noted that in order to enable reappointment of Honorary Wild Life Ranger within STA members companies, STAT is partnering with the Sarawak Forestry Corporation and Forest Department Sarawak to conduct Honorary Wild Life Ranger (Reappointment) Training in near future.

Besides that, the Board had also revised the course fees for members from RM750.00 to RM1,200.00 per day per skills set starting 1 January 2025. However, the course fees for non-member which include contractors

and sub-contractors of members will remain at RM1,500.00 per day per skills set. Both course fees and travel expenses are claimable under the HRD Corp Claimable Course Scheme for registered employers who contributed to the fund. Additionally, the meeting was also informed that the integration of FDS Systems (REVLOG and Licensee Portal) with STAT Database is currently in the final stages and is expected to be operational by the end of 2024. All future training nominations will be processed via the portal.

STAE

The STAE BOD Meeting No. 2/2024 endorsed and deliberated various financial and administrative matters which related to building operation and maintenance as well as the tenancy of Wisma STA.

Engagement Session with Asia Pacific Resources International Limited (APRIL) Group

STA organised an Engagement Session with Asia Pacific Resources International Limited (APRIL) Group for its forest plantation members on 27 September 2024 in Wisma STA, Kuching. The session served as a platform for exploring the collaboration opportunities between APRIL Group and holders of License for Planted Forests in Sarawak.

Ms Annie Ting, Chief Executive Officer of STA welcomed the APRIL Group, led by Mr Sihol Parulian Aritonang, President Director of PT Riau Andalan Pulp and Paper. In her welcoming remarks, Ms Ting briefly introduced the functions and roles of STA, expressing her hope that the session would be productive. She emphasised that this initiative has the potential to enhance the

sustainable development of the industrial forest plantations in member companies.

Meanwhile, Mr. Sihol provided an overview of the company's background and its commitment to creating a positive impact on the climate, nature and communities while pursuing sustainable business growth. Key highlights included their collaborative natural climate solution project, the Sustainable Forest Management Policy 2.0, operational system, productivity enhancement, and research and development in industrial forest plantations.

During the session, both parties exchanged insights and engaged in discussions about the collaborative proposal.

Webinar on e-Invoicing

PricewaterhouseCoopers (PwC) Malaysia organised a complimentary e-Invoicing webinar on 26 September 2024. The webinar was conducted by two (2) speakers, Mr Lavindran Sandragasu, Tax Partner and Mr Mohd Haizam Abdul Aziz, Tax Director.

The speakers discussed the benefits and challenges faced by the companies under Phase 1 of e-Invoicing, which began on 1 August 2024. They highlighted that the government has granted a six-month grace period for taxpayers following the mandatory implementation date, allowing them to issue consolidated e-Invoices.

PwC's team of experienced consultants is available to assist with e-Invoicing implementation, helping businesses navigate the transition smoothly. They can provide insights into e-Invoicing operations, processes, and system capabilities.

Global Legal and Sustainable Timber Forum (GLSTF) 2024

The Global Legal and Sustainable Timber Forum (GLSTF) 2024, co-hosted by the International Tropical Timber Organization and the Commerce and Investment Promotion Institute of the Macao SAR, and organised by the Secretariat of the Global Green Supply Chains Initiative, was held from 11 to 12 September 2024 at the MGM COTAI, Macao SAR, China.

The GLSTF 2024 aimed to enhance networking, collaboration and business exchange among timber industry stakeholders, namely producers, buyers, processors and market players. The goal was to strengthen support for sustainable forest management, and the uptake of legal and sustainable wood product supply chains. This, in turn, would facilitate the legal and sustainable use and trade of wood products while contributing to sustainable development and climate-change mitigation.

With the theme "*Together towards reliable and effective global timber supply chains*", GLSTF 2024 attracted approximately 700 guests from over 40 countries and regions, including representatives from international organisations, national governments and timber industry associations and enterprises.

The Malaysian delegation, led by Mr Mazlan Othman, Senior Undersecretary of the Timber, Tobacco and Kenaf Industries Development Division, Ministry of Plantation and Commodities, consists of 13 members which included representatives from the Malaysian Timber Council, Forestry Department of Peninsular Malaysia, Sabah Forestry Department, Sabah Timber Industries Association and Sarawak Timber Association.



The two-day event included a high-level segment discussion, a main forum, four specialised subforums and several side events, as well as a business matching session. A diverse array of significant topics were covered, including new timber trade requirements and regulations, precise supply and demand alignment, market-facilitating measures. trans-boundary collaboration, advanced technologies and equipment as well as green finance. Additionally, Malaysia participated in the forum exhibition, showcasing its forest monitoring and management digitalisation systems alongside a selection of Malaysian timber products.

During the forum, two research collaboration outcomes and three action plans for multinational cooperation were announced, all aimed at enhancing international collaboration in legal and sustainable timber supply chains. Notably, the full operation of the Global Timber Index (GTI) Platform was revealed, with Malaysia participating as one of the pilot countries. The GTI Platform is designed to facilitate the exchange of information and data related to the timber trade, fostering collaboration among stakeholders in a stable, transparent and predictable business environment. This initiative is a crucial step toward building legal and sustainable forest product supply chains.

Ms Annie Ting, Chief Executive Officer of STA was also invited as one of the speakers in the panel discussion at Specialised Sub-Forum 4: Green Finance and Innovative Facilitating Measures for Green Supply Chains – New Financial Opportunities in Forest Sustainability. The session delved into the current landscape of global forestry investment, emphasising the importance of green finance as a pivotal tool for optimising resource allocation. It highlighted various international models and experiences in green forestry finance, underscoring common

challenges in market financing, such as limited access to capital and environmental regulations challenges. Ms Ting emphasised that effective green finance can significantly promote forest conservation and sustainable management practices by incentivising investments in ecofriendly initiatives and fostering collaboration between stakeholders.

Her insights offered a forward-looking perspective on how integrating financial strategies with environmental goals can lead to healthier forests and communities.

In addition, Ms Ting also shared her insights during a side event titled "She" Power: The Roundtable Dialogue on Forests for Sustainable Development. The dialogue provided a platform for sharing the achievements and experiences of women within and beyond industries in the process of realising the Sustainable Development Goals. The conversation underscored the essential connection between love - whether for family, career or the environment - and sustainability. Ms Ting emphasised that love is a powerful motivating force for environmental protection and community engagement. She also addressed the significant challenges women face in their pursuit of gender equality, while recognising the strengths they bring to the table.

Technical Training under STA-Funded Scale-Up Production of Kelampayan Research Project

In 2021, STA funded the Scale-Up Production of the Kelampayan Research Project conducted by Universiti Malaysia Sarawak (UNIMAS). The project aimed to establish an optimal protocol for mass-producing Kelampayan planting materials using the innovative temporary immersion bioreactor (TIB) technology.

Upon completion of the project, a technical training session was held on 26 September 2024 at the Forest Genomics and Informatics Laboratory, Faculty of Resource Science and Technology, UNIMAS. This session presented the protocol for effectively using the TIB to propagate Kelampayan planting materials.

Attendees included Dr. Roger James Arnold, Manager (Research) at Samling Reforestation (Bintulu) Sdn Bhd, Dr. Arno Brune, Senior Forest Geneticist at GP Pusaka Sdn Bhd, and staff from the STA Secretariat. The training was led by the project's Principal Investigator, Assoc. Prof. Dr. Ho Wei Seng, alongside his research team.

24th Tri-Nation Joint Meeting of JLIA, JPMA, APKINDO, MPMA, STIA & STA

The 24th Tri-Nation Joint Meeting of Japan Lumber Importers' Association (JLIA), Japan Plywood Manufacturers' Association (JPMA), Asosiasi Panel Kayu Indonesia (APKINDO), The Malaysian Panel-Products Manufacturers' Association (MPMA), Sabah Timber Industries Association (STIA) and Sarawak Timber Association (STA) was held on 17 September 2024 at Park Royal Hotel, Tokyo, Japan.

A total of fifty-four (54) participants, led by their respective heads of delegation comprising Mr Hiroshi Sekino, Chairman of JLIA; Mr Atsuhiro Inoue, Chairman of JPMA; Mr Gunawan Salim, Board Member of APKINDO; and Mr Vincent Chieng, Honorary Secretary of STA's Panel Products Committee, gathered to deliberate on the supply and current market situation of plywood in Japan, Indonesia and Malaysia.

In their opening remarks, all heads of delegation emphasised the mounting challenges posed by geopolitical risks, economic uncertainty, high inflation, logistical issues, and the rapid depreciation of currencies. These factors have had profound effects on financial stability and introduced significant insecurity into economic activities across the region. During the Joint Meeting, country-specific market reports were presented by STA, APKINDO and JLIA which included an analysis of several plywood products in Japan.

Key issues discussed during the meeting included global environmental agenda such as sustainability, timber legality and traceability, the shift from hardwood to softwood and plantation species, and increasing competition for logs used in the production of other products such as MDF and chipboard. Trends in plywood supply and usage in Japan were also reviewed. Additionally, JLIA highlighted Japan's close monitoring of the upcoming European Union Deforestationfree Regulation and Malaysia how and Indonesia plan to respond when the regulation takes effect on 1 January 2025. JLIA also acknowledged the importance of industry durina cooperation the review process of Japan's Clean Wood Act, which occurs every three (3) years.

Mr Sekino concluded that the meeting by noting the challenges currently facing Japan's housing market. He commended Malaysia and Indonesia for their firm stance on the importance of using timber and expressed gratitude for the high regard both countries place on tropical timber. He called for continued collaboration to promote the sustainable use of tropical timber across the region. It was also decided that STA will host next year's meeting in Malaysia.

Presentation of Interim II Report for the Study on Integrated River Basin Management Plan for Batang Saribas Basin

The Department of Irrigation and Drainage, Malaysia (DID Malaysia) commissioned consultant, O.B.E Consulting Sdn Bhd to undertake a study on the Integrated River Basin Management (IRBM) plan for Batang Saribas Basin. The goal of this initiative is to develop an IRBM plan that ensures sufficient and clean water, reduces flood risk and promotes environmental conservation.

On 10 September 2024, stakeholders gathered at the DID Sarawak office to receive updates on the study's progress. The consultant team provided a detailed analysis of the data collected, addressing key issues related to land use, socioeconomic factors, engineering challenges as well as environmental aspects.

The study further emphasised the importance of ongoing collaboration between the Natural Resources and Environment Board (NREB) and the STA in supporting the transition from conventional regulatory requirement towards self-regulated

Discussion Session on the Operations of the 2024 Agricultural Census: Forestry and Logging Cluster

The Department of Statistics Malaysia is currently conducting the 2024 Agricultural Census, which encompasses all agricultural activities, including forestry and logging. A Discussion Session on the Operations of the 2024 Agricultural Census: Forestry and Logging Cluster was held online on 6 September 2024. The session was led by Mr Syed Ibrahim Mohd Jamaluddin, Head Assistant Director of the Agricultural and Environmental Statistics Division (BPPAS), and attended by officers from the Forest Department Sarawak and STA.

Mr Syed Ibrahim provided an overview of the 2024 Agricultural Census, explaining its purpose in obtaining a comprehensive structure and characteristics of the agricultural sector. This information will serve as a key input for formulating agricultural policies by various stakeholders. He also outlined the key compliance in the forestry sector. The joint ECA training sessions conducted by NREB and STA were also recognised as vital in supporting the effective implementation of the Natural Resources and Environment (Audit) Rules, 2008, marking a significant step toward improving regulatory compliance and environmental accountability in the forestry sector.

Focus Group Discussion Workshop on European Union Regulation on Deforestation-free Products (EUDR) in Rubber and Timber for Sabah and Sarawak

The European Union (EU) Delegation in Malaysia and Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) organised a Focus Group Discussion Workshop on EU Regulation on Deforestation-free Products (EUDR) in Rubber and Timber for Sabah and Sarawak on 19 September 2024 at Hilton Kota Kinabalu, Sabah. Ms Nadirah Abdul Manaf from GIZ discussed the EUDR, which aims to minimise the EU's role in global deforestation and forest degradation, thereby reducing greenhouse gas emissions and protecting biodiversity. The specific goals include lowering the risk of products linked to deforestation from entering the EU market and promoting the trade of legal and "deforestationfree" commodities.

She highlighted that the regulation focuses on commodities selected as of 31 December 2020, and outlined key elements related to deforestation-free requirements. She also mentioned that a Frequently Asked Questions document will be released in the coming weeks. The EU is currently developing Guidance Documents on technical legal matters and establishing an information technology system for risk benchmarking. Additionally, she pointed out that the EU Observatory on Deforestation is nonmandatory and non-exclusive. It is provided free of charge by the Commission as a useful but nonlegally binding tool. The participants received updates from representatives of the Malaysian Rubber Processors Association (MRPA) and the Sabah and Sarawak Forest Departments. Mr Semilan Ripot, Deputy Director of Forests, Sarawak discussed Sarawak's readiness for the traceability and geolocation requirements of the EUDR through the Sarawak Timber Legality Verification System (STLVS). He introduced STLVS and the Sarawak Logs Tracking and Forest Revenue System (REVLOG), sharing that data from REVLOG is directly integrated into the Enterprise Forest Information Management System, which is used for geo-visualisation of photos, remote sensing imagery, and GIS layers to enhance the detection of illegal logging and land-use changes. He mentioned that their system is undergoing upgrades, including indexing timber names to a four-letter code, creating a geolocation map, and implementing a digital ePass.

Mr Indra Purwandita, Deputy Chief Conservator of Forests, Sabah, shared information on Sabah's forest resources and the sustainable forest management policy adopted in 1997, which transformed the forest management landscape in Sabah from a focus on timber to multiple-use forest management. He discussed the Sabah Timber Legality Assurance System, which has been mandatory since 2009, and Sabah's commitment to the EUDR. The Sabah TLAS



aligns with the EUDR by incorporating additional key certification elements such as sustainability, environmental protection, and social benefits for workers and local communities.

The session ended with a Question and Answer session for the participants. Delegasi Kesatuan Eropah (EU) di Malaysia dan Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) telah mengadakan Bengkel Perbincangan Kumpulan Fokus mengenai Peraturan EU tentang Produk Bebas Penyahutanan (EUDR) untuk Getah dan Kayu di Sabah dan Sarawak pada 19 September 2024. Cik Nadirah Abdul Manaf daripada GIZ menggariskan matlamat peraturan itu, termasuk mengurangkan peranan EU dalam penyahutanan global dan mempromosi komoditi "bebas penyahutanan", manakala wakil daripada Persatuan Pemprosesan Getah Malaysia serta Jabatan Hutan Sabah dan Sarawak berkongsi perkembangan mengenai sistem kebolehkesanan dan dasar pengurusan hutan lestari yang selaras dengan EUDR.

HCV Programme Update by WWF-Malaysia to FDS and STA

WWF-Malaysia Sarawak organised a meeting on 24 September 2024 at Bangunan Baitulmakmur, Kuching to update stakeholders on the High Conservation Value (HCV) programme. The meeting was chaired by Mr Ricky Jonathan, Assistant Director of Forests and attended by representatives from WWF-Malaysia, Forest Department Sarawak (FDS) and STA.

Ms Esther Mawan, HCV Programme Manager for WWF-Malaysia Sarawak, presented an overview of the programme's activities over the past five years. Key initiatives included conducting HCV screenings for Permanent Forest Estates (PFEs) in Sarawak, providing training for High Conservation Value - High Carbon Stock Approach (HCV-HCSA) Assessors, and developing resources such as the HCV Training Module book. Additionally, a Technical Guide for Monitoring Wildlife Populations was developed in collaboration with the Wildlife Conservation team.

Recent workshops on HCV screening for PFEs produced valuable results shared with all

stakeholders, including STA, by the HCV Resource Network. Discussions focused on improving access to this crucial database to facilitate effective HCV management and monitoring.

Participants also explored potential enhancements to database accessibility and other aspects of the HCV programme in collaboration with the FDS. Furthermore, the possibility of conducting a second cohort of HCV-HCSA Assessor Training to bolster capacity building as well as facilitate collaboration on carbon-related activities was also discussed.

Briefing on Documentation Development Incentive Programme under MTIB CB Certification Scheme

The Malaysian Timber Industry Board (MTIB) Puan Syafinaz Abd Rashad, Deputy Director Certification Body (CB) organised a hybrid briefing with the Sarawak Timber Industry Development Corporation and STA at Wisma STA, Kuching on 10 September 2024. The briefing aimed to explain MTIB CB's role and the incentives available to manufacturers for developing documentation based on MTIB CB Standard Product requirements.

MTIB CB outlined the body's roles and functions as mandated under MTIB Act 105. Established in 2010, MTIB CB provides recognition for the Timber Product Quality Assurance Scheme. She explained that the body is responsible for developing and implementing a timber product certification scheme, evaluating and certifying companies that meet established standards and specifications. The primary objectives are to assist the local industry in fulfilling quality assurance requirements, ensuring consistent product quality and guaranteeing that the certification process adheres to the developed standards for consumer safety.

Currently, MTIB CB oversees two product standards: the Plywood Certification Standard (MTIB-CB-PS-01), which outlines requirements for various plywood types, and the Formaldehyde Emission from Wood-Based Panel Standard (MTIB-CB-PS-02), specifying acceptable emission levels for wood-based products. Puan Syafinaz noted that the certification process spans two years and involves assessments, sampling, and audits, with fees ranging from RM10,000 to RM15,000 per standard.

Encik Abdul Razak Abu Bakar, Managing Director/Lead Consultant of QTC Management Consultant Sdn Bhd, explained the key requirements of both standards and how QTC supports manufacturers in meeting certification criteria. He encouraged manufacturers to apply for MTIB product certification, assuring that once applications are approved, associated fees for training and consulting provided by QTC would be fully funded by MTIB CB.

STIDC Industry Update


The Sarawak Timber Industry Development Corporation (STIDC) organised a series of industry update programme in Kuching, Miri, Bintulu and Sibu in September 2024 to inform the timber industry about its newly developed Sarawak Timber Regulatory & Compliance System (TRACE) and enhancements to the current ePermit system. The update session in Kuching took place on 11 September 2024 at STIDC headquarters Kuching saw an overwhelming turnout of 107 participants.

In his opening remarks, Tuan Haji Zainal Abidin Bin Haji Abdullah, General Manager of STIDC highlighted the importance of leveraging digital technology to drive continuous improvement in the timber industry, transitioning from manual processes to web-based system. He added that these updates and new systems aims to enhance efficiency and transparency in service delivery.

Mr Afizulmizam Bin Afandi, Manager - Licensing of STIDC provided an overview of the system's evolution, from the certificate of registration issued in 1983 to the current TRACE, which facilitates the issuance of Timber Industry Licence (Importer, Exporter, Local Trader, Manufacturer) under Section 5A of the STIDC Ordinance 1973 (Amendment 2022). He introduced the new Timber Industry Licence format and its terms and conditions.

Mr Redzuan Bin Khamis of Dagang Net Technologies Sdn Bhd updated participants on the evolution of Timber Licence Application Systems; outlining enhancement to the new ePermit system and the physical inspection module, including process flows for import/export permit. His presentation featured a pictorial walkthrough of TRACE, the new ePermit System and the physical inspection module.

TRACE integrates the Export, Import, Local Trader and Manufacturer Licences, transitioning from semi-automated processes to fully digital environment. It offers a user-friendly interface that adjusts to various devices such as smartphones, tablets and desktops. TRACE is expected to go live in October 2024.

Key Changes to Malaysian Labour Laws 2024

The Malaysian Employers Federation Academy hosted a webinar on the Key Changes to Malaysian Labour Laws 2024 on 10 September 2024. The session provided an in-depth overview of substantial revisions affecting employer-employee relations, attended by 25 participants including human resources practitioners, industrial relations practitioners and department heads. The objectives were to equip participants with the knowledge and skills needed to implement these significant changes and to guide them in updating workplace policies in accordance with the new regulations.

Datuk Hj Shamsuddin Bardan, Executive Director of MEF kicked off the webinar with a presentation on "*Modernisation of Labour Laws in Malaysia*". He highlighted Malaysia's ambition to become the 30th largest economy by 2030, discussing strategies to attract high-value investors and improve workforce participation, particularly among women. He also touched on the challenges of reducing reliance on migrant workers by encouraging local employment and integrating senior citizens into the workforce. The upcoming October 2024 budget is expected to further address these employment issues.

This 1-day event delved into modernising Malaysia's labour laws to align with the international standards set by the International Labour Organization as well as enhancing compliance for labour efficiency and productivity. These revisions build on the initiatives from the 11th Malaysia Plan and continue into the 12th Malaysia Plan.

Five speakers dived deep into recent amendments to key legislations such as Employment Act 1955, Trade Union Act 1959, Industrial Relations Act 1967, and Occupational Safety and Health Act 1994. Notable changes to the Employment Act 1955 include new provisions for flexible working arrangements and enhanced measures to combat workplace harassment. Key amendments to the Industrial Relations Act 1967 simplify trade union recognition and collective bargaining

processes, introducing secret ballots for union recognition and allowing multiple trade unions within a single company. Changes to the Trade Union Act 1959 aim to strengthen workers' rights and improve transparency in union operations, with expanded oversight powers granted to the Director-General of Trade Unions.

These amendments aim not only to comply with international trade agreements, such as the Comprehensive and Progressive Agreement for Trans-Pacific Partnership, but also to foster a more equitable and safe working environment for all employees.

Pada 10 September 2024, Akademi Persekutuan Majikan-Majikan Malaysia menganjurkan webinar mengenai Perubahan Utama kepada Undang-undang Buruh Malaysia 2024 untuk melengkapkan peserta dengan pengetahuan tentang semakan perundangan yang penting, termasuk kemas kini kepada Akta Pekerjaan 1955, Akta Kesatuan Sekerja 1959, Akta Perhubungan Perusahaan 1967, dan Akta Keselamatan dan Kesihatan Pekerjaan 1994. Perubahan itu menyelaraskan undang-undang Malaysia dengan piawaian antarabangsa yang ditetapkan oleh Pertubuhan Buruh Antarabangsa dan bertujuan untuk meningkatkan kecekapan buruh, memupuk persekitaran kerja yang lebih selamat, dan menyokong cita-cita negara untuk menjadi ekonomi ke-30 terbesar menjelang tahun 2030.



Meeting of MEF East Malaysia Region Members No. 9/2024

The Malaysian Employers Federation (MEF) East Malaysia (Sarawak) Region convened its 9th meeting of the year on 30 September 2024, presided over by Ms Dayang Jamillah Tun Abang Muhd Salahuddin, Consultant-Industrial Relations of MEF Sarawak. The online session focused on "*Punitive Damages*", presented by Dato' Jalaldin Hussain, MEF Senior Principal Consultant.

Dato' Jalaldin emphasised the necessity for punitive measures in employment matters, particularly in the context of retrenchment. Any decision to retrench must be substantiated by clear evidence of redundancy and a shift towards privatisation. This emphasis on justification is crucial, as punitive damages can amount to two months' pay for each year of service. As such, employers must proceed with caution to mitigate potential financial liabilities. He also discussed the challenges posed by multiple trade unions within a single company. While these unions can enhance worker representation, they can also complicate collective issues, including wrongful dismissals.

Additionally, Dato' Jalaldin highlighted the significance of fixed-term contracts. These contracts should clearly outline their non-



terminable nature, distinguishing them from permanent contracts. This is vital for both employers and employees to understand their rights and obligations.

He concluded by urging MEF members to seek guidance from MEF before proceeding with retrenchments and engaging in matters that may come before the industrial court. He also encouraged adoption of industrial harmony laws to create a cohesive workplace.

Persekutuan Majikan-Majikan Malaysia (MEF) Wilayah Malaysia Timur (Sarawak) telah mengadakan mesyuarat ke-9 pada 30 September 2024. Dato' Jalaldin Hussain, Perunding Utama Kanan MEF membentangkan "Punitive Damages" menekankan bahawa keputusan pemberhentian kerja mesti berasas dengan bukti pemberhentian kerja dan peralihan ke arah penswastaan, kerana ganti rugi punitif boleh menjadi ketara. Beliau juga membincangkan cabaran pelbagai kesatuan sekerja dalam syarikat dan kepentingan mentakrifkan kontrak jangka tetap dengan jelas.

E-Invoicing: A Heavy Burden for Malaysian SMEs

The government's decision to mandate e-invoicing for all businesses in Malaysia is an inconsiderate policy that will disproportionately impact small and medium-sized enterprises (SMEs), which form the backbone of the Malaysian economy. While the intention to modernise the tax system is understandable, this compulsory approach ignores the unique challenges faced by SMEs, which often lack the resources and expertise to implement complex technological solutions.

The low threshold for e-invoicing registration, set at revenue above RM150,000, further entraps SMEs in a compliance dilemma. Implementing e-invoicing requires significant investments in new hardware, software, and training. For many SMEs, these expenses are simply out of reach, forcing them to either divert resources from core business activities or face the risk of non-compliance. Moreover, the transition to e-invoicing can be complex and time-consuming, disrupting operations and potentially leading to errors or delays.

Instead of imposing a mandatory requirement, the government should focus on providing incentives to encourage voluntary adoption of e-invoicing. This approach could include:

- · Tax rebates or credits for SMEs that implement e-invoicing
- · Financial assistance to help offset the costs of hardware, software, and training
- · Simplified compliance procedures for e-invoicing adopters

By offering these incentives, the government can create a more favourable environment for SMEs to embrace e-invoicing while minimising the financial burden on businesses.

Unlike other countries, such as Singapore, Australia, and the United Kingdom, Malaysia's approach is overly hasty, lacking consultations with businesses in Sarawak especially the SMEs. These nations have successfully promoted e-invoicing adoption through voluntary frameworks, providing businesses with the flexibility to choose the best solution for their needs. By following the lead of these countries, Malaysia can create a more supportive and sustainable business environment.

We urge the government to reconsider this policy and make e-invoicing a voluntary choice for businesses with effective incentives and support. This approach would alleviate the financial burden on SMEs, promote innovation, and ultimately contribute to a more vibrant Malaysian economy.






Top Five Sawntimber Export Destinations By Volume



STA Training Sdn Bhd (STAT) is the appointed training provider by Forest Department Sarawak to provide skills training for the five (5) prescribed forestry activities (PFAs) as listed in Schedule 1 The Forests (Trained Workmen) Rules, 2015.
