he STA Annual General Meeting (AGM), which had been deferred twice from the initial date of 29 March 2022 due to unfavourable COVID-19 situation in Sarawak, was held on 30 September 2022 at Wisma STA, Kuching. The AGM was attended by representative from 170 member companies throughout Sarawak.

STA Chairman Datuk Sir Wong Kie Yik delivered his message followed by presentation of report on the workings of the Association read by Dato Henry Lau, Honorary Secretary. He said that for much of 2022, the Association had focused on capacity building to springboard the industry towards sustainable growth post COVID-19 and keeping its members up-to-date with latest forestry laws and regulations.

During the meeting, members appointed auditors and public officers for the ensuing years and dealt with matters relating to the subsidiary companies of the Association, namely STA Enterprises Sdn Bhd, STA Training Sdn Bhd, STA Mutual Sdn Bhd and STA Ventures Sdn Bhd. Members also elected Council members for the term of 2022 and 2023, as well as voted to pass the proposed amendments to STA's Constitution.

A Council Meeting was convened immediately after the AGM, during which Office Bearers were elected and Dato Henry Lau was elected as the new Chairman, succeeding Datuk Sir Wong Kie Yik.

Election in progress

Chairman's Speech Annual General Meeting 2022

I warmly welcome each one of you to STA Annual General Meeting (AGM) for 2022. It gives me great pleasure to once again see everyone in person. We had no choice last year but to conduct our first ever virtual AGM due to the unprecedented COVID-19 pandemic.

Over the last two (2) years, the pandemic had caused hardships to all at large. I am glad that we have started to emerge from the pandemic. With the re-opening of economies around the world, the Sarawak timber industry saw an uptick in its exports value. Total export value of Sarawak timber products has grown by 3.9% from RM3.7 billion in 2020 to RM3.9 billion last year. There is a marked increase of 11.7% in the total export value at RM2.0 billion for the first half of this year compared to RM1.8 billion in the same period last year.

STA is optimistic that the momentum and positive trend can be sustained with more supporting policies by the Government, as many companies from Peninsular Malaysia are looking at Sarawak for raw materials in the form of logs, sawntimber, plywood, etc. Since the start of this year, STA has several engagements with organisations from Peninsular Malaysia such as the Malaysian Timber Council, Malaysian Furniture Council, Malaysian Wood Moulding And Joinery Council and Muar Furniture Association to name a few. One very important policy is to facilitate enough manpower from Indonesia or any other source countries such as Bangladesh, Nepal and Myanmar for the industry to carry this momentum forward.

Moreover, in moving our industry up the value chain, the Sarawak Government has urged our members to value-add and venture into furniture and engineered wood products. The Government, through Sarawak Timber Industry Development Corporation, has taken some initiatives such as developing Furniture Park and building a pool of furniture designers to accelerate the development of furniture industry.

To facilitate the development of furniture industry, the establishment and support of auxiliary industries such as wood adhesives/chemicals/lacquers, upholstery/textiles and logistics are crucial. It is also necessary to upgrade infrastructure such as roads and build more deep sea ports.

Our Sarawak Government has made it mandatory for all long term forest timber licences to be certified by year 2022. Prior to the pandemic, STA members had made significant progress in forest management certification (FMC). Out of a total of twenty three (23) certified Forest Management Units (FMUs) and nine (9) certified Forest Plantation Management Units (FPMUs) in Malaysia, thirteen (13) FMUs and six (6) FPMUs are located in approximately 1.37 million hectares of forest area in Sarawak.

The pandemic had caused significant disruptions to all sectors and industries including the timber industry. Plans made for FMC were affected when ground preparation work towards FMC and onsite audits had to be postponed. No new FMUs were certified yet since year 2021.

With the easing of restrictions in 2022, FMC activities has since started to pick up again and STA hopes that the Government will allow more time for the FMUs to work towards achieving FMC.



Security of tenure is of utmost importance for implementing sustainable forest management as it allows FMUs to carry out long term planning for optimal management of the forests to meet the needs of the present and future generations. With that, STA seeks the Government's understanding in expediting the issuance of the promised 60-year licence to certified FMUs.

Returning to the matters of the Association, this is an election year. Members shall elect Council members for a term of two (2) years, 2022 and 2023. I hope members will set aside their differences and elect members who are prepared to serve and lead the Association as Office Bearers and Council members for the mutual benefits of all members and well-being of the industry.

The workings of our Association shall be presented by Honorary Secretary, Dato Henry Lau. As this shall be my last term as Chairman of STA, I would like to thank all our members for your support, cooperation, tolerance and understanding, especially the outgoing Council Members and I wish the incoming Council Members a successful term.

I have to similarly thank the following for their continuous support to STA:

Second Workshop to Identify Gaps and Opportunities in Implementing Forest Management Certification in Sarawak

The Forest Department Sarawak (FDS) and STA jointly organised the "Second Workshop to Identify Gaps and Opportunities in Implementing Forest Management Certification in Sarawak" from 6 to 7 September 2022 at Imperial Hotel, Kuching. A total of 75 participants from FDS, Malaysian Timber Certification Council (MTCC), certified forest / forest plantation management units, timber licensees and STA Secretariat attended the Workshop. The Workshop served as a platform for participants to highlight main challenges faced when implementing and maintaining forest management certification in Sarawak as well as to identify opportunities and necessary key resources in overcoming those challenges.

In the welcoming remarks by Ms Annie Ting, Chief Executive Officer of STA, she mentioned that the Workshop was held timely following the adoption of the revised standard namely Malaysian Criteria and Indicators for Sustainable Forest Management in 2021 and with more and more forest / forest plantation management units in Sarawak being certified. She urged all participants to take this opportunity to share their experiences and challenges faced in implementing forest management certification.

Datu Hamden bin Haji Mohammad, Director of Forests in his welcoming speech shared that since the announcement of mandatory forest management certification for all long-term forest timber licences in 2018, a total of 13 forest management units and 6 forest plantation management units have been certified. This accounts for about 23.8% of certified forests under Malaysian Timber Certification Scheme (MTCS) and 3.39% of the world's certified tropical forests which represents a significant amount of

certified tropical forests regionally and globally. He also highlighted that adoption of forest management certification will also help Malaysia to meet the international commitments and national policies on the aspect of environment, biodiversity and climate change as well as contribute country's national sustainable development goals.

The Workshop featured three (3) presentations on the journey and challenges faced in implementing forest management certification in Sarawak. These presentations were made by Mr Andy Wong from Shin Yang Sdn Bhd, Mr Wong Ing Yung from Zedtee Sdn Bhd and Mr Haji Hamzah bin Haji Morshidi from Sarawak Timber Industry Development Corporation. Amongst the key challenges highlighted were management of unauthorized land use within permanent forest estate, unverified land claims and security of licence tenure for long term investment planning. Ms Siti

Syaliza Mustapha, Chief Executive Officer of MTCC also provided an update on the MTCS which includes changes to the certification standard, recognition of MTCS, export of certified products and certification as a tool for meeting environmental, social and governance criteria.

Following participants were divided into three (3) groups to discuss principles of the Malaysian Criteria and Indicators for Sustainable Management. Capacity building such as training in various fields, control mechanism for encroachment, illegal harvesting and prohibited activities within forest management units and effective engagement with local communities were among some of the gaps and challenges highlighted.

After the workshop was concluded, representatives from FDS, MTCC and STA joined the Chair, Mr Jack Anak Liam, Deputy Director of Forests in discussing the issues and challenges highlighted during the Workshop. Among some of the ways forward are establishing a common understanding on the local terms such as temuda, pulau and community used area, for benefit of auditing in Sarawak. For communicating claims from certified areas, FDS will consider to allow forest manager to stamp the Removal Pass (Transit) document with "100% PEFC Certified" as part of the requirement under chain of custody.

STA Council Meeting No.3/2022

The Council for the term 2020 and 2021 convened its last meeting on 5 September 2022 via video conferencing. The meeting was presided over by STA Chairman, Datuk Sir Wong Kie Yik and attended by Honorary Secretary Dato Henry Lau, Honorary Treasurer Mr Philip Choo and twenty six (26) members of the Council.

The Council put on record the Association's deepest regret in the passing of the late Mr Lau Swee Nguong as well as its appreciation for his long standing contribution to the Sarawak timber industry and the Association dating all the way back to the 1970s. The late Mr Lau had held several important positions in the Association, which includes Vice Chairman, Honorary Treasurer, Chairman of STA Sawmilling Category Committee and Council member.

On the amendments to the STA Constitution which were recommended and successfully approved by the Registry of Societies Malaysia (ROS) on 8 April 2022, the Council had voted in favour of Clause 8(1)(a)(i) of STA Constitution in person at the last meeting or through postal ballots issued on 5 July 2022. Having achieved the Unanimous Assenting Vote (UAV) of a Council meeting, the amendment shall now be tabled at the Annual General Meeting for UAV of a General Meeting.

STA Forest Plantation Committee Meeting No.3/2022

The STA Forest Plantation Committee Meeting No.3/2022 convened on 14 September 2022 at Wisma STA, Kuching. Updates on activities with several forestry agencies and trade association were shared in the hybrid meeting, attended by all the Committee members. The Committee also deliberated on the collaborative research and development (R&D) projects with Universiti Malaysia Sarawak (UNIMAS).

After the meeting, the Committee visited trial plot established at Sejingkat, Kuching to observe the growth performance of the Kelampayan tissue culture clones under the STA-UNIMAS collaborative R&D project. This was followed by a visit to UNIMAS to look at the bioreactor system which was purchased for the study on mass propagation of Kelampayan funded by STA. Associate Professor Dr Ho Wei Seng, project leader for this project received the Committee at both sites.

Mastering Training Delivery Course

In an effort to upgrade their training skills and deliver impactful training, seven (7) trainers and a training officer of STA Training Sdn Bhd took the initiative to attend 2-day course on "Mastering Training Delivery Course".

The course, conducted by Mr Dominic Jay from 12 to 13 September 2022 at the GEM Consultancy Sdn Bhd. is designed to enhance learning by making subjects and information more enjoyable and interesting through the introduction of comprehensive and useful training best practices. Six (6) modules were covered during the 2-day course which encompassed climate setting, understanding human learner, building engagement, promote interactions, training delivery impact, and developing assessment.

The lab session was attended by twenty (20) officers from FDS, SAINS, STA and STA Training Sdn Bhd (STAT). SAINS is the information and communication technology systems provider for Sarawak Government and STAT the appointed training provider for the five (5) prescribed forestry activities. The lab was organised to facilitate the integration of STAT's internal database with FDS systems i.e. Sarawak Logs Tracking and Forest Revenue System (REVLOG) and Licensee Portal.

The participants discussed in depth on the processes of workman nomination to issuance of trained workman certificate.

Stakeholder Engagement Workshop on Biomass Removal Plan for Baleh Hydroelectric Project

A Stakeholder Engagement Workshop on Biomass Removal Plan (BRP) for Baleh Hydroelectric Project was held on 13 September 2022 at Chemsain Building in Kuching.

The Workshop, organised by Chemsain Konsultant Sdn Bhd, consultant appointed by SEB Power Sdn Bhd, was attended by representatives from the Ministry of Natural Resources and Urban Development, Ministry of Utility and Telecommunication, Forest Department Sarawak, Natural Resources and Environment Board (NREB), Sarawak Timber Industry Development Corporation, Sarawak Energy Bhd and affected timber operators namely WTK group of companies, Jaya Tiasa Holdings Bhd, Billion Venture Sdn Bhd as well as STA secretariat.

Among some of the objectives of Workshop were to build-up practical approaches of salvage logging among affected parties in ensuring full compliance to Salvage Logging Guidelines and BRP Approval Conditions as well as identify best practices and methodologies for biomass removal works.

The consultants shared an overview of the biomass removal works in Baleh hydroelectric project. The BRP involves two (2) phases, namely removal of

commercial timber within entire of Baleh dam reservoir through salvage logging followed by total removal of remaining biomass within main dam area covering 9,478 ha with exclusion of areas with slopes more than 35° and imposition of 100 meter buffer from main river system.

Also presented during the Workshop were forestry and environmental requirements to biomass removal, NREB approval conditions for biomass removal works and exploring the possibility of wood chipping as option for biomass disposal.

Engagement Session on Industrial Harmony Index

The Department of Industrial Relations Malaysia (DIRM) under the Ministry of Human Resources (MoHR) and UNIMAS Holdings Sdn Bhd (UHSB) jointly organised an engagement session on the industrial harmony index on 22 September 2022.

The session, which aimed at gathering feedback on best practices in industrial relations for industries in Sarawak to assist the Government in formulating better guidelines in maintaining industrial harmony in the country, was moderated by Associate Professor Dr Kartinah Ayup and Dr Dzulzalani bin Eden of UHSB.

Twenty four (24) representatives from association and industries, who attended the session in person,

were informed that the National Industrial Harmony Index (IHI) 2022 was developed to measure industrial harmony using systematic and empirical instrument development procedures, to determine the level of industrial harmony in various sectors in Malaysia.

Five (5) dimensions, namely nurturing relationship, connectedness, mutual peacemaking, mutual cooperation and being responsible are measured in IHI

Questionnaire for IHI 2022 were distributed to 1,000 employers from all over Malaysia and 15,000 employees from all sectors such as services, manufacturing, construction, agriculture, electricity, gas and forestry.

Preliminary finding from the data collected shows that impacts of COVID-19 on different industries varied. The data also highlighted a reduction in workforce, overtime, working hours and number of shifts caused by COVID-19.

Participants had the opportunity to share challenges faced and measures taken to maintain productivity, company competitiveness and job continuity during the COVID-19 pandemic.

Ways to improve industrial harmony between employers and employees were then discussed and staff engagement programme, coffee talk session and town hall workshop were among some of the suggestions raised.

Meeting on the Implementation of Pilot Project for Environmental Compliance Audit

In the long going effort of the Natural Resources and Environment Board (NREB) and STA to ensure smooth implementation and better understanding of the compliance audit requirement, required under the Natural Resources and Environment (Audit) Rules, 2008, NREB and STA met on 9 September 2022 at Wisma STA to update and discuss on the progress of the second batch of Pilot Projects for Environmental Compliance Audit.

This Pilot Project, kicked off in 2018 with voluntary participation from seven (7) STA member companies is expected to complete in the first quarter of 2023.

Mr Kenny Poon, Assistant Controller (Compliance and Enforcement Section), NREB pointed out that once completed, more than ten (10) companies in the forestry sector will continue with self-regulated compliance, a transition that will hopefully help address the constraint faced by NREB in monitoring compliance of active projects throughout Sarawak.

The NREB also committed to engage with all parties to the Pilot Projects in reviewing the findings from both pilot projects and make necessary changes to fine tune the Guidelines for Natural Resources and Environment (Audit) Rules, 2008.

MTC's Virtual Marketing Seminar 2022

The Malaysian Timber Council (MTC) organized a virtual "Revitalising the Timber Business" seminar on 21 September 2022 with the aim to benefit traderelated event for the timber industry players, who are reviving their businesses especially in export markets during the post-pandemic era. The seminar attracted more than 180 participants.

In her welcoming remarks, MTC's Chief Operation Officer, Ms Noraihan Abdul Rahman highlighted that the seminar is one of MTC's effort to keep Malaysia's timber industry well-informed on the global market trends and development.

As the global industry slowly transit into endemic phase of COVID-19, the Malaysian timber industry are encouraged to adapt to the new landscape of global trade and supply chain which has created a new normal in doing business. She also urged the Malaysian timber industry to better position itself in maintaining its traditional market and develop its niche market for their timber products.

The seminar which covered topics from trade to international markets updates, including the challenges and opportunities in the timber industry was moderated by Ms Alexis Chang, Director of Market Promotion & Product Development Division, MTC.

Dr Sailesh K. Jha, Group Chief Economist & Head, Market Research, RHB Bank shared global economic outlook for the second half of 2022 and 2023 and expect that the economy will recover by mid-June of 2023, despite news of global economic recession.

Lic. Jose Sebastian Ceballos Gallardo, Honorary Consul of Malaysia in Guadalajara, Mexico encouraged Malaysian timber industry to explore opportunities in Mexico, as Latin Americans prefers timber and wood products produced from species such as Meranti, Nyatoh, Bintangor, Mersawa and Merbau.

Challenges faced by other country's timber industry were also highlighted. Timber merchants and builders in Australia are feeling the impact of fixed pricing in a rapidly changing cost environment and labour shortages while India struggle with inconsistent taxation regime and freight fluctuation, among other issues.

China too, is not spared, as its timber industry is challenged with strict environmental policies, increasing wood prices and inconsistent demand.

PEFC Webinar

"How the wooden furniture you design, make and sell stores carbon and combats climate change"

Programme for the Endorsement of Forest Certification (PEFC) attracted participants from 46 countries worldwide in its webinar on "How the wooden furniture you design, make and sell stores carbon and combats climate change" on 7 September 2022.

Moderated by Mr Thorsten Arndt, Head of Communications, PEFC International, the webinar featured two (2) speakers, Mr Michael Berger,

Chief Executive Officer/Secretary-General, PEFC International as well as Mr Francesco Negro, who is a Research Associate from the University of Torino.

Mr Berger shared that the world forests absorb 7.6 billion metric tonnes of carbon dioxide per year and sequestered twice as much carbon dioxide as they emitted between 2001 and 2019.

To ensure that forests reach their full potential as a climate change solution, they must be managed sustainably. He added that the wooden furniture received attention in recent years as it is the third largest user of wood and its demand continues to increase.

The products made of wood can only be a climate change solution if they originate from sustainably-managed forests and PEFC plays an important role in helping combat climate change through forest management certification and chain of custody certification.

Mr Negro demonstrated the method to calculate carbon dioxide storage in wood and derived products and shared a scientific case study investigating the amount

of carbon stored by furnishing wood-based products for an apartment in Italy.

He then promoted efficient utilisation of wood including in the furniture sector to extend the total biomass availability within a given system as a way for the wooden furniture to contribute in the race to net zero of carbon emission.

DF Circular No.5/2022 on Forest Plantation Management Certification

The Forest Department Sarawak issued a DF Circular No 5/2022 with reference number (78) JHS/100-1/8/104/Jld.1 dated 12 September 2022 addressed to all holders of licence for planted forests, and copied to STA on forest plantation management certification.

The circular was circulated to STA forest plantation members on 14 September 2022. The following is an excerpt of the above-mentioned circular, for your information:

DF Circular No.5/2022

Pursuant to Policy Direction on Industrial Forest Plantation in Sarawak endorsed by the Minister of Urban Development and Natural Resources, all licence areas under the licence for planted forest that have been cleared or planted before the year 2010, are required to obtain Forest Plantation Management Certification (FPMC) by December 2025 and such holder of the licence are required to make necessary preparation.

AsiaFlux 2022 Conference

The highly specialised and historically important scientific international AsiaFlux2022 Conference was held in Sarawak from 20 to 22 September 2022 at the Sarawak Tropical Peat Research Institute (TROPI). AsiaFlux is a regional research network that played a vital role in the long-term study of climate change in relation to carbon, water and energy fluxes between terrestrial ecosystems and the atmosphere in Asia.

The conference which was originally scheduled for 2020 but postponed due to the COVID-19 pandemic was jointly organised by TROPI, Malaysian Peat Society and Asia Flux Science Steering Committee, in collaboration with the National Institute for Environmental Studies, Hokkaido University of Japan, Forest Research Institute Malaysia, Malaysian Palm Oil Board and Malaysian Agriculture Research and Development Institute.

Themed "The nexus of land use change, ecosystems & climate: a path toward SDGs", the conference is staged at a critical moment in the history of climate change science and attracted scientists from different fields of expertise from various parts of the world as well as researchers, academicians, industry professionals, business entrepreneurs, policymakers and experts.

Dr Lulie Melling, Director of TROPI cum Organising Chairperson of AsiaFlux2022 in her opening speech, underscored the importance of communicating science to the wider community, particularly policy makers and hoped that the conference helped stimulate sharing of

research findings, exchanging valuable insights learning and from one another towards achieving that end.

Dr Lulie, who is also the President of Malaysian Peat Society, urged everyone to work together, discuss and recommend potential strategies to adapt and mitigate climate based change on best practices

rooted in newly discovered scientific evidence from across the globe.

Research papers and findings from studies related to carbon cycle and anthropogenic emissions of greenhouse gases (GHGs) as well as initiatives to minimize the negative impacts of climate change on food security and natural disasters were presented throughout the five (5) thematic sessions of the conference, namely ecosystem dynamics, environmental variability and climate change, land use change, communication science to society and new instrumentation, products and tools.

Datu Haji Len Talif Salleh, Deputy Minister of Urban Planning, Land Administration and Environment in his keynote presentation on "Environment and Environmental Sustainability towards Mitigating Climate Change" shared that Sarawak, which contributes 44% of total forest cover in Malaysia, is the biggest carbon sink in the country.

He also shared initiatives undertaken by the Sarawak Government to mitigate climate change, one of which is the establishment of Ministry of Energy and Environmental Sustainability, responsible for planning, coordinating and providing direction for the development of green growth, renewable energy, sustainability and climate change. A number of policies and ordinances were also reviewed, such as the Land Code to enable carbon capture usage and storage as well as the Forests Ordinance to regulate forest carbon activity.

Malaysian Employers Federation Annual General Meeting 2022

The Annual General Meeting (AGM) of Malaysian Employers Federation (MEF) was held on 1 September 2022 at Dorsett Grand Subang, Subang Jaya.

In the opening address by MEF President, Datuk Dr Syed Hussain Syed Husman, he highlighted on the challenging situation in the global and domestic fronts due to re-imposition of nationwide containment measures from June to September 2021 to control the spread of COVID-19 variant infections and the continuous cycle of 'on-and-off' closures and reopenings in 2021.

These measures had resulted in massive disruptions in supply chains, causing employers to suffer loss of revenue while still having to bear obligations to cover fixed costs.

He stated that although the Malaysian economy managed to register a growth of 3.1% in 2021, and is expected to improve further in 2022 supported mainly by higher domestic demands, the growth prospects is subjected to many other factors such as global growth, geopolitical conflicts, adverse developments surrounding COVID-19 and heightened financial market volatility.

Unemployment rate increased from 4.5% in May to 4.8% in July 2021 and the labour market conditions only resumed recovery towards the end of 2021 following the lifting of COVID-19 restrictions.

One of the hot issues on the table currently is the need for the Government to provide adequate manpower so that industry can operate at optimum levels, as the efforts by businesses to bring their operations back to pre-pandemic levels were hampered by the shortages of manpower especially foreign workers.

Even though MEF supports the efforts to reduce dependency on foreign workers in certain sectors, he appealed to the Government to address this complex matter on a sectoral basis because many sectors such as manufacturing, restaurants, plantation, and construction depend on foreign workers.

According to Datuk Dr Syed Hussain, the pandemic has shown that timely information, up-to-date strategic agendas, and shorter decision cycles are critical to business sustainability.

He advised both employers and employees to be flexible and agile towards adopting continuous learning attitudes in the face of uncertainty because flexibility of both employers and employees will enable businesses to respond quickly to supply chain disruptions, technological developments, and societal changes.

The AGM saw the election of twenty one (21) Council members. Datuk Dr Syed Hussain retained MEF presidency for the second consecutive term and will lead MEF for the term 2022 – 2024. Ms Peggy Chew, STA's representative at MEF was appointed as the Honorary Secretary.

Engagement Session with Training Coordinators

STA Training Sdn Bhd (STAT), an appointed Training Provider under the Forests (Trained workmen) Rules, 2015 continues to engage with timber companies for better execution of ground training programme.

An engagement session with training coordinators, administrators and managers was conducted virtually on 22 September 2022.

Ms Annie Ting, Manager of STAT facilitated the engagement session by providing an update on the enhanced training schedule for skills sets training programmes offered by STAT. She mentioned that under the newly enhanced training schedule, the assessment of operators will be conducted immediately after training instead of a few months apart. This arrangement which has been agreed by the Director of Forests will take effect from 1 October 2022.

Apart from that, she also updated participants on the registration of STAT and its skills sets training programmes under the Human Resource Development Corporation (HRD Corp). In the future, timber companies can utilise levy contributed by sending their employees to attend HRD Corp claimable courses offered by STAT. The participants discussed at length on the proposed training fees structure.

Ms Ting also updated the attendees on number of trained workmen, financial incentive scheme for the five (5) prescribed forestry activities, and training on the reduced impact logging.

Themed "Bringing SIRIM Closer to Community and Industry", it provided a platform for industry players and SIRIM experts to meet and share each other's experiences and concerns in these challenging times, especially after the COVID-19 pandemic.

Tan Sri Dr Ir Ahmad Tajuddin Ali, Chairman of SIRIM in his welcoming remarks affirmed the commitment of SIRIM as premier industrial research and technology organisation in Malaysia in assisting industry players from Sarawak. He added that SIRIM has over forty (40) years of experience and expertise in developing new technologies and improvements in the manufacturing, technology and services sectors.

He urged entrepreneurs from Sarawak to seek out SIRIM for first-hand information on latest solutions and

support available for local industries to add value and increase industrial productivity.

In the keynote address, read by Datu Haji Len Talif Salleh, Deputy Minister of Urban Planning, Land Administration and Environment, the Premier of Sarawak Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari bin Tun Datuk Abang Haji Openg mentioned that the Sarawak Government is implementing various initiatives and projects to drive Sarawak's economy by using renewable energy such as hydro power and hydrogen.

Announcement on SOCSO and EIS 2022

STA received two (2) Circulars AG 19/2022 and AG 20/2022 dated 2 September 2022 and 10 September 2022 respectively from the Malaysian Employers Federation ("MEF") on the increase in the maximum monthly salary ceiling limit for Contributions under the Employees' Social Security Act 1969 ("SOCSO") and the Employment Insurance System Act 2017 ("EIS").

The respective amendments to SOCSO and EIS were made under the Employees' Social Security (Amendment) Act 2022 ("Act A1658") and the Employment Insurance System (Amendment) Act 2022 ("Act A1657"), which were gazetted on 30 August 2022 via the respective Federal Government Gazettes P.U. (B) 395 and P.U. (B) 393.

In exercise of the powers conferred by the respective subsections 1(2) of both Act A1658 and Act A1657, the Minister of Human Resources appoints 1 September 2022 as the date for both amendments to come into operation.

Previously, the maximum monthly salary ceiling for contributions under SOCSO and EIS was RM4,000.00, as provided in the relevant schedules of SOCSO and EIS. With the amendments, it is now increased to RM5,000.

Based on the Frequently Asked Questions (FAQs) issued by SOCSO dated 1 September 2022, SOCSO has granted a transitional period of six (6) months from 1 September 2022 to 28 February 2023 for the new contribution rates.

According to MEF, SOCSO can impose penalty against non-compliance with effect from 1 March 2023 in respect to non-compliance occurring during the transitional period of 1 September 2022 to 28 February 2023.


