United States (US) withdrawal from the Paris Agreement could mean three billion tones more of carbon dioxide being released into the atmosphere each year, increasing the rate of rising sea levels and melting ice sheets. The US could add as much as 0.3 degrees Celsius to global warming by the end of the century. However, under the rules of the Paris Agreement, the process of the US withdrawal could take at least three years, making the US decision to formally leave the accord only valid by the year 2020.

Reclamation works for the Forest City in Johor, a Chine-funded real estate project launched in 2014 is currently ongoing and four artificial islands will soon rise up from the waters and bringing Malaysia's shoreline ever closer to Singapore. The magnitude of the construction works has raised concern among environmentalist who claimed that it could have dire consequences on the local ecosystems if left unsupervised. The project is also purported to have invaded a nearby intertidal seagrass meadow, potentially altering currents and threatening the ecosystem's rich biodiversity.
